Short Title: Simplify Privilege License Tax.

A BILL TO BE ENTITLED
AN ACT TO SIMPLIFY AND MODIFY PRIVILEGE LICENSE AND EXCISE
TAXES AND RELATED PERMIT FEES.

The General Assembly of North Carolina enacts:

Section 1. The title of Article 2 of Chapter 105 of the General Statutes reads as rewritten:

"ARTICLE 2.

"SCHEDULE B. LICENSE PRIVILEGE TAXES."

Section 2. G.S. 105-33 reads as rewritten:

"§ 105-33. Taxes under this Article.

(a) General. – Taxes in this Article ~~or schedule shall be~~ are imposed as State license ~~taxes~~ for the privilege of carrying on the business, exercising the privilege, or doing the act ~~named, named.~~ and nothing in this Article shall be construed to relieve any person, firm, or corporation from the payment of the tax prescribed in this Article or schedule: Provided, the obtaining of a license required by this Article shall not of itself authorize the practice of a profession, business, or trade for which a State qualification license is required.

(b) ~~If the business made taxable or the privilege to be exercised under this Article is carried on at two or more separate places, a separate State license for each place is required.~~ License Taxes. – A license tax imposed by this Article is an annual tax. The tax is due by July 1 of each year. The tax is imposed for the privilege of engaging in a

1 specified activity during the fiscal year that begins on the July 1 due date of the tax. The
2 full amount of a license tax applies to a person who, during a fiscal year, begins to
3 engage in an activity for which this Article requires a license. Before a person engages in
4 an activity for which this Article requires a license, the person must obtain the required
5 license.

6 ~~(c) Every State license issued under this Article or schedule shall be for 12~~
7 ~~months, shall expire on the thirtieth day of June of each year, and shall be for the full~~
8 ~~amount of tax prescribed; provided, that where the tax is levied on an annual basis and~~
9 ~~the licensee begins such business or exercises such privilege after the first day of January~~
10 ~~and prior to the thirtieth day of June of each year, then such licensee shall be required to~~
11 ~~pay one half of the tax prescribed other than the tax prescribed to be computed and levied~~
12 ~~upon a gross receipts and/or percentage basis for the conducting of such business or the~~
13 ~~exercising of such privilege to and including the thirtieth day of June, next following.~~
14 ~~Every county, city and town license issued under this Article or schedule shall be for 12~~
15 ~~months, and shall expire on the thirty first day of May or thirtieth day of June of each~~
16 ~~year as the governing body of such county, city or town may determine: Provided, that~~
17 ~~where the licensee begins such business or exercises such privilege after the expiration of~~
18 ~~seven months of the current license year of such municipality, then such licensee shall be~~
19 ~~required to pay one half of the tax prescribed other than the tax prescribed to be~~
20 ~~computed upon a gross receipts and/or percentage basis. Other Taxes. – The taxes~~
21 ~~imposed by this Article on a percentage basis or another basis are due as specified in this~~
22 ~~Article.~~

23 ~~(d) The State license issued under G.S. 105-41 is a personal privilege to conduct~~
24 ~~the profession or business named in the State license, is not transferable to any other~~
25 ~~person, and does not limit the person named in the license to conducting the profession or~~
26 ~~business and exercising the privilege named in the State license to the county and/or city~~
27 ~~and location specified in the State license, unless otherwise provided in this Article.~~
28 ~~Other licenses issued for a tax year for the conduct of a business at a specified location~~
29 ~~shall upon a sale or transfer of the business be deemed a sufficient license for the~~
30 ~~succeeding purchaser for the conduct of the business specified at that location for the~~
31 ~~balance of the tax year. If the holder of a license under this Article moves the business for~~
32 ~~which a license tax has been paid to another location, a new license may be issued to the~~
33 ~~licensee at a new location for the balance of the license year, upon surrender of the~~
34 ~~original license for cancellation and the payment of a fee of five dollars (\$5.00) for each~~
35 ~~license certificate reissued.~~

37 ~~(f) All State taxes imposed by this Article shall be paid to the Secretary of~~
38 ~~Revenue, or to one of his deputies; shall be due and payable on or before the first day of~~
39 ~~July of each year, and after such date shall be deemed delinquent, and subject to all the~~
40 ~~remedies available and the penalties imposed for the payment of delinquent State license~~
41 ~~and privilege taxes; provided, that if a person, firm, or corporation begins any business or~~
42 ~~the exercise of any privilege requiring a license under this Article or schedule after the~~
43 ~~thirtieth day of June and prior to the thirtieth day of the following June of any year, then~~

1 such person, firm, or corporation shall apply for and obtain a State license for conducting
2 such business or exercising any such privilege in advance, and before the beginning of
3 such business or the exercise of such privilege; and a failure to so apply and to obtain
4 such State license shall be and constitute a delinquent payment of the State license tax
5 due, and such person, firm, or corporation shall be subject to the remedies available and
6 penalties imposed for the payment of such delinquent taxes.

7 (g) ~~The taxes imposed and the rates specified in this Article or schedule shall~~
8 ~~apply to the subjects taxed on and after the first day of June, 1939, and prior to said date~~
9 ~~the taxes imposed and the rates specified in the Revenue Act of 1937 shall apply.~~

10 (h) Liability Upon Transfer. ~~It shall be the duty of a~~ A grantee, transferee, or
11 purchaser of any business or property subject to the State license taxes imposed in this
12 Article ~~to~~ must make diligent inquiry as to whether the State license tax has been paid, ~~but~~
13 ~~when such paid.~~ If the business or property has been granted, sold, transferred, or
14 conveyed to an innocent purchaser for value and without notice that the vendor owed or
15 is liable for any of the State license taxes imposed under this Article, such ~~the~~ property,
16 while in the possession of such ~~the~~ innocent purchaser, shall not be ~~is not~~ subject to any
17 lien for such State license ~~the~~ taxes.

18 (i) ~~The tax collector of a county or city shall issue licenses required under this~~
19 ~~Article by the governing body of the county or city and shall collect the taxes due for~~
20 ~~these licenses.~~

21 (j) ~~Any person, firm, or corporation who shall wilfully make any false statement~~
22 ~~in an application for a license under any section of this Article or schedule shall be guilty~~
23 ~~of a Class 1 misdemeanor, which may include a fine which shall not be less than the~~
24 ~~amount of tax specified under such section, and shall be in addition to the amount of such~~
25 ~~tax.~~

28 **"§ 105-33.1. Definitions.**

29 The following definitions apply in this Article:

30 (1) City. – Defined in G.S. 105-228.90.

31 ~~(1)~~(1a) Code. – Defined in G.S. 105-228.90.

32 (2) Municipality.— A municipal corporation organized under the laws of
33 this State.

34 (3) Person. – Defined in G.S. 105-228.90.

35 (4) Secretary. — ~~The Secretary of Revenue.~~ Defined in G.S. 105-228.90."

36 Section 4. G.S.105-37.1 reads as rewritten:

37 **"§ 105-37.1. Amusements – Forms of amusement not otherwise taxed.**

38 (a) ~~Every person, firm, or corporation~~ person engaged in the business of giving,
39 ~~offering~~ offering, or managing any form of entertainment or amusement not otherwise
40 ~~taxed or specifically exempted in this Article,~~ for which an admission is charged, shall pay
41 an annual license tax of fifty dollars (\$50.00) for each room, hall, tent or other place where such
42 admission charges are made.

1 In addition to the license tax levied above, ~~such person, firm, or corporation shall pay~~
2 ~~an additional a tax upon the gross receipts of such the business at the rate of three percent~~
3 ~~(3%). Reports shall be made to the Secretary of Revenue, in such form as he may~~
4 ~~prescribe, within the first 10 days of each month covering all such the gross receipts for~~
5 ~~the previous month, and the additional tax herein levied shall be paid monthly at the time~~
6 ~~such the reports are made. The annual license tax herein levied shall be treated as an~~
7 ~~advance payment of the tax upon gross receipts herein levied, and the annual license tax~~
8 ~~shall be applied as a credit upon or advance payment of the gross receipts tax.~~

9 Every ~~person, firm, or corporation~~ person giving, offering, or managing any dance or
10 athletic contest of any kind, except high school and elementary school athletic contests,
11 for which an admission fee in excess of fifty cents (50¢) is charged, shall pay ~~an annual~~
12 ~~license tax of fifty dollars (\$50.00) for each location where such charges are made, and, in~~
13 ~~addition, a tax upon the gross receipts derived from admission charges at the rate of three~~
14 ~~percent (3%). The additional tax upon gross receipts shall be levied and collected in~~
15 ~~accordance with such regulations as may be made by the Secretary of Revenue. as prescribed~~
16 ~~by the Secretary. No tax shall be levied on admission fees for high school and elementary~~
17 ~~school contests.~~

18 ~~Dances and other amusements actually promoted and managed by civic organizations~~
19 ~~and private and public secondary schools, shall not be subject to the license tax imposed~~
20 ~~by this section and the first one thousand dollars (\$1,000) of gross receipts derived from~~
21 ~~such events shall be exempt from the gross receipts tax herein levied when the entire~~
22 ~~proceeds of such dances or other amusements are used exclusively for the school or civic~~
23 ~~and charitable purposes of such organizations and not to defray the expenses of the~~
24 ~~organization conducting such dance or amusement. The mere sponsorship of dance or~~
25 ~~other amusement by such a school, civic, or fraternal organization shall not be deemed to~~

30 ~~Dances and other amusements promoted and managed by a qualifying corporation~~
31 ~~that operates a center for the performing and visual arts are exempt from the license tax~~
32 ~~and the gross receipts tax imposed under this section if the dance or other amusement is~~
33 ~~held at the center. "Qualifying corporation" means a corporation that is exempt from~~
34 ~~income tax under G.S. 105-130.11(a)(3). "Center for the performing and visual arts"~~
35 ~~means a facility, having a fixed location, that provides space for dramatic performances,~~
36 ~~studios, classrooms and similar accommodations to organized arts groups and individual~~
37 ~~artists. This exemption shall not apply to athletic events.~~

38 ~~The license and gross receipts taxes imposed by this section do not apply to a person,~~
39 ~~firm, or corporation that is exempt from income tax under Article 4 of this Chapter and is~~
40 ~~engaged in the business of operating a teen center. A "teen center" is a fixed facility~~
41 ~~whose primary purpose is to provide recreational activities, dramatic performances,~~
42 ~~dances, and other amusements exclusively for teenagers.~~

1 (b) Counties shall not levy any license tax on the business taxed under this section,
2 but cities and towns may levy a license tax not in excess of one-half the base tax levied
3 herein: twenty-five dollars (\$25.00).

4 (e) ~~No tax shall be collected pursuant to this section with respect to entertainments
5 or amusements offered or given on the Cherokee Indian reservation when the person,
6 firm or corporation giving, offering or managing such entertainment or amusement is
7 authorized to do business on the reservation and pays the tribal gross receipts levy to the
8 tribal council.~~

9 (d) ~~It is not the purpose of this Article to discourage agricultural fairs in the State,
10 and to further this cause, no carnival company taxable under this section may play a "still
11 date" in any county where there is a regularly advertised agricultural fair, 30 days prior to
12 the dates of the fair. This subsection does not restrict the date on which a fair or tobacco
13 festival may be held if (i) it is held by a veteran's organization or post chartered by
14 Congress or organized and operated on a statewide or nationwide basis and (ii) the
15 organization or post has held the fair or festival annually since before July 1, 1988."~~

16 Section 5. G.S. 105-38 reads as rewritten:

17 "**§ 105-38. Amusements — ~~Circuses, menageries, wild west, dog and/or pony shows, etc.~~**
18 **Circuses and other traveling amusements.**

19 (a) ~~Every person, firm, or corporation~~ person engaged in the business of exhibiting
20 performances, such as a circus, menagerie, wild west show, dog and/or pony show, or
21 any other similar show, exhibition ~~exhibition, or performance similar thereto, performance~~
22 not taxed in other sections of this Article, shall ~~apply for and obtain a State license from the~~
23 ~~Secretary of Revenue for the privilege of engaging in such business, and pay for such license a~~
24 ~~tax of fifty dollars (\$50.00) for each day or part of a day for each place in the State where~~
25 ~~exhibitions or performances are to be given.~~ pay a tax upon the gross receipts of the business
26 at the rate of three percent (3%).

27 (b) ~~Every person, firm, or corporation~~ person by whom any show or exhibition taxed
28 under this section is owned or controlled shall file with the ~~Secretary of Revenue,~~
29 Secretary, not less than five days before entering this State for the purpose of ~~such the~~
30 ~~exhibitions or performances therein, a statement, under oath, setting out in detail the~~
31 dates, times, and places for the exhibitions or performances. ~~such information as may be~~
32 ~~required by the Secretary of Revenue covering the places in the State where exhibitions or~~
33 ~~performances are to be given, the character of the exhibitions, and such other and further~~
34 ~~information as may be required. Upon receipt of such statement, the Secretary of Revenue shall~~
35 ~~fix and determine the amount of State license tax with which such person, firm, or corporation is~~
36 ~~chargeable, shall endorse his findings upon such statement, and shall transmit a copy of such~~
37 ~~statement and findings to each such person, firm, or corporation to be charged, to the sheriff or~~
38 ~~tax collector of each county in which exhibitions or performances are to be given, and to the~~
39 ~~division deputy of the Secretary of Revenue, with full and particular instructions as to the State~~
40 ~~license tax to be paid. Before giving any of the exhibitions or performances provided for in such~~
41 ~~statement, the person, firm, or corporation making such statement shall pay the Secretary of~~
42 ~~Revenue the tax so fixed and determined. If one or more of such exhibitions or performances~~
43 ~~included in such statement and for which the tax has been paid shall be canceled, the Secretary of~~
44 ~~Revenue may, upon proper application made to him, refund the tax for such canceled exhibitions~~

1 or performances. Every such person, firm, or corporation shall give to the Secretary of Revenue a
2 notice of not less than five days before giving any of such exhibitions or performances in each
3 county.

4 (e) ~~The sheriff of each county in which such exhibitions or performances are~~
5 ~~advertised to be exhibited shall promptly communicate such information to the Secretary~~
6 ~~of Revenue; and if the statement required in this section has not been filed as provided~~
7 ~~herein, or not filed in time for certified copies thereof, with proper instructions, to be~~
8 ~~transmitted to the sheriffs of the several counties and the division deputy, the Secretary of~~
9 ~~Revenue shall cause his division deputy to attend at one or more points in the State where~~

18 ~~exhibition or performance in addition to the license tax first levied in this section, to be~~
19 ~~assessed and collected by the Secretary of Revenue or his duly authorized deputy.~~

20 (e) ~~The provisions of this section, or any other section of this Article, shall not be~~
21 ~~construed to allow without the payment of the tax imposed in this section, any exhibition~~
22 ~~or performance described in this section for charitable, benevolent, educational, or any~~
23 ~~other purpose whatsoever, by any person, firm, or corporation who is engaged in giving~~
24 ~~such exhibitions or performances, no matter what terms of contract may be entered into~~

2 performances are to be given."

3 Section 6. G.S. 105-40 reads as rewritten:

4 **"§ 105-40. Amusements — ~~Certain exhibitions, performances, and entertainments~~**
5 **~~exempt from license tax.~~**

6 The following forms of amusement are exempt from the taxes imposed under this
7 Article:

8 (1) All exhibitions, performances, and entertainments, except as in this
9 Article expressly mentioned as not exempt, produced by local talent
10 exclusively, and for the benefit of religious, charitable, benevolent or
11 educational purposes, and where as long as no compensation is paid to
12 such local talent shall be exempt from the State license tax. the local talent.

13 (2) The North Carolina Symphony Society, Incorporated, as specified in
14 G.S. 140-10.1.

15 (3) All exhibits, shows, attractions, and amusements operated by a society
16 or association organized under the provisions of Chapter 106 of the
17 North Carolina General Statutes where the society or association has
18 obtained a permit from the Secretary to operate without the payment of
19 taxes under this Article.

20 (4) All outdoor historical dramas, as specified in Article 19C of Chapter
21 143 of the North Carolina General Statutes.

22 (5) All high school and elementary school athletic contests.

23 (6) The first one thousand dollars (\$1,000) of gross receipts derived from
24 dances and other amusements actually promoted and managed by civic
25 organizations and private and public secondary schools when the entire
26 proceeds of the dances or other amusements are used exclusively for the
27 school or civic and charitable purposes of the organizations and not to
28 defray the expenses of the organization conducting the dance or
29 amusement. The mere sponsorship of a dance or another amusement by
30 a school, civic, or fraternal organization does not exempt the dance or
31 other amusement, because the exemption applies only when the dance
32 or amusement is actually managed and conducted by the school, civic,
33 or fraternal organization.

34 (7) All dances and other amusements promoted and managed by a
35 qualifying corporation that operates a center for the performing and
36 visual arts if the dance or other amusement is held at the center.
37 'Qualifying corporation' means a corporation that is exempt from
38 income tax under G.S. 105-130.11(a)(3). 'Center for the performing and
39 visual arts' means a facility, having a fixed location, that provides space
40 for dramatic performances, studios, classrooms, and similar
41 accommodations to organized arts groups and individual artists. This
42 exemption does not apply to athletic events.

1 (8) A person that is exempt from income tax under Article 4 of this Chapter
2 and is engaged in the business of operating a teen center. A 'teen center'
3 is a fixed facility whose primary purpose is to provide recreational
4 activities, dramatic performances, dances, and other amusements
5 exclusively for teenagers.

6 (9) All entertainments or amusements offered or given on the Cherokee
7 Indian reservation when the person giving, offering, or managing the
8 entertainment or amusement is authorized to do business on the
9 reservation and pays the tribal gross receipts levy to the tribal council."

10 Section 7. G.S. 105-41 reads as rewritten:

11 **"§ 105-41. Attorneys-at-law and other professionals.**

12 (a) Every individual in this State who practices a profession or engages in a
13 business and is included in the list below must obtain from the Secretary a statewide
14 license for the privilege of practicing the profession or engaging in the business. A
15 license required by this section is not transferable to another person. The tax for each
16 license is fifty dollars ~~(\$50.00); the tax does not apply to an individual who is at least 75 years~~
17 ~~old. (\$50.00).~~

18 (1) An attorney-at-law.

19 (2) A physician, a veterinarian, a surgeon, an osteopath, a chiropractor, a
20 chiropodist, a dentist, an ophthalmologist, an optician, an optometrist, or
21 another person who practices a professional art of healing.

22 (3) A professional engineer, as defined in G.S. 89C-3.

23 (4) A registered land surveyor, as defined in G.S. 89C-3.

24 (5) An architect.

25 (6) A landscape architect.

26 (7) A photographer, a canvasser for any photographer, or an agent of a
27 photographer in transmitting photographs to be copied, enlarged, or
28 colored.

29 (8) A real estate broker or a real estate salesman, as defined in G.S. 93A-2.
30 A real estate broker or a real estate salesman who is also a real estate
31 appraiser is required to obtain only one license under this section to
32 cover both activities.

33 (9) A real estate appraiser, as defined in G.S. 93E-1-4. A real estate
34 appraiser who is also a real estate broker or a real estate salesman is
35 required to obtain only one license under this section to cover both
36 activities.

37 (10) A person who solicits or negotiates loans on real estate as agent for
38 another for a commission, brokerage, or other compensation.

39 (11) A mortician or embalmer licensed under G.S. 90-210.25.

40 (b) ~~Persons practicing the professional art of healing for a fee or reward shall be~~
41 ~~exempt from the payment of the license tax levied in the preceding paragraph of this~~
42 ~~section, if such persons are adherents of established churches or religious organizations~~

1 and ~~confine their healing practice to prayer or spiritual means.~~ The following persons are
2 exempt from the tax:

3 (1) A person who is at least 75 years old.

4 (2) A person practicing the professional art of healing for a fee or reward, if
5 the person is an adherent of an established church or religious
6 organization and confines the healing practice to prayer or spiritual
7 means.

8 (3) A blind person engaging in a trade or profession as a sole proprietor. A
9 'blind person' means any person who is totally blind or whose central
10 visual acuity does not exceed 20/200 in the better eye with correcting
11 lenses, or where the widest diameter of visual field subtends an angle no
12 greater than 20 degrees. This exemption shall not extend to any sole
13 proprietor who permits more than one person other than the proprietor
14 to work regularly in connection with the trade or profession for
15 remuneration or recompense of any kind, unless the other person in
16 excess of one so remunerated is a blind person.

17 (c) Every person engaged in the public practice of accounting as a principal, or as
18 a manager of the business of public accountant, shall pay for such license fifty dollars
19 (\$50.00), and in addition shall pay a license of twelve dollars and fifty cents (\$12.50) for
20 each person employed who is engaged in the capacity of supervising or handling the
21 work of auditing, devising or installing systems of accounts.

22 ~~(d) Every licensed mortician or embalmer shall in like manner apply for and obtain~~
23 ~~from the Secretary of Revenue a statewide license for practicing his profession, whether~~
24 ~~for himself or in the employ of another, and pay for such license a tax of fifty dollars~~
25 ~~(\$50.00).~~

26 (e) Licenses issued under this section are issued as personal privilege licenses and
27 shall not be issued in the name of a firm or corporation. ~~Provided, that a corporation.~~ A
28 licensed photographer having a located place of business in this State, ~~shall be State is~~
29 liable for a license tax on each agent or ~~solicitor, solicitor~~ employed by ~~him—the~~
30 photographer for soliciting business. If any person engages in more than one of the
31 activities for which a privilege tax is levied by this section, ~~such—the person shall be is~~

34 ~~(g) License Revocable for Failure To Pay Tax. Whenever it shall be made to~~
35 ~~appear to any judge of the superior court that any person practicing any profession for~~
36 ~~which the payment of a license tax is required by this section has failed, or fails, to pay~~
37 ~~the professional tax levied in this section, and execution has been issued for the same by~~
38 ~~the Secretary of Revenue and returned by the proper officer "no property to be found," or~~
39 ~~returned for other cause without payment of the tax, it shall be the duty of the judge~~
