**A BILL TO BE ENTITLED**

**AN ACT TO ALLOW THE CONSTITUENT INSTITUTIONS OF THE UNIVERSITY OF NORTH CAROLINA AND THE INSTITUTIONS OF THE COMMUNITY COLLEGE SYSTEM TO OBTAIN REFUNDS OF SALES AND USE TAXES.**

The General Assembly of North Carolina enacts:

Section 1. G.S. 105-164.14(c) reads as rewritten:

"(c) Certain Governmental Entities. – A governmental entity listed in this subsection is allowed an annual refund of sales and use tax paid by it under this Article, except under G.S. 105-164.4(a)(4a) and G.S. 105-164.4(a)(4c), on direct purchases of tangible personal property. Sales and use tax liability indirectly incurred by a governmental entity on building materials, supplies, fixtures, and equipment that become a part of or annexed to any building or structure that is owned or leased by the governmental entity and is being erected, altered, or repaired for use by the governmental entity is considered a sales or use tax liability incurred on direct purchases by the governmental entity for the purpose of this subsection. A request for a refund must be in writing and must include any information and documentation required by the Secretary. A request for a refund is due within six months after the end of the governmental entity's fiscal year.

This subsection applies only to the following governmental entities:

- 19 regional economic development commission created pursuant to
- 20 Chapter 158 of the General Statutes.
- 21 (12) A regional planning commission created pursuant to G.S. 153A-391.
- 22 (13) A regional sports authority created pursuant to G.S. 160A-479.
- 23 (14) A public transportation authority created pursuant to Article 25 of
- 24 Chapter 160A of the General Statutes.
- 25 (14a) A facility authority created pursuant to Part 4 of Article 20 of Chapter
- 26 160A of the General Statutes.
- 27 (15) A regional public transportation authority created pursuant to Article 26
- 28 of Chapter 160A of the General Statutes.
- 29 (16) A local airport authority that was created pursuant to a local act of the
- 30 General Assembly and has at least one of the following characteristics:
- 31 a. It has all of the rights of a municipality.
- 32 b. A local act of the General Assembly declares it to be a

- 34 c. A local act of the General Assembly specifically authorizes it to

6                   Section 2. This act is effective when it becomes law and applies to taxes paid
