A BILL TO BE ENTITLED
AN ACT TO REVISE THE BOUNDARIES OF THE HARTSEASE AND HARRISON
FIRE TAX DISTRICTS IN EDGECOMBE COUNTY.

The General Assembly of North Carolina enacts:

SECTION 1. Section 1 of Chapter 187 of the 1995 Session Laws reads as rewritten:

"Section 1. The boundaries of the Heartsease Fire Tax District in Edgecombe County are as follows:

HEARTSEASE FIRE TAX DISTRICT

~~BEGINNING at point (1) on N. C. Highway 97, 1.0 miles east of its intersection with S.R. 1404 (New Hope Church Road) and said beginning point also being in the common boundary of Heartsease Volunteer Fire Department Fire Tax District and the Leggett Volunteer Fire Department Fire Tax District and thence running southwesterly with the line of the existing Leggett Volunteer Fire Department Fire Tax District and following the Tar River to point (2) where the Tar River intersects with the Town of Tarboro Corporate Limits; thence running Southwesterly with the Town of Tarboro Corporate Limits to point (3) at the intersection of U.S. Highway 64 Alternate and N.C. Highway 33; thence running along and with the Town of Tarboro Corporate Limits westerly to point (4) on U.S. Highway 64 Alternate 1.1 miles west of its intersection with S.R. 1207 (McNair Road); thence running southerly along and with the Town of Tarboro Corporate Limits and line of the Princeville Volunteer Fire Department Fire Tax District to point (5) at the intersection of S.R. 1207 (McNair Road) and S.R. 1208 (Howard Avenue Extension); thence running in a westerly direction following the centerline of S.R. 1208 (Howard Avenue Extension) and along the line of the Princeville Volunteer Fire Department Fire Tax District to point (6) on S.R. 1208 (Howard Avenue Extension), 0.3 miles southwest of its intersection with S.R. 1225 (Kingsboro Road); thence continuing with the line of the Princeville Volunteer Fire Department Fire Tax District northwesterly to point (7) on S.R. 1223 (Antioch Road), a point which is 1.3 miles southwest of its intersection with S.R. 1225 (Kingsboro Road)~~

1 and also being a point in the line of the West Edgecombe Volunteer Fire Department
2 Fire Tax District; thence running northwesterly with the line of the West Edgecombe
3 Volunteer Fire Department Fire Tax District to point (8), on S.R. 1226 (Melton Road),
4 0.7 miles south of its intersection with U. S. Highway 64 Alternate; thence continuing
5 with the line of the West Edgecombe Volunteer Fire Department Fire Tax District in a
6 southwesterly direction to point (9) on U. S. Highway 64 Alternate, 0.4 miles west of its
7 intersection with S.R. 1226 (Melton Road); thence running in a northerly direction
8 continuing with the line of the West Edgecombe Volunteer Fire Department Fire Tax
9 District to and with Tar River to point (10) on N. C. Highway 97, 0.2 miles northwest
10 with its intersection with Leggett Road and also being in the line of the Battleboro
11 Volunteer Fire Department Harrison Fire Tax District; thence running northeasterly
12 along and with the line of the Battleboro Volunteer Fire Department Harrison Fire Tax
13 District to point 11 on S.R. 1407 (Battleboro Leggett Road), 1.2 miles northwest of its
14 intersection with S.R. 1408 (New Hope Church Road); thence continuing with the
15 Battleboro Volunteer Fire Department Harrison Fire Tax District northerly and
16 southerly to the line of the Leggett Volunteer Fire Department Fire Tax District and
17 along the Leggett Volunteer Fire Department Fire Tax District line to point (12) of S.R.
18 1407 (Battleboro Leggett Road), 0.4 miles southeast of its intersection with S.R. 1208
19 (New Hope Church Road) and thence continuing along and with the Leggett Volunteer
20 Fire Department Fire Tax District southeasterly to point (1) the point of beginning, all
21 as the same appears on a map on file in the Office of the Emergency Services
22 Coordinator of Edgecombe County in the Edgecombe County Administrative Offices at
23 201 St. Andrews Street in Tarboro, North Carolina and which has been signed and dated
24 by the Edgecombe County Emergency Services Coordinator, the Chief of the
25 Heartsease Volunteer Fire Department and the President of the Edgecombe County
26 Association of Volunteer Fire Departments. Beginning at point (1) on NC Highway 97,
27 1.0 miles east of its intersection with S.R. 1408 (New Hope Church Road) and said
28 beginning point also being in the common boundary of Heartsease Volunteer Fire
29 Department Fire Tax District and the Leggett Volunteer Fire Department Tax District
30 and thence running southeasterly with the line of the existing Leggett Volunteer Fire
31 Department Fire Tax District and following the Tar River to point (2) where the Tar
32 River intersects with the Town of Tarboro Corporate Limits; thence running
33 Southwesterly and Westerly with the Town of Tarboro Corporate Limits to point (3) on
34 US Highway 64 Alternate 1.1 miles west of its intersection with SR 1207 (McNair
35 Road); thence running southerly along and with the Town of Tarboro Corporate Limits
36 and line of the Princeville Volunteer Fire Department Fire Tax District to point (4) at
37 the intersection of SR 1207 (McNair Road) and SR 1208 (Howard Avenue Extension);
38 thence running in a westerly direction following the centerline of SR 1208 (Howard
39 Avenue Extension) and along the line of the Princeville Volunteer Fire Department Fire
40 Tax District to point (5) on SR 1208 (Howard Avenue Extension), 0.3 miles southwest
41 of its intersection with SR 1225 (Kingsboro Road); thence continuing with the line of
42 the Princeville Volunteer Fire Department Fire Tax District northwesterly to point (6)
43 on SR 1223 (Antioch Road), a point which is 1.3 miles southwest of its intersection
44 with SR 1225 (Kingsboro Road), and also being a point in the line of the West

1 Edgecombe Volunteer Fire Department Fire Tax District; thence running northwesterly
2 with the line of the West Edgecombe Volunteer Fire Department Fire Tax District to
3 point (7) on SR 1226 (Melton Road), 0.7 miles south of its intersection with US
4 Highway 64 Alternate; thence continuing with the line of the West Edgecombe
5 Volunteer Fire Department Fire Tax District in a southwesterly direction to point (8) on
6 US Highway 64 Alternate, 0.4 miles west of its intersection with SR 1226 (Melton
7 Road); thence running in a northerly direction continuing with the line of the West
8 Edgecombe Volunteer Fire Department Fire Tax District to and with Tar River to point
9 (9) on NC Highway 97, 0.2 miles east of its intersection with Leggett Road and also
10 being in the line of the Battleboro Volunteer Fire Department Harrison Fire Tax
11 District; thence running northeasterly along and with the line of the Battleboro
12 Volunteer Fire Department Harrison Fire Tax District to point (10) on SR 1407
13 (Battleboro-Leggett Road), 0.3 miles west of its intersection with SR 1408 (New Hope
14 Church Road); thence easterly to point (11), on SR 1407 (Battleboro-Leggett Road), 0.4
15 mile southeast of its intersection with SR 1408 (New Hope Church Road) including all
16 property between this and the preceding point; thence Southeasterly to point (1), the
17 beginning."

18 **SECTION 2.** Section 2 of Chapter 187 of the 1995 Session Laws reads as
19 rewritten:

20 "Sec. 2. The boundaries of the Harrison Fire Tax District in Edgecombe County are
21 as follows:

22 **HARRISON FIRE TAX DISTRICT**
23 **EDGECOMBE COUNTY**

24 ~~BEGINNING at point (1) at the common intersection of the Edgecombe County~~
25 ~~line, the centerline of the CSX Railroad and the Davenport Volunteer Fire Department~~
26 ~~Fire Tax District which intersection is 1.5 miles along the CSX Railroad north from the~~
27 ~~corporate limits of Battleboro; thence running in a southeasterly direction along and~~
28 ~~with the Davenport Volunteer Fire Department Fire Tax District line to point (2), on~~
29 ~~S.R. 1404 (Seven Bridges Road) 0.1 mile northeast of its intersection with S.R. 1411~~
30 ~~(Marriott Road); thence continuing with the line of the Davenport Volunteer Fire~~
31 ~~Department Fire Tax District line in a southeasterly direction 2.4 miles to point (3) at its~~
32 ~~intersection with the Leggett Volunteer Fire Department Fire Tax District line; thence~~
33 ~~running in a southerly direction along and with the Leggett Volunteer Fire Department~~
34 ~~Tax District line to its intersection with the Heartsease Volunteer Fire Department Fire~~
35 ~~Tax District line; and thence running along and with the Heartsease Volunteer Fire~~
36 ~~Department Fire Tax District line in a northeasterly direction and southerly direction to~~
37 ~~point (4), on S.R. 1407 (Battleboro Leggett Road), 0.6 miles west of its intersection~~
38 ~~with S.R. 1415 (Morningstar Church Road); thence continuing with the line of~~
39 ~~Heartsease Volunteer Fire Department Fire Tax District in a southeasterly direction to~~
40 ~~point (5), on N.C. Highway 97, 0.2 miles south of its intersection with S.R. 1406~~
41 ~~(Coolspring Road), thence continuing with the line of the Heartsease Volunteer Fire~~
42 ~~Department Fire Tax District line in a southeasterly direction to Tar River, a corner with~~
43 ~~the Heartsease Volunteer Fire Department Fire Tax District line and the West~~
44 ~~Edgecombe Volunteer Fire Department Fire Tax District line and then continuing with~~

1 the Tar River and the West Edgecombe Volunteer Fire Tax District line in and to its
2 intersection with the corporate limits of the City of Rocky Mount; and thence running
3 northeasterly and following the corporate limits of the City of Rocky Mount, the
4 Edgecombe County and Nash County lines and CSX Railroad to point (1), the
5 beginning point, all as shown on a map on file in the Office of the Emergency Services
6 Coordinator of Edgecombe County in the Edgecombe County Administrative Offices at
7 201 St. Andrews Street in Tarboro, North Carolina and which has been signed and dated
8 by the Edgecombe County Emergency Services Coordinator, the Chief of the Battleboro
9 Volunteer Fire Department and the President of the Edgecombe County Association of
10 Volunteer Fire Departments. The Harrison Fire Tax District within a part of Edgecombe
11 County is described as being that portion of Edgecombe County bounded by a line
12 beginning at Point (1) at the intersection of the Edgecombe County line and the CSX
13 Railroad line, 1.5 mile north of the Battleboro City limits; thence southeast to Point (2),
14 on SR 1404 (Seven Bridges Road), 0.1 mile northeast of its intersection with SR 1411
15 (Marriott Road); thence southeasterly 2.4 mile to Point (3), at its intersection with the
16 Leggett Fire Protection District; line to Point (4), on SR 1407 (Battleboro-Leggett
17 Road), 1.5 mile east of its intersection with SR 1415 (Morning Star Church Road);
18 thence southwesterly to Point (5), on NC Highway 97, 0.2 miles east of its intersection
19 with Leggett Road and the Heartsease Fire Protection District line; thence southwesterly
20 following the Tar River to Point (6), where the Tar River intersects with the Rocky
21 Mount City limits; thence northeasterly following the Rocky Mount City limits,
22 Edgecombe, Nash County lines and CSX Railroad to Point (1), to the beginning."

23 **SECTION 3.** This act becomes effective June 30, 2002.
