A BILL TO BE ENTITLED

1 AN ACT TO REMOVE THE 300 PLATE REQUIREMENT FROM SPECIAL  
2 LICENSE PLATES FOR WORLD WAR II AND KOREAN CONFLICT  
3 VETERANS' PLATES, TO MODIFY THE LOGO ON THE ROCKY MOUNTAIN  
4 ELK FOUNDATION SPECIAL LICENSE PLATE, AND TO AUTHORIZE THE  
5 DIVISION OF MOTOR VEHICLES TO ISSUE A SPECIAL LICENSE PLATE  
6 FOR AVIATION MAINTENANCE TECHNICIANS, NORTH CAROLINA  
7 AGRIBUSINESS, AND THE STATE'S OFFICIAL VEGETABLE, THE SWEET  
8 POTATO.  
9

10 The General Assembly of North Carolina enacts:

11 **SECTION 1.** G.S. 20-79.4(b)(27b) reads as rewritten:

12 "(b) Types. – The Division shall issue the following types of special registration  
13 plates:

14 ...

15 (27b) Military Wartime Veteran. – Issuable to either a member or veteran of  
16 the armed services of the United States who served during a period of  
17 war. If the person is a veteran of the armed services, then the veteran  
18 must be separated from the armed services under honorable conditions.  
19 The plate shall bear a word or phrase identifying the period of war and  
20 a replica of the campaign badge or medal awarded for that war. ~~The~~  
21 Except for World War II and Korean Conflict plates, the Division may  
22 not issue a plate authorized by this subdivision unless it receives at  
23 least 300 applications for that plate. A "period of war" is any of the  
24 following:

- 25 a. World War I, meaning the period beginning April 16, 1917, and  
26 ending November 11, 1918.  
27 b. World War II, meaning the period beginning December 7,  
28 1941, and ending December 31, 1946.

- 1 c. The Korean Conflict, meaning the period beginning June 27,  
2 1950, and ending January 31, 1955.
- 3 d. The Vietnam Era, meaning the period beginning August 5,  
4 1964, and ending May 7, 1975.
- 5 e. Desert Storm, meaning the period beginning August 2, 1990,  
6 and ending April 11, 1991.
- 7 f. Any other campaign, expedition, or engagement for which the  
8 United States Department of Defense authorizes a campaign  
9 badge or medal.

10 ..."

11 **SECTION 2.** G.S. 20-79.4(b)(36b) reads as rewritten:

12 "(b) Types. – The Division shall issue the following types of special registration  
13 plates:

14 ...

15 (36b) Rocky Mountain Elk Foundation. – Issuable to the registered owner of  
16 a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear  
17 the phrase "Rocky Mountain Elk Foundation" and a ~~replica of the~~  
18 ~~"Walking Bull" logo of the Rocky Mountain Elk Foundation, Inc. The~~  
19 ~~Division shall not develop this plate unless the approved by the Rocky~~  
20 ~~Mountain Elk Foundation, Inc. licenses, without charge, the State to~~  
21 ~~use the "Walking Bull" logo on the plate.~~

22 ...."

23 **SECTION 3.** G.S. 20-79.4(b)(3c) is recodified as G.S. 20-79.4(b)(3d) and  
24 G.S. 20-79.4(b)(45b) is recodified as G.S. 20-79.4(b)(45c).

25 **SECTION 4.** G.S. 20-79.4(b) is amended by adding two new subdivisions to  
26 read:

27 "(b) Types. – The Division shall issue the following types of special registration  
28 plates:

29 ...

30 (3c) Aviation Maintenance Technician. – Issuable to a person who is a  
31 Federal Aviation Authority certified Aviation Maintenance  
32 Technician. The plate shall bear the logo of the F.A.A. Airworthiness  
33 Program and the initials "A.M.T." The Division may not issue the  
34 plate authorized by this subdivision unless it receives at least 300  
35 applications for the plate.

36 ...

37 (28b) NC Agribusiness. – Issuable to the registered owner of a motor vehicle  
38 in accordance with G.S. 20-81.12. The plate shall bear the logo of the  
39 North Carolina Agribusiness Council, Inc., and the phrase 'NC's #1  
40 Industry'.

41 ...

42 (45b) Sweet Potato. – Issuable to the registered owner of a motor vehicle.  
43 The plate may bear a phrase and picture representing the State's  
44 official vegetable, the sweet potato. The Division may not issue the

plate authorized by this subdivision unless it receives at least 300 applications for the plate.

**SECTION 5.** G.S. 20-79.7(a) reads as rewritten:

"(a) Fees. – Upon request, the Division shall provide and issue free of charge one registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled veteran, and an ex-prisoner of war. All other special registration plates, including additional Congressional Medal of Honor, 100% Disabled Veteran, and Ex-Prisoner of War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

3 **SECTION 6.** G.S. 20-79.7(b) reads as rewritten:

4 "(b) Distribution of Fees. – The Special Registration Plate Account and the  
 5 Collegiate and Cultural Attraction Plate Account are established within the Highway  
 6 Fund. The Division must credit the additional fee imposed for the special registration  
 7 plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the  
 8 Collegiate and Cultural Attraction Plate Account (CCAPA), and the Natural Heritage  
 9 Trust Fund (NHTF), which is established under G.S. 113-77.7, as follows:

42 **SECTION 7.** G.S. 20-81.12 is amended by adding a new subsection to read:

43 "(b23) NC Agribusiness. – The Division must receive 300 or more applications for a  
 44 NC Agribusiness plate before the plate may be developed. The Division must transfer

1 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived  
2 from the sale of NC Agribusiness plates to the North Carolina Agribusiness Council,  
3 Inc., to be used to promote awareness of the importance of agribusiness in North  
4 Carolina."

5           **SECTION 8.** This act is effective when it becomes law.
