A BILL TO BE ENTITLED

AN ACT TO APPROPRIATE FUNDS TO ESTABLISH AN ADDITIONAL
SUPERIOR COURT JUDGE IN DISTRICT 24.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 7A-41(a) reads as rewritten:

"§ 7A-41. Superior court divisions and districts; judges.

(a) The counties of the State are organized into judicial divisions and superior court districts, and each superior court district has the counties, and the number of regular resident superior court judges set forth in the following table, and for districts of less than a whole county, as set out in subsection (b) of this section:

16 **SECTION 2.** The Governor shall appoint a superior court judge for the
 17 additional judgeship in Superior Court District 24 as authorized by Section 1 of this act.
 18 The successor to that judge shall be elected in the 2002 general election to serve an
 19 eight-year term.

20 **SECTION 3.** There is appropriated from the General Fund to the Judicial
 21 Department the sum of one hundred sixty-one thousand nine hundred forty-seven
 22 dollars (\$161,947) for the 2001-2002 fiscal year and the sum of one hundred forty-seven
 23 thousand seven hundred one dollars (\$147,701) for the 2002-2003 fiscal year to
 24 establish the additional superior court judge provided for in this act.

25 **SECTION 4.** This act becomes effective July 1, 2001.
