2 AN ACT TO PROVIDE A GREATER ROLE FOR THE STATE BOARD OF
3 ELECTIONS IN PERSONNEL DECISIONS CONCERNING COUNTY
4 ELECTION DIRECTORS; TO ENHANCE THE CERTIFICATION PROGRAM
5 FOR ELECTION OFFICIALS; TO REMOVE LIMITATIONS ON TWO
6 PROVISIONS CONCERNING PRECINCTS; TO CHANGE THE LENGTH OF
7 THE ONE-STOP VOTING PERIOD; TO ALLOW COUNTY BOARDS OF
8 ELECTIONS TO USE OTHER ONE-STOP SITES INSTEAD OF THE COUNTY
9 BOARD OFFICE AS LONG AS A NEARBY SITE IS PROVIDED; TO ALLOW
10 LATER ACCEPTANCE OF VOTER REGISTRATION APPLICATIONS; TO
11 PROVIDE FOR ELECTRONIC TRANSFER OF VOTER REGISTRATION
12 APPLICATIONS FROM THE DIVISION OF MOTOR VEHICLES; TO UPDATE
13 THE STATUTES CONCERNING VOTER REGISTRATION LIST
14 MAINTENANCE; TO REQUIRE PERMANENT VOTER REGISTRATION
15 NUMBERS; TO APPLY THE WRITE-IN STATUTE TO SUPERIOR COURT
16 JUDGE ELECTIONS; TO CORRECT A REFERENCE IN THE CAMPAIGN
17 FINANCE LAW; TO REQUIRE THAT ALL NEW PRECINCT LINES FOLLOW
18 CENSUS BLOCK LINES UNLESS THE EXECUTIVE DIRECTOR OF THE
19 STATE BOARD OF ELECTIONS GRANTS A WAIVER AFTER MAKING
20 CERTAIN FINDINGS; AND TO RENAME THE EXECUTIVE SECRETARY-
21 DIRECTOR OF THE STATE BOARD OF ELECTIONS THE "EXECUTIVE
22 DIRECTOR".

23 The General Assembly of North Carolina enacts:

24 **--CHANGES CONCERNING COUNTY ELECTION DIRECTORS.**

25 **SECTION 1.(a)** G.S. 163-35(b) reads as rewritten:

26 "(b) Appointment, Duties; Termination. – Upon receipt of a nomination from the
27 county board of elections stating that the nominee for director of elections is submitted

1 for appointment upon majority selection by the county board of elections the Executive
2 Secretary-Director shall issue a letter of appointment of such nominee to the chairman
3 of the county board of elections within 10 days after receipt of the nomination.
4 Thereafter, the county board of elections shall enter in its official minutes the specified
5 duties, responsibilities and designated authority assigned to the director by the county
6 board of elections. A copy of the specified duties, responsibilities and designated
7 authority assigned to the director shall be filed with the State Board of Elections.

8 The county board of elections may, by petition signed by a majority of the board,
9 recommend to the Executive Secretary-Director of the State Board of Elections the
10 termination of the employment of the county board's director of elections. The petition
11 shall clearly state the reasons for termination. Upon receipt of the petition, the
12 Executive Secretary-Director shall forward a copy of ~~same the petition~~ by certified mail,
13 return receipt requested, to the county director of elections involved. The county
14 director of elections may reply to ~~said the~~ petition within 15 days of receipt thereof.
15 Within 20 days of receipt of the county director of elections' reply or the expiration of
16 the time period allowed for the filing of ~~said the~~ reply, the State Executive
17 Secretary-Director shall render a decision as to the termination or retention of the
18 county director of elections. The decision of the Executive Secretary-Director of the
19 State Board of Elections shall be final unless ~~such the decision shall, is,~~ within 20 days
20 from the official date on which it was made, ~~be deferred by the State Board of Elections,~~
21 ~~Elections. in which event a public hearing shall be conducted by State Board or any~~
22 ~~single member designated by the remaining four members, in the county seat of the~~
23 ~~county involved. Following the conduct of public hearing and a decision by the State~~
24 ~~Board of Elections, the chairman of said Board shall notify the Executive~~
25 ~~Secretary Director of the State Board of Elections, in writing, of the decision resulting~~
26 ~~from the public hearing. If the State Board defers the decision, then the State Board~~
27 ~~shall make a final decision on the termination after giving the county director of~~
28 ~~elections an opportunity to be heard and to present witnesses and information to the~~
29 ~~State Board, and then notify the Executive Director of its decision in writing. If the~~
30 ~~decision, rendered by the State Board of Elections, results in concurrence with the~~
31 ~~decision entered by the Executive Secretary-Director, the decision becomes final. If the~~
32 ~~decision rendered by the Board is contrary to that entered by the Executive~~
33 ~~Secretary-Director, then the Executive Secretary-Director shall, within 15 days from the~~
34 ~~written notification, enter an amended decision consistent with the results of the~~
35 ~~decision by the State Board of Elections. The employment of any director of elections~~
36 ~~presently employed or hereafter employed shall not be terminated except in compliance~~
37 ~~with the procedures herein prescribed. For the purposes of this subsection the individual~~
38 ~~designated by the remaining four members of the State Board shall possess the same~~
39 ~~authority conferred upon the chairman pursuant to G.S. 163-23.~~

40 Upon majority vote on the recommendation of the Executive Director, the State
41 Board of Elections may initiate proceedings for the termination of a county director of
42 elections for just cause. If the State Board votes to initiate proceedings for termination,

1 the State Board shall state the reasons for the termination in writing and send a copy by
2 certified mail, return receipt requested, to the county director of elections. The director
3 has 15 days to reply in writing to the notice. The State Board shall make a final decision
4 on the termination after giving the county director of elections an opportunity to be
5 heard, present witnesses, and provide information to the State Board.

6 A county director of elections may be suspended, with pay, without warning for
7 causes relating to personal conduct detrimental to service to the county or to the State
8 Board of Elections, pending the giving of written reasons, in order to avoid the undue
9 disruption of work or to protect the safety of persons or property or for other serious
10 reasons. Any suspension may be initiated by the Executive Director but may not be for
11 more than five days. Upon placing a county director of elections on suspension, the
12 Executive Director shall, as soon as possible, reduce to writing the reasons for the
13 suspension and forward copies to the county director of elections, the members of the
14 county board of elections, and the State Board of Elections. If no action for termination
15 has been taken within five days, the county director of elections shall be fully reinstated.

16 Termination of any county director of elections shall comply with this subsection.
17 For the purposes of this subsection, the individual designated by the remaining four
18 members of the State Board shall possess the same authority conferred upon the
19 chairman pursuant to G.S. 163-23."

20 **SECTION 1.(b)** G.S. 163-35 is amended by adding a new subsection to
21 read:

22 "(e) **Training and Certification.** – The State Board of Elections shall conduct a
23 training program consisting of four weeks for each new county director of elections.
24 The director shall complete that program. Each director appointed after May 1995 shall
25 successfully complete a certification program as provided in G.S. 163-82.24(b) within
26 three years after appointment or by January 1, 2003, whichever occurs later."

27 **SECTION 1.(c)** This section becomes effective January 1, 2002.

28 **--CERTIFICATION OF ELECTION OFFICIALS.**

29 **SECTION 2.(a)** G.S. 163-82.24 reads as rewritten:

30 **"§ 163-82.24. Statewide training and certification for election officials.**

31 (a) **Training.** – The State Board of Elections shall conduct training programs in
32 election law and procedures. Every county elections director shall receive training
33 conducted by the State Board at least as often as required in the following schedule:

- 34 (1) Once during each odd-numbered year before the municipal election
35 held in the county;
- 36 (2) Once during each even-numbered year before the first partisan
37 primary; and
- 38 (3) Once during each even-numbered year after the partisan primaries but
39 before the general election.

40 Every member of a county board of elections shall receive training conducted by the
41 State Board at least once during the six months after the member's initial appointment
42 and at least once again during the first two years of the member's service. The State

1 Board of Elections shall promulgate rules for the training of precinct officials, which
2 shall be followed by the county boards of elections.

3 (b) Certification. – The State Board of Elections shall conduct a program for
4 certification of election officials. The program shall include training in election law and
5 procedures. Before issuing certification to an election official, the State Board shall
6 administer an examination designed to determine the proficiency of the official in
7 election law and procedures. The State Board shall set adequate standards for the
8 passage of the examination."

9 SECTION 2.(b) This section is effective when this act becomes law.

12 SECTION 3.(a) Section 3(b) of S.L. 1999-426 reads as rewritten:

13 "Section 3.(b) This section is effective when this act becomes ~~law and expires~~
14 ~~January 1, 2002. law."~~

15 SECTION 3.(b) This section is effective when this act becomes law.

16 ~~--REMOVE SUNSET AND 3-COUNTY PILOT LIMITATION FROM~~
17 ~~2-VOTING-PLACE-PER-PRECINCT PROVISION.~~

18 SECTION 4.(a) G.S. 163-130.2 reads as rewritten:

19 "~~§ 163-130.2. Temporary use of two voting places for certain precincts; pilot~~
20 ~~program. precincts.~~

21 A county board of elections, by unanimous vote of all its members, may propose to
22 designate two voting places to be used temporarily for the same precinct. The temporary
23 designation of a voting place shall continue only for the term of office of the county
24 board of elections making the designation. For any precinct that is temporarily given
25 two voting places, the county board shall assign every voter to one or the other of those
26 voting places.

27 The county board's proposal is subject to approval by the Executive
28 Secretary-Director of the State Board of Elections. The county board shall submit its
29 proposal in writing to the Executive Secretary-Director. ~~The Executive Secretary-~~
30 ~~Director may approve a proposal under this section in not more than three counties, to~~
31 ~~be a pilot program.~~ The Executive Secretary-Director shall approve that proposal only if
32 it finds all of the following:

- 33 (1) That the precinct has more registered voters than can adequately be
34 accommodated by any single potential voting place available for the
35 precinct.
- 36 (2) That no boundary line that complies with Article 12A of this Chapter
37 can be identified that adequately divides the precinct.
- 38 (3) That the county board can account for, by street address number, the
39 location of every registered voter in the precinct and fix that voter's
40 residence with certainty on a map.
- 41 (4) That no more than three other precincts in the same county will have
42 two voting places.

- 1 (5) That both voting places for the precinct would have adequate facilities
2 for the elderly and disabled.
3 (6) That the proposal provides adequately for security against fraud.
4 (7) That the proposal does not unfairly favor or disfavor voters with regard
5 to race or party affiliation.

6 The county board shall designate a full set of precinct officials, in the manner set forth
7 in Article 5 of this Chapter, for each voting place designated for the precinct."

8 **SECTION 4.(b)** Section 4(b) of S.L. 1999-426 reads as rewritten:

9 "Section 4.(b) This section becomes effective January 2, 2000, ~~and expires January~~
10 ~~2, 2002.~~ 2000. The Executive Secretary-Director of the State Board of Elections shall
11 study the operation and consequences of the pilot program created by this section and
12 report findings and recommendations to the 2001 General Assembly by February 1,
13 2001."

14 **SECTION 4.(c)** This section is effective when this act becomes law.

15 **--CHANGES CONCERNING ONE-STOP VOTING.**

16 **SECTION 5.(a)** G.S. 163-227.2(b) reads as rewritten:

17 "(b) Not earlier than the ~~first business day after the twenty fifth day~~ third
18 Thursday before an election, in which absentee ballots are authorized, in which a voter
19 seeks to vote and not later than ~~5:00~~ 1:00 p.m. P.M. on the ~~Friday prior to last Saturday~~
20 before that election, the voter shall appear in person only at the office of the county
21 board of elections, except as provided in subsection ~~(f1)~~ (g) of this section. A county
22 board of elections shall conduct one-stop voting on the last Saturday before the election
23 until 1:00 P.M. and may conduct it until 5:00 P.M. on that Saturday. That voter shall
24 enter the voting enclosure at the board office through the appropriate entrance and shall
25 at once state his or her name and place of residence to an authorized member or
26 employee of the board.

27 In a primary election, the voter shall also state the political party with which the
28 voter affiliates and in whose primary the voter desires to vote, or if the voter is an
29 unaffiliated voter permitted to vote in the primary of a particular party under G.S.
30 163-119, the voter shall state the name of the authorizing political party in whose
31 primary he wishes to vote. The board member or employee to whom the voter gives this
32 information shall announce the name and residence of the voter in a distinct tone of
33 voice. After examining the registration records, an employee of the board shall state
34 whether the person seeking to vote is duly registered. If the voter is found to be
35 registered that voter may request that the authorized member or employee of the board
36 furnish the voter with an application form as specified in G.S. 163-227. The voter shall
37 complete the application in the presence of the authorized member or employee of the
38 board, and shall deliver the application to that person."

39 **SECTION 5.(b)** G.S. 163-227.2(f) reads as rewritten:

40 "(f) Notwithstanding the exception specified in G.S. 163-36, counties which
41 operate a modified full-time office shall remain open five days each week during
42 regular business hours consistent with daily hours presently observed by the county

1 board of elections, commencing with the date prescribed in G.S. 163-227.2(b) and
2 continuing until 5:00 ~~p.m.~~ P.M. on the Friday prior to that election ~~or primary~~ and shall
3 also be open on the last Saturday before the election. A county board may conduct one-
4 stop absentee voting during evenings or on weekends, as long as the hours are part of a
5 plan submitted and approved according to subsection (g) of this section. The boards of
6 county commissioners shall provide necessary funds for the additional operation of the
7 office during that time."

8 **SECTION 5.(c)** G.S. 163-227.2(g) reads as rewritten:

9 "(g) Notwithstanding any other provision of this section, a county board of
10 elections by unanimous vote of all its members may provide for one or more sites in that
11 county for absentee ballots to be applied for and cast under this section. Any site other
12 than the county board of elections office shall be in any building or part of a building
13 that the county board of elections is entitled under G.S. 163-129 to demand and use as a
14 voting place. Every individual staffing any of those sites shall be a member or full-time
15 employee of the county board of elections or an employee of the county board of
16 elections whom the board has given training equivalent to that given a full-time
17 employee. Those sites must be approved by the State Board of Elections as part of a
18 Plan for Implementation approved by both the county board of elections and by the
19 State Board of Elections which shall also provide adequate security of the ballots and
20 provisions to avoid allowing persons to vote who have already voted. The Plan for
21 Implementation shall include a provision for the presence of political party observers at
22 each one-stop site equivalent to the provisions in G.S. 163-45 for party observers at
23 voting places on election day. A county board of elections may propose in its Plan not
24 to offer one-stop voting at the county board of elections office; the State Board may
25 approve that proposal in a Plan only if the Plan includes at least one site reasonably
26 proximate to the county board of elections office and the State Board finds that the sites
27 in the Plan as a whole provide adequate coverage of the county's electorate. If a county
28 board of elections has considered a proposed Plan or Plans for Implementation and has
29 been unable to reach unanimity in favor of a Plan, a member or members of that county
30 board of elections may petition the State Board of Elections to adopt a plan for it. If
31 petitioned, the State Board may also receive and consider alternative petitions from
32 another member or members of that county board. The State Board of Elections may
33 adopt a Plan for that county. The State Board, in that plan, shall take into consideration
34 factors including geographic, demographic, and partisan interests of that county."

35 **SECTION 5.(d)** This section becomes effective with respect to primaries
36 and elections held on or after January 1, 2002.

37 **--LATER REGISTRATION DEADLINE ON FINAL DAY.**

38 **SECTION 6.(a)** G.S. 163-82.6(c) reads as rewritten:

39 "(c) Registration Deadlines for an Election. – In order to be valid for an election,
40 the form:

- 41 (1) If submitted by mail, must be postmarked at least 25 days before the
42 election, except that any mailed application on which the postmark is

1 missing or unclear is validly submitted if received in the mail not later
2 than 20 days before the election,

3 (2) If submitted in person, must be received by the county board of
4 elections by ~~5:00 p.m.~~ a time established by that board, but no earlier
5 than 5:00 P.M., on the twenty-fifth day before the election,

6 (3) If submitted through a delegatee who violates the duty set forth in
7 subsection (a) of this section, must be signed by the applicant and
8 given to the delegatee not later than 25 days before the election, except
9 as provided in subsection (d) of this section."

10 **SECTION 6.(b)** This section becomes effective with respect to primaries
11 and elections held on or after January 1, 2002.

12 **--ELECTRONIC TRANSFER OF DMV REGISTRATIONS.**

13 **SECTION 7.(a)** G.S. 163-82.19 reads as rewritten:

14 **"§ 163-82.19. Voter registration at drivers license offices.**

15 The Division of Motor Vehicles shall, pursuant to the rules adopted by the State
16 Board of Elections, modify its forms so that any eligible person who applies for original
17 issuance, renewal or correction of a drivers license, or special identification card issued
18 under G.S. 20-37.7 may, on a part of the form, complete an application to register to
19 vote or to update his registration if the voter has changed his address or moved from one
20 precinct to another or from one county to another. The person taking the application
21 shall ask if the applicant is a citizen of the United States. If the applicant states that the
22 applicant is not a citizen of the United States, or declines to answer the question, the
23 person taking the application shall inform the applicant that it is a felony for a person
24 who is not a citizen of the United States to apply to register to vote. Any person who
25 willfully and knowingly and with fraudulent intent gives false information on the
26 application is guilty of a Class I felony. The application shall state in clear language the
27 penalty for violation of this section. The necessary forms shall be prescribed by the
28 State Board of Elections. The form must ask for the previous voter registration address
29 of the voter, if any. If a previous address is listed, and it is not in the county of residence
30 of the applicant, the appropriate county board of elections shall treat the application as
31 an authorization to cancel the previous registration and also process it as such under the
32 procedures of G.S. 163-82.9. If a previous address is listed and that address is in the
33 county where the voter applies to register, the application shall be processed as if it had
34 been submitted under G.S. 163-82.9.

35 Registration shall become effective as provided in G.S. 163-82.7. Applications to
36 register to vote accepted at a drivers license office under this section until the deadline
37 established in G.S. 163-82.6(c)(2) shall be treated as timely made for an election, and no
38 person who completes an application at that drivers license office shall be denied the
39 vote in that election for failure to apply earlier than that deadline.

40 All applications shall be forwarded by the Department of Transportation to the
41 appropriate board of elections not later than five business days after the date of
42 acceptance, according to rules which shall be promulgated by the State Board of

1 Elections. Those rules shall provide for a paperless, instant, electronic transfer of
2 applications to the appropriate county board of elections."

3 SECTION 7.(b) This section becomes effective with respect to primaries and
4 elections held on or after January 1, 2002.

5 **--UPDATING OF VOTER REGISTRATION LIST MAINTENANCE**
6 **PROVISION TO REFLECT CURRENT FEDERALLY APPROVED**
7 **PRACTICE.**

8 **SECTION 8.(a)** G.S. 163-82.14(d) reads as rewritten:

9 "(d) Change of Address. – A county board of elections shall conduct a systematic
10 program to remove from its list of registered voters those who have moved out of the
11 county, and to update the registration records of persons who have moved within the
12 county. The county board shall remove a person from its list if the registrant:

- 13 (1) Gives confirmation in writing of a change of address for voting
14 purposes out of the county. "Confirmation in writing" for purposes of
15 this subdivision shall include:
- 16 a. A report to the county board from the Department of
17 Transportation or from a voter registration agency listed in G.S.
18 163-82.20 that the voter has reported a change of address for
19 voting purposes outside the county;
 - 20 b. A notice of cancellation received under G.S. 163-82.9; or
 - 21 c. A notice of cancellation received from an election jurisdiction
22 outside the State.
- 23 (2) Fails to respond to a confirmation mailing sent by the county board in
24 accordance with this subdivision and does not vote or appear to vote in
25 an election beginning on the date of the notice and ending on the day
26 after the date of the second general election for the United States
27 House of Representatives that occurs after the date of the notice. A
28 county board sends a confirmation notice in accordance with this
29 subdivision if the notice:
- 30 a. Is a postage prepaid and preaddressed return card, sent by
31 forwardable mail, on which the registrant may state current
32 address;
 - 33 b. Contains or is accompanied by a notice to the effect that if the
34 registrant did not change residence but remained in the county,
35 the registrant should return the card not later than the deadline
36 for registration by mail in G.S. 163-82.6(c)(1); and
 - 37 c. Contains or is accompanied by information as to how the
38 registrant may continue to be eligible to vote if the registrant
39 has moved outside the county.

40 A county board shall send a confirmation mailing in accordance with
41 this subdivision ~~if the to every registrant remains on the list, the~~
42 ~~registrant has not voted in two successive presidential elections or in~~

1 ~~any election in between, and after every congressional election if the~~
2 ~~county board has not confirmed the registrant's address by another~~
3 ~~means. The county board may send a confirmation mailing in~~
4 ~~accordance with this subdivision if the registrant has been identified as~~
5 ~~residing outside the county through change of address information~~
6 ~~supplied by the Postal Service through its licensees."~~

7 **SECTION 8.(b)** This section is effective when this act becomes law.

8 **--PERMANENT VOTER REGISTRATION NUMBERS.**

9 **SECTION 8.1.(a)** Article 7A of Chapter 163 of the General Statutes is
10 amended by adding a new section to read:

11 "**§ 163-82.10A. Permanent voter registration numbers.**

12 Each county board of elections shall assign to each voter a registration number. That
13 number shall be permanent for that voter and shall not be changed or reassigned by the
14 county board of elections."

15 **SECTION 8.1.(b)** This section becomes effective January 1, 2002.

16 **--APPLYING WRITE-IN STATUTE TO SUPERIOR COURT JUDGE**
17 **ELECTIONS.**

18 **SECTION 9.(a)** G.S. 163-123(g) reads as rewritten:

19 "(g) Municipal and Nonpartisan Elections Excluded. – This section does not apply
20 to municipal elections conducted under Subchapter IX of Chapter 163 of the General
21 Statutes, and does not apply to nonpartisan ~~elections~~elections except for superior court
22 judge elections under Article 25 of this Chapter."

23 **SECTION 9.(b)** This section is effective when this act becomes law.

24 **--CORRECTING REFERENCE TO FUND FOR RETURNING ILLEGAL**
25 **CONTRIBUTIONS.**

26 **SECTION 10.(a)** G.S. 163-278.14(a) reads as rewritten:

27 "(a) No individual, political committee, or other entity shall make any
28 contribution anonymously, except as provided in G.S. 163-278.8(d), or in the name of
29 another. No candidate, political committee, referendum committee, political party, or
30 treasurer shall knowingly accept any contribution made by any individual or person in
31 the name of another individual or person or made anonymously except as provided in
32 G.S. 163-278.8(d). If a candidate, political committee, referendum committee, political
33 party, or treasurer receives anonymous contributions or contributions determined to
34 have been made in the name of another, he shall pay the money over to the Board, by
35 check, and all such moneys received by the Board shall be deposited in the ~~general fund~~
36 Civil Penalty and Forfeiture Fund of the State of North Carolina."

37 **SECTION 10.(b)** This section is effective when this act becomes law.

38 **--PRECINCTS TO FOLLOW CENSUS BLOCK BOUNDARIES.**

39 **SECTION 10.1.** G.S. 163-132.3(a) reads as rewritten:

40 "**§ 163-132.3. Alterations to approved precinct boundaries.**

1 (a) No county board of elections may change any precinct boundary unless the
2 proposed new precinct consists solely of contiguous territory and its new boundaries are
3 coterminous with those of:

4 (1) ~~Townships, as certified by the county manager, or the chairman of the~~
5 ~~board of county commissioners if there is not a county manager, on the~~
6 ~~official map of the county;~~

7 (2) ~~The of census blocks established under the latest U.S. Census or the~~
8 ~~boundaries contained on the latest preliminary U.S. Census maps,~~
9 ~~issued under P.L. 94-171, whichever occurs later;~~

10 (3) ~~The following visible physical features, readily distinguishable upon~~
11 ~~the ground:~~

12 a. ~~Roads or streets;~~

13 b. ~~Water features or drainage features;~~

14 c. ~~Ridgelines;~~

15 d., e. ~~Repealed by Session Laws 1999-227, s. 1.~~

16 f. ~~Rail features;~~

17 g. ~~Major above-ground power lines; or~~

18 h. ~~Major footpaths~~

19 ~~as certified by the North Carolina Department of Transportation on its~~
20 ~~highway maps or the county manager of the relevant county or, if there~~

26 The county boards of elections shall report precinct boundary changes by filing with
27 the Legislative Services Office on current official census maps or maps certified by the
28 North Carolina Department of Transportation or the county's planning department or on
29 other maps or electronic databases approved by the Executive Secretary-Director the
30 new boundaries of these precincts. The Executive Secretary-Director may require a
31 county board of elections to file a written description of the boundaries of any precinct
32 or part thereof. No newly created or altered precinct boundary is effective until
33 approved by the Executive Secretary-Director of the State Board as being in compliance
34 with this subsection. No precinct may be changed under this section between the date its
35 boundaries become effective under G.S. 163-132.1(c) and January 2, 2002. Any
36 changes to precincts during that period shall be made as provided in G.S. 163-132.1(d).

37 (b) The Executive Secretary-Director of the State Board of Elections and the
38 Legislative Services Office shall examine the maps of the proposed new or altered
39 precincts and any required written descriptions. After its examination of the maps and
40 their written descriptions, the Legislative Services Office shall submit to the Executive
41 Secretary-Director of the State Board of Elections its opinion as to whether all of the
42 proposed precinct boundaries are in compliance with subsection (a) of this section, with

1 notations as to where those boundaries do not comply with these standards. If the
2 Executive Secretary-Director of the State Board determines that all precinct boundaries
3 are in compliance with this section, the Executive Secretary-Director of the State Board
4 shall approve the maps and written descriptions as filed and these precincts shall be the
5 official precincts.

6 (c) If the Executive Secretary-Director of the State Board determines that the
7 proposed precinct boundaries are not in compliance with subsection (a) of this section,
8 ~~he—the Executive Director shall not approve those precinct boundaries. He—The~~
9 Executive Director shall notify the county board of elections of his disapproval
10 specifying the reasons. The county board of elections may then resubmit new precinct
11 maps and written descriptions to cure the reasons for their disapproval.

12 (d) Upon a determination that restricting the county board to using Census block
13 boundaries would force the county board to draw a precinct without an adequate voting
14 place or otherwise to draw a precinct in such a way that the administration of elections
15 would be seriously hindered, the Executive Director may permit a county board of
16 elections to designate a precinct boundary on a line that is not a Census block boundary
17 of the most recent federal decennial Census if both the following conditions exist:

18 (1) The feature desired by the county board to be the precinct boundary
19 meets at least one of the following:

- 20 a. Is likely to be designated by the Census Bureau as a block
21 boundary in the next federal decennial Census.
22 b. Is a visible physical feature, readily distinguishable upon the
23 ground, as certified by the North Carolina Department of
24 Transportation on its highway maps or by the county manager
25 of the relevant county or if there is no county manager the chair
26 of the county board of commissioners on official county maps,
27 of the following nature:
28 1. Roads or streets.
29 2. Water features or drainage features.
30 3. Ridgelines.
31 4. Rail features.
32 5. Major aboveground power lines.
33 6. Major footpaths.
34 c. Is a municipalities boundary, as certified by the city clerk on the
35 official map of the city.
36 d. Is a township boundary, as certified by the county manager, or
37 the chair of the county board of commissioners if there is no
38 county manager, on the official map of the county.

39 (2) All the following are true:

- 40 a. The precincts of which the line is a boundary which could be
41 combined into a unit whose outer boundaries would be Census

- 1 blocks, similar to the Combined Reporting Unit permitted by
2 G.S. 163-132.1(c)(6).
3 b. That combined unit would be reasonable in size.
4 c. That combined unit, together with all other such combined
5 units, would not undermine the coverage of the State's precincts
6 in the next Census."

7 **--NAME CHANGE TO EXECUTIVE DIRECTOR.**

8 **SECTION 11.** The Revisor of Statutes shall change the term "Executive
9 Secretary-Director" and the term "State Executive Secretary-Director" to "Executive
10 Director" wherever it appears in the General Statutes in reference to the State Board of
11 Elections Executive Secretary-Director.

12 **SECTION 12.** The headings to the sections of this act are a convenience to
13 the reader and are for reference only. The headings do not expand, limit, or define the
14 text of this act.

15 **SECTION 13.** Except as otherwise provided in each section, this act is
16 effective when it becomes law.
