Access to voting enclosure. 7 In all counties, only the following persons shall be allowed within the voting 8 enclosure while the polls are open to voting: 9 Officers of election, that is, members of the State Board of Elections, (1) members of the county board of elections, directors of elections, and 10 the precinct chief judge, precinct judges of election, and assistants 11 12 appointed for the precinct under the provisions of G.S. 163-42. Voters in the act of voting. 13 (2) A near relative of a voter, but except as provided in subdivision (3a) of 14 (3) this section only while assisting the voter as authorized in G.S. 15 163-152. 16 17 A minor child of the voter, but only while accompanying the voter and (3a) while under the control of the voter. 18 19 Any voter of the precinct called upon to assist another voter, but only (4) 20 while assisting him as authorized in G.S. 163-152. 21 Municipal policemen assigned by the municipal authorities to keep the (5) 22 peace at a voting place located within the municipality, but only when
