A BILL TO BE ENTITLED

2 AN ACT TO PROVIDE FOR THE MEMBERSHIP AND METHOD OF  
3 APPOINTING THE MEMBERS OF THE MOUNT AIRY PLANNING BOARD  
4 AND THE ZONING BOARD OF ADJUSTMENT OF AND FOR THE CITY OF  
5 MOUNT AIRY UPON THE ADOPTION OF AN ORDINANCE BY THE CITY  
6 OF MOUNT AIRY EXTENDING ITS JURISDICTION ONE MILE BEYOND ITS  
7 CORPORATE LIMITS.

8 The General Assembly of North Carolina enacts:

9       **SECTION 1.(a)** The City of Mount Airy shall create a Planning Board and a  
10 Zoning Board of Adjustment pursuant to Article 19 of Chapter 160A of the General  
11 Statutes upon extending its extraterritorial jurisdiction one mile beyond the corporate  
12 limits by ordinance.

13       **SECTION 1.(b)** The Planning Board shall consist of nine members. Five  
14 members of the Planning Board shall be appointed by the Board of Commissioners of  
15 the City of Mount Airy, and four of the members shall be appointed by the Board of  
16 Commissioners of Surry County.

17       **SECTION 1.(c)** Three members of the Planning Board shall be appointed  
18 for terms of four years and two members of the Planning Board shall be appointed for  
19 terms of two years by the City of Mount Airy. Two members of the Planning Board  
20 shall be appointed for a term of four years and two members of the Planning Board shall  
21 be appointed for a term of two years by Surry County.

22       **SECTION 1.(d)** The Zoning Board of Adjustment shall consist of nine  
23 regular members and two alternate members. Five members of the Zoning Board of  
24 Adjustment shall be appointed by the Board of Commissioners of the City of Mount  
25 Airy, and four members shall be appointed by the Board of Commissioners of Surry  
26 County. One alternate member shall be appointed by the City of Mount Airy, and one  
27 alternate member shall be appointed by Surry County. Members and alternate members  
28 may be reappointed.

1           **SECTION 1.(e)** Three members of the Zoning Board of Adjustment shall be  
2 appointed for terms of four years, and two members of the Zoning Board of Adjustment  
3 shall be appointed for a term of two years by the City of Mount Airy. Two members of  
4 the Zoning Board of Adjustment shall be appointed for four years, and two members of  
5 the Zoning Board of Adjustment shall be appointed for a term of two years by Surry  
6 County. The alternate members shall be appointed for terms of two years by the City of  
7 Mount Airy and Surry County.

8           **SECTION 2.** This act applies to the City of Mount Airy and to Surry County  
9 only.

10           **SECTION 3.** This act is effective when it becomes law.
