Short Title: Magistrate Can Carry Gun in Courthouse. (Public)

Sponsors: Representatives Hurley, Justus, Spear, and Sutton (Primary Sponsors).

1 A BILL TO BE ENTITLED  
2 AN ACT TO PROVIDE THAT A MAGISTRATE WHO HAS A CONCEALED HANDGUN  
3 PERMIT MAY CARRY OR POSSESS A CONCEALED HANDGUN WHILE IN A  
4 COURTHOUSE TO DISCHARGE OFFICIAL DUTIES.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 14-269.4 reads as rewritten:

7 "**§ 14-269.4. Weapons on State property and in courthouses.**

8 It shall be unlawful for any person to possess, or carry, whether openly or concealed, any  
9 deadly weapon, not used solely for instructional or officially sanctioned ceremonial purposes in  
10 the State Capitol Building, the Executive Mansion, the Western Residence of the Governor, or  
11 on the grounds of any of these buildings, and in any building housing any court of the General  
12 Court of Justice. If a court is housed in a building containing nonpublic uses in addition to the  
13 court, then this prohibition shall apply only to that portion of the building used for court  
14 purposes while the building is being used for court purposes.

15 This section shall not apply to:

19 (4a) Any person in a building housing a court of the General Court of Justice in  
20 possession of a weapon for evidentiary purposes, to deliver it to a  
21 law-enforcement agency, or for purposes of registration,  
22 (4b) Any magistrate, district court ~~judge~~-~~judge~~, or superior court judge who  
23 carries or possesses a concealed handgun in a building housing a court of the  
24 General Court of Justice if the magistrate or judge is in the building to  
25 discharge his or her official duties and the magistrate or judge has a  
26 concealed handgun permit issued in accordance with Article 54B of this  
27 Chapter or considered valid under G.S. 14-415.24,  
28 (4c) Firearms in a courthouse, carried by detention officers employed by and  
29 authorized by the sheriff to carry firearms,  
30 (5) State-owned rest areas, rest stops along the highways, and State-owned  
31 hunting and fishing reservations.

32 Any person violating the provisions of this section shall be guilty of a Class 1  
33 misdemeanor."

34 **SECTION 2.** This act is effective when it becomes law.
