1 A JOINT RESOLUTION SETTING THE TIME FOR ADJOURNMENT OF THE 2009  
2 GENERAL ASSEMBLY TO MEET IN 2010 AND LIMITING THE SUBJECTS THAT  
3 MAY BE CONSIDERED IN THAT SESSION.

4 Be it resolved by the Senate, the House of Representatives concurring:

5 **SECTION 1.** When the Senate and the House of Representatives adjourn, they  
6 stand adjourned to reconvene on Wednesday, May 12, 2010, at 12:00 noon.

7 **SECTION 2.** During the regular session that reconvenes on Wednesday, May 12,  
8 2010, only the following matters may be considered:

9 (1) Bills directly and primarily affecting the State budget, including the budget  
10 of an occupational licensing board, for fiscal year 2009-2010, provided that  
11 the bill must be submitted to the Bill Drafting Division of the Legislative  
12 Services Office no later than 4:00 P.M. Friday, May 14, 2010, and must be  
13 introduced in the House of Representatives or filed for introduction in the  
14 Senate no later than 4:00 P.M. Tuesday, May 25, 2010.

15 (2) Bills amending the Constitution of North Carolina.

16 (3) Bills and resolutions introduced in 2009 and having passed third reading in  
17 2009 in the house in which introduced, received in the other house in  
18 accordance with Senate Rule 41 or House Rule 31.1(d) as appropriate, and  
19 not disposed of in the other house by tabling, unfavorable committee report,  
20 indefinite postponement, or failure to pass any reading, and which do not  
21 violate the rules of the receiving house.

22 (4) Bills and resolutions implementing the recommendations of:

- 23 a. Study commissions, authorities, and statutory commissions  
24 authorized or directed to report to the 2010 Session;  
25 b. The General Statutes Commission, the Courts Commission, or any  
26 commission created under Chapter 120 of the General Statutes that is  
27 authorized or directed to report to the General Assembly;  
28 c. The House Ethics Committee;  
29 d. Select committees; or  
30 e. The Joint Legislative Ethics Committee or its Advisory  
31 Subcommittee.

32 A bill authorized by this subdivision must be submitted to the Bill Drafting  
33 Division of the Legislative Services Office no later than 4:00 P.M.  
34 Wednesday, May 12, 2010, and must be filed for introduction in the Senate  
35 or introduced in the House of Representatives no later than 4:00 P.M.  
36 Wednesday, May 19, 2010.



- 1 (5) Any local bill that has been submitted to the Bill Drafting Division of the  
2 Legislative Services Office by 4:00 P.M. Wednesday, May 19, 2010, is  
3 introduced in the House of Representatives or filed for introduction in the  
4 Senate by 4:00 P.M. Wednesday, May 26, 2010, and is accompanied by a  
5 certificate signed by the principal sponsor stating that no public hearing will  
6 be required or asked for by a member on the bill, the bill is noncontroversial,  
7 and that the bill is approved for introduction by each member of the House  
8 of Representatives and Senate whose district includes the area to which the  
9 bill applies.
- 10 (6) Selection, appointment, or confirmation of members of State boards and  
11 commissions as required by law, including the filling of vacancies of  
12 positions for which the appointees were elected by the General Assembly  
13 upon recommendation of the Speaker of the House of Representatives,  
14 President of the Senate, or President Pro Tempore of the Senate.
- 15 (7) Any matter authorized by joint resolution passed by a two-thirds majority of  
16 the members of the House of Representatives present and voting and by a  
17 two-thirds majority of the members of the Senate present and voting. A bill  
18 or resolution filed in either house under the provisions of this subdivision  
19 shall have a copy of the ratified enabling resolution attached to the jacket  
20 before filing for introduction in the Senate or introduction in the House of  
21 Representatives.
- 22 (8) A joint resolution authorizing the introduction of a bill pursuant to  
23 subdivision (6) of this section.
- 24 (9) Any bills primarily affecting any State or local pension or retirement system,  
25 provided that the bill has been submitted to the Bill Drafting Division of the  
26 Legislative Services Office no later than 4:00 P.M. Wednesday, May 19,  
27 2010, and is introduced in the House of Representatives or filed for  
28 introduction in the Senate no later than 4:00 P.M. Wednesday, May 26,  
29 2010.
- 30 (10) Joint resolutions, House resolutions, and Senate resolutions authorized for  
31 introduction under Senate Rule 40(b) or House Rule 31.
- 32 (11) A joint resolution adjourning the 2009 Regular Session, sine die.
- 33 (12) Bills to disapprove rules under G.S. 150B-21.3.

34 **SECTION 3.** The Speaker of the House of Representatives or the President Pro  
35 Tempore of the Senate may authorize appropriate committees or subcommittees of their  
36 respective houses to meet during the interims between sessions to:

- 37 (1) Review matters related to the State budget for the 2009-2011 biennium,  
38 (2) Prepare reports, including revised budgets, or  
39 (3) Consider any other matters as the Speaker of the House of Representatives  
40 or the President Pro Tempore of the Senate deems appropriate, except that  
41 no committee or subcommittee of a house may consider, after the date of  
42 adjournment provided in Section 1 of this resolution and before the date of  
43 reconvening provided in Section 2 of this resolution, any bill, or proposed  
44 committee substitute for such bill, which originated in the other house. A  
45 conference committee may meet in the interim upon approval by the Speaker  
46 of the House of Representatives or the President Pro Tempore of the Senate.

47 **SECTION 4.** This resolution is effective upon ratification.
