1 A HOUSE RESOLUTION HONORING THE LIFE AND MEMORY OF GORDON PHILLIP  
2 ALLEN, SR., FORMER MEMBER OF THE GENERAL ASSEMBLY.

3 Whereas, Gordon Phillip Allen, Sr. was born on April 29, 1929, in Roxboro, North  
4 Carolina, to George Lemuel Allen and Sallie Wilkerson Allen; and

5 Whereas, Gordon Phillip Allen, Sr. graduated from Roxboro High School in 1947  
6 and received an associate's degree from Mars Hill College in 1949; and

7 Whereas, Gordon Phillip Allen, Sr. served as a 1<sup>st</sup> lieutenant in the United States  
8 Army during the Korean War, earning a Bronze Star, and served as Commanding Officer in the  
9 North Carolina National Guard following the war; and

10 Whereas, in 1954, Gordon Phillip Allen, Sr. began a career in the insurance business  
11 and later became a partner in the Thompson-Allen Insurance Agency; and

12 Whereas, Gordon Phillip Allen, Sr. earned the respect of his colleagues and  
13 represented them as Director of Independent Insurance Agents of North Carolina; and

14 Whereas, Gordon Phillip Allen, Sr. served with honor and distinction as a member  
15 of the General Assembly for three terms in the Senate from 1969 to 1975, where he served as  
16 President Pro Tempore during the 1971 and 1973 sessions, and in the House of Representatives  
17 from 1997 to 2005, where he served as Chair of the Finance Committee; and

18 Whereas, Gordon Phillip Allen, Sr. served as a lobbyist for the North Carolina  
19 Bankers Association from 1977 to 1997 and was honored when the Association named its  
20 annual service award the "Gordon P. Allen Award for Public Service"; and

21 Whereas, Gordon Phillip Allen, Sr. served as President of the Roxboro Chamber of  
22 Commerce, President of the Roxboro Kiwanis Club, Chair of the Person County Economic  
23 Development Commission, and Cochair of the Person Memorial Hospital Building Project; and

24 Whereas, Gordon Phillip Allen, Sr. served as Chair of the Board of Directors of  
25 Home Savings of Durham, a member of the Board of Directors of both Central Carolina Bank  
26 of Durham and Peoples Bank, and served on the Board of Trustees of the Piedmont Community  
27 College for more than 30 years; and

28 Whereas, Gordon Phillip Allen, Sr. received numerous awards and honors,  
29 including the 1959 Jaycees Distinguished Service Award, Thirty Year Service Award from  
30 Piedmont Community College, 1999 Distinguished Service Award from Mars Hill College, and  
31 the Order of the Long Leaf Pine; and

32 Whereas, Gordon Phillip Allen, Sr. was a member of Long Memorial United  
33 Methodist Church of Roxboro; and

34 Whereas, Gordon Phillip Allen, Sr. of Roxboro died on December 23, 2010, at the  
35 age of 81; and



1           Whereas, Gordon Phillip Allen, Sr. was married to the late Betsy Harris Allen for  
2 55 years and is survived by his children, Phillip Allen, Kassie McCollum, Betsy Reade Creech,  
3 George Allen, and Page Allen, and 17 grandchildren; Now, therefore,

4 Be it resolved by the House of Representatives:

5           **SECTION 1.** The House of Representatives honors the memory of Gordon Phillip  
6 Allen, Sr. and expresses the appreciation of this body for the service he rendered his  
7 community, State, and nation.

8           **SECTION 2.** The House of Representatives extends its deepest sympathy to the  
9 family of Gordon Phillip Allen, Sr. for the loss of a beloved family member.
