1 AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE
2 RECOMMENDATION OF THE SPEAKER OF THE HOUSE OF REPRESENTATIVES
3 AND THE PRESIDENT PRO TEMPORE OF THE SENATE AND TO MAKE FURTHER
4 MODIFICATIONS TO APPOINTMENTS MADE IN THE 2018 APPOINTMENTS BILL.

6 The General Assembly of North Carolina enacts:

8 **PART I. SPEAKER'S RECOMMENDATIONS**

9 **SECTION 1.1.** William R. Warner of Cumberland County is appointed to the
10 Fayetteville State University Board of Trustees for a term expiring on June 30, 2021, to fill the
11 unexpired term of Dr. John G. McNeil.

12 **SECTION 1.2.** Bruce B. Friend of Wake County is appointed to the North Carolina
13 Charter Schools Advisory Board for a term expiring on June 30, 2021, to fill the unexpired term
14 of Joseph Maimone.

15 **SECTION 1.3.(a)** Representative John Torbett of Gaston County is appointed to the
16 Virginia-North Carolina Interstate High-Speed Rail Compact for a term expiring on June 30,
