A BILL TO BE ENTITLED

1 AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE
2 RECOMMENDATION OF THE SPEAKER OF THE HOUSE OF REPRESENTATIVES,
3 PRESIDENT PRO TEMPORE OF THE SENATE, AND THE MAJORITY AND
4 MINORITY LEADERS OF THE HOUSE OF REPRESENTATIVES AND SENATE
5 AND TO MAKE TECHNICAL CHANGES.

7 Whereas, G.S. 120-121 authorizes the General Assembly to make certain
8 appointments to public offices upon the recommendation of the Speaker of the House of
9 Representatives and President Pro Tempore of the Senate; and

10 Whereas, G.S. 116-31 and G.S. 116-233, as amended by S.L. 2016-126, authorize
11 the General Assembly to make appointments to the board of trustees of each of the constituent
12 institutions of The University of North Carolina and the School of Science and Mathematics
13 upon the recommendation of the Speaker of the House of Representatives and the President Pro
14 Tempore of the Senate pursuant to G.S. 120-121; and

15 Whereas, G.S. 143B-168.12 authorizes the General Assembly to appoint members
16 of the public to the Board of Directors of the North Carolina Partnership for Children, Inc.,
17 upon the recommendation of the Majority and Minority Leaders of the House of
18 Representatives and the Senate; and

19 Whereas, the Speaker of the House of Representatives and President Pro Tempore
20 of the Senate have made recommendations; and

21 Whereas, the Majority and Minority Leaders of the House of Representatives and
22 the Senate have made recommendations; Now, therefore,
23 The General Assembly of North Carolina enacts:
