A BILL TO BE ENTITLED
AN ACT TO ESTABLISH ELECTORAL DISTRICTS FOR WAKE COUNTY DISTRICT
COURT JUDGES.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 7A-133 reads as rewritten:

"§ 7A-133. Numbers of judges by districts; numbers of magistrates and additional seats of court, by counties.

(a) Each district court district shall have the numbers of judges as set forth in the following table:

2 94-171 for the 1990 Census in the IVTD Version of the TIGER files.

4 **SECTION 2.** This act becomes effective January 1, 2019, and elections in 2018
5 and thereafter shall be held in accordance with G.S. 7A-133, as amended by Section 1 of this
6 act, as terms expire.
