A BILL TO BE ENTITLED

AN ACT TO PROVIDE ADDITIONAL AND REVISED USES FOR FEDERAL  
CORONAVIRUS RELIEF FUNDS, TO PROVIDE FUNDING FOR DISASTER  
RECOVERY, AND TO MAKE OTHER REVISIONS OF LAW.

The General Assembly of North Carolina enacts:

**PART I. TRANSFER, APPROPRIATION, AND USE OF REMAINING CORONAVIRUS  
RELIEF FUNDS**

**TRANSFER AND APPROPRIATION OF CORONAVIRUS RELIEF FUNDS**

**SECTION 1.1.(a)** Section 3.1 of S.L. 2020-4, as amended by Section 1 of S.L.  
2020-32 and Section 1.1(b) of S.L. 2020-80, reads as rewritten:

**"SECTION 3.1.** Transfer of Funds from Reserves to Relief Fund. – The State Controller  
shall transfer the sum of ~~one two billion seven three hundred ninety five sixty three million nine~~  
~~three hundred eighty eight ninety thousand twenty nine six hundred forty six~~ dollars  
(~~\$1,795,988,029~~)(~~\$2,363,390,646~~) for the 2019-2020 fiscal year from the Reserve established  
in Section 2.1 of this act, and the sum of three hundred million dollars (\$300,000,000) for the  
2019-2020 fiscal year from the Local Government Coronavirus Relief Reserve established in  
Section 2.3 of this act, to the Fund established in Section 2.2 of this act. All interest earned on  
funds held in the Reserve shall be transferred to the Coronavirus Relief Fund."

**SECTION 1.1.(b)** Section 3.2 of S.L. 2020-4, as amended by Section 2 of S.L.  
2020-32 and Section 1.1(c) of S.L. 2020-80, reads as rewritten:

**"SECTION 3.2.** Appropriation of Funds from Relief Fund to OSBM. – There is appropriated  
from the Fund to OSBM the sum of two billion ~~ninety five six hundred sixty three million nine~~  
~~three hundred eighty eight ninety thousand twenty nine six hundred forty six~~ dollars  
(~~\$2,095,988,029~~)(~~\$2,663,390,646~~) in nonrecurring funds for the 2019-2020 fiscal year to be  
allocated and used as provided in Section 3.3 of this act. The funds appropriated in this section  
shall not revert at the end of the 2019-2020 fiscal year ~~but year~~. Notwithstanding any provision  
of law to the contrary in this act or any other act appropriating funds from the Fund, funds  
appropriated from the Fund shall (i) remain available to expend until December 30, 2020, the  
deadline established by applicable federal law or guidance and (ii) be returned in accordance with  
that applicable federal law or guidance if unexpended by that deadline."

**SECTION 1.1.(c)** Section 2.3 of S.L. 2020-4, as amended by Section 1.1(a) of S.L.  
2020-80, reads as rewritten:



1 "SECTION 2.3. The State Controller shall establish a Local Government Coronavirus Relief  
2 Reserve (Local Reserve) in the General Fund to maintain certain federal funds transferred from  
3 the Reserve established in Section 2.1 of this act that are eligible to mitigate the impact of the  
4 COVID-19 outbreak in North Carolina on the revenue of local governments. The State Controller  
5 shall transfer the sum of three hundred million dollars (\$300,000,000) from the Reserve to the  
6 Local Reserve. Funds that are reserved in the Local Reserve do not constitute an "appropriation  
7 made by law," as that phrase is used in Section 7(1) of Article V of the North Carolina  
8 Constitution. All interest earned on funds held in the Local Reserve shall be transferred to the  
9 Coronavirus Relief Fund."

#### 10 11 USE OF CORONAVIRUS RELIEF FUNDS

12 SECTION 1.2. Section 3.3 of S.L. 2020-4, as amended by Section 3 of S.L. 2020-32,  
13 Section 4 of S.L. 2020-49, Section 1.1(d) of S.L. 2020-80, Section 3B(b) of S.L. 2020-88, and  
14 Section 4.9(a) of S.L. 2020-91, reads as rewritten:

15 "SECTION 3.3. Allocations of Funds. – OSBM shall allocate the funds appropriated in  
16 Section 3.2 of this act as follows:

- 18 (3) ~~\$370,000,000~~ \$237,500,000 to OSBM to be used for the continuity of  
19 operation needs across State government. As referenced in Section 2.2 of this  
20 act, expenditures incurred during the period that begins on March 1, 2020, and  
21 ends on December 30, 2020, are eligible for funding under this subdivision.  
22 Expenditures eligible under this subdivision may include, but are not limited  
23 to, covering overtime costs at mental health institutions, prisons, community  
24 corrections, juvenile facilities, and veterans homes; covering costs of pay  
25 provided to employees of the Division of Adult Correction and Juvenile  
26 Justice at the Department of Public Safety in accordance with The  
27 Communicable Disease Emergency Policy established by the Office of State  
28 Human Resources; covering costs of in-home monitoring for all nonviolent  
29 juvenile offenders and nonviolent, elderly, health-compromised, and  
30 near-release adult offenders; covering costs of personal protective equipment,  
31 COVID-19 testing, and hygienic supplies for the Division of Adult Correction  
32 and Juvenile Justice at the Department of Public Safety; rent and utility  
33 assistance; purchasing critical information technology equipment and  
34 software licenses; enhancing telepresence services in public safety facilities  
35 and the court system; and purchasing emergency sanitation and hygienic  
36 supplies. Provided that the United States Department of Labor does not  
37 approve additional funding for the Customer Call Center operated by the  
38 Division of Employment Security, funds may also be used to hire additional  
39 time-limited staff in the Customer Call Center to meet the unprecedented  
40 demand for services. Up to two million dollars (\$2,000,000) of the funds  
41 allocated in this subdivision may be used to establish a temporary North  
42 Carolina Pandemic Recovery Office in accordance with Section 4.3 of this  
43 act. Up to five hundred thousand dollars (\$500,000) of the funds allocated in  
44 this subdivision may be further allocated to the Office of the State Auditor to  
45 perform the requirements set forth in Section 1.8 of this act. OSBM shall  
46 provide a report to the Joint Legislative Commission on Governmental  
47 Operations no later than August 15, 2020, detailing the allocation of funds  
48 under this subdivision. The report shall include which State agencies received  
49 allocations, the amounts disbursed, the amount spent in the 2019-2020 fiscal  
50 year, and for what purposes the funds were used by fund code and line-item  
51 detail.

- 44          (21)     ~~\$20,000,000~~\$25,000,000 to the Board of Governors of The University of  
45          North Carolina to be allocated to the State Education Assistance Authority  
46          (Authority) for the Authority to provide funds to each eligible private  
47          postsecondary institution, as defined in G.S. 116-280(3), by apportioning an  
48          amount equal to the following:
- 49               a.     Seventy-five percent (75%) of the institution's relative share of  
50                     full-time equivalent students who were enrolled as of March 13, 2020,  
51                     who received scholarships pursuant to Article 34 of Chapter 116 of the

- 10 (22) ~~\$15,000,000~~ \$17,000,000 to OSBM to allocate to the Duke University Human  
 11 Vaccine Institute (DHVI) of the Duke University School of Medicine to  
 12 develop (i) a safe and effective COVID-19 vaccine that will be available to  
 13 the public as soon as possible ~~possible~~ and (ii) rapid, low-cost COVID-19  
 14 testing for active infections.
- 15 ...
- 16 (28) ~~\$6,000,000~~ \$12,000,000 to the Department of Health and Human Services to  
 17 allocate equally among each of the six food banks in this State. The food banks  
 18 are encouraged to use the funds allocated in this subdivision to purchase food  
 19 from North Carolina-based farmers and vendors.
- 20 ...
- 21 (30a) \$20,000,000 to the Department of Health and Human Services, Division of  
 22 Social Services (DSS), for facilities licensed to accept State-County Special  
 23 Assistance. These funds shall be used to provide temporary financial  
 24 assistance in the form of a monthly payment to these facilities to offset the  
 25 increased costs of serving residents who are recipients of State-County Special  
 26 Assistance during the COVID-19 emergency. For the period commencing  
 27 August 1, 2020, and ending December 30, 2020, the amount of the monthly  
 28 payment authorized by this subdivision shall be equal to two hundred fifty  
 29 dollars (\$250.00) per month for each resident of the facility as of the first day  
 30 of the month who is a recipient of State-County Special Assistance. The DSS  
 31 shall terminate all monthly payments pursuant to this subdivision on the  
 32 earlier of December 30, 2020, or when the funds allocated under this  
 33 subdivision are depleted. Nothing in this subdivision shall be construed as an  
 34 obligation by the General Assembly to appropriate funds for the purpose of  
 35 this subdivision or as an entitlement by any facility, resident of a facility, or  
 36 other person to receive financial assistance under this subdivision. The  
 37 following definitions apply in this subdivision:
- 38 a. Facility licensed to accept State-County Special Assistance payments.  
 39 – Any residential care facility that is (i) licensed by the Department of  
 40 Health and Human Services and (ii) authorized to accept State-County  
 41 Special Assistance payments from its residents.
- 42 b. State-County Special Assistance. – The program authorized by  
 43 G.S. 108A-40.
- 44 ...
- 45 (32) ~~\$7,425,000~~ \$12,425,000 to OSBM to allocate to ~~the~~ North Carolina  
 46 Association of Free and Charitable Clinics (NCAFCC), a nonprofit  
 47 organization, to be used for distribution to its member clinics to cover the cost  
 48 of eligible health services provided during the COVID-19 emergency and  
 49 other costs allowed pursuant to federal guidance. By August 1, 2020, and by  
 50 November 1, 2020, NCAFCC shall report to the Joint Legislative Oversight  
 51 Committee on Health and Human Services and the Fiscal Research Division

- 1 on a plan for allocating the funds received under this ~~section, subdivision~~ and  
 2 by February 1, 2021, on the use of these funds by recipients.
- 3 (33) ~~\$1,500,000 \$6,500,000~~ to the Department of Health and Human Services to  
 4 provide a grant to NC MedAssist, a nonprofit corporation, to offset increased  
 5 costs for providing prescription assistance services during the COVID-19  
 6 pandemic to individuals who are indigent or uninsured.
- 7 (34) ~~\$7,425,000 \$12,425,000~~ to OSBM to allocate to ~~the~~ North Carolina  
 8 Community Health Center Association (NCCHCA), a nonprofit organization,  
 9 to be used ~~for~~ as follows:
- 10 a. \$600,000 for equal distribution to the following North Carolina  
 11 federally qualified health center look-alikes, to cover the cost of  
 12 eligible health services provided during the COVID-19 emergency and  
 13 other costs allowed pursuant to federal guidance:
- 14 1. Black River Health Services, Inc., a nonprofit corporation.
  - 15 2. Hot Springs Health Program, a nonprofit corporation.
  - 16 3. NeighborHealth Center, Inc., a nonprofit corporation.
- 17 b. The remainder for distribution to its member health centers to cover

- 26 (35a) \$34,002,617 in nonrecurring funds to OSBM to be allocated for COVID-19  
 27 testing, as provided in sub-subdivisions a. and b. of this subdivision.
- 28 a. \$29,002,617 to be distributed in equal amounts to the nonprofit  
 29 organizations known as NC Senior Living Association (NCSLA), NC  
 30 Health Care Facilities Association (NHCFA), and NC Assisted  
 31 Living Association (NCALA) to purchase COVID-19 tests that, at a  
 32 minimum, have been approved for emergency use by the United States  
 33 Food and Drug Administration. NCSLA, NHCFA, and NCALA  
 34 shall use at least fifty percent (50%) of their allocated funds to  
 35 purchase rapid COVID-19 tests for distribution to their member  
 36 facilities. NCSLA, NHCFA, and NCALA shall distribute all tests  
 37 funded by this allocation equally among their member facilities, free

 40 under this subdivision for testing visitors who are family members or  
 41 legal guardians of residents.

 43 Carolina (UNC), to be used to effectively mitigate the spread of  
 44 COVID-19 on UNC campuses through testing, tracing, enforcing  
 45 required on-campus isolation and quarantine, and providing  
 46 COVID-19 related health care services.

- 48 (37) ~~\$19,000,000 \$20,000,000~~ to the Department of Health and Human Services  
 49 to provide funding for food banks, support for residential settings that are  
 50 incurring additional costs to mitigate spread or isolate positive cases (Special  
 51 Assistance), adult and child protective services response, support for homeless

- 1 and domestic violence shelters and housing security (prevention, diversion,  
2 and rapid re-housing), child care response, costs to expand NCCARE360, a  
3 Statewide coordinated care network that will connect individuals impacted by  
4 COVID-19 to local services such as food, housing, child care and other  
5 resources, and technology modifications to support COVID-19 emergency  
6 relief to beneficiaries. From funds received pursuant to this subdivision, the  
7 sum of ~~\$2,500,000~~ \$3,500,000 is allocated to Reinvestment Partners, a  
8 nonprofit organization, for its Produce Prescription Program, which provides  
9 a monthly forty dollar (\$40.00) per household benefit for each eligible Food  
10 and Nutrition Services recipient enrolled by the recipient's health care  
11 provider, to serve individuals impacted by the COVID-19 emergency.  
12 Individuals receiving assistance pursuant to this subdivision are limited to  
13 three months of food assistance.

- 15 (42) ~~\$3,550,000~~ \$4,350,000 to the Department of Health and Human Services,  
16 Division of Social Services, to assist in serving children in foster care during  
17 the COVID-19 emergency. These funds shall be used for monthly  
18 supplemental payments in the amount of one hundred dollars (\$100.00) for  
19 each child receiving foster care assistance payments beginning with the month  
20 of April 2020 and continuing until funds are exhausted.

- 22 (45) ~~\$125,000,000~~ \$75,000,000 to OSBM for Golden LEAF to provide loans in  
23 accordance with Section 4.2 of this act.
- 24 (46) \$9,000,000 to the Department of Information Technology to use for the  
25 Growing Rural Economies with Access to Technology Fund to provide  
26 supplementary project funding to enable funding for all qualifying GREAT  
27 program applications. GREAT program grant applications received on or  
28 before April 1, 2020, that meet the criteria established pursuant to  
29 G.S. 143B-1373 shall be eligible to receive the supplementary funding in  
30 accordance with this subdivision. Applications that may have been eliminated  
31 as a result of the scoring process or that may have contained proposed project  
32 areas that overlap with other applications may submit a revision to an existing  
33 application to the Department to qualify for funding under this subdivision.  
34 An applicant awarded a grant shall, upon finalizing the agreement, receive an  
35 initial lump sum grant fund disbursement equal to the total grant award  
36 amount minus amounts assessed to the grant recipient for the matching  
37 requirement in G.S. 143B-1373(j). A grant recipient receiving the initial lump  
38 sum disbursement must provide evidence satisfactory to the Department that  
39 the recipient is financially solvent and has been providing broadband service  
40 in this State for at least two years and an attestation that the project will be  
41 completed pursuant to the agreement. Funds allocated under this subsection  
42 that remain unawarded on or after September 1, 2020, may be awarded for  
43 GREAT program grants that may be awarded by the Department in a special  
44 supplementary grant process occurring after October 1, 2020.
- 45 (47) ~~\$10,000,000~~ \$20,250,000 to the Department of Agriculture and Consumer  
46 Services to be used to provide support for meat processing facilities and for  
47 seafood processing facilities in accordance with Section 4.2A of this act.

- 49 (51) ~~\$15,000,000~~ \$60,500,000 to the Department of Commerce for grants awarded  
50 by the Economic Investment Committee pursuant to Section 4.2B of this act.

- 1 (63) ~~\$7,000,000-\$27,000,000~~ to the Department of Public Instruction to provide  
2 personal protective equipment for public schools, in response to the  
3 COVID-19 pandemic, to facilitate in-person instruction for the 2020-2021  
4 school year. Personal protective equipment provided pursuant to this  
5 subdivision shall meet applicable federal standards and guidelines from the  
6 Centers for Disease Control and Prevention. Funds allocated pursuant to this  
7 subdivision may also be used to provide COVID-19 testing for public schools.
- 8 (64) ~~\$5,000,000-\$22,000,000~~ to the Department of Public Instruction to hold in  
9 reserve and to award as grants, in the discretion of the Department, to public  
10 school units that apply for funds to provide access to services for exceptional  
11 children who have lost critical services as a result of school closures related  
12 to COVID-19. Of these funds, the Department is encouraged to use at least  
13 seventeen million dollars (\$17,000,000) for in-person services for qualifying  
14 children.

- 16 (70) \$4,300,000 to OSBM to be allocated to the Children's Advocacy Centers  
17 (CACNC) of North Carolina, Inc., a nonprofit corporation, ~~to~~ of which at least  
18 seventy-five percent (75%) shall be distributed to child advocacy centers in  
19 this State that are in good standing with CACNC to cover the cost of increased  
20 child caseloads and the statewide provision of more effective and available  
21 virtual counseling assist with increased costs due to the COVID-19 pandemic.
- 22 ...
- 23 (72) \$440,541,000 to the Department of Revenue for grants awarded by the  
24 Department pursuant to Section 4.12 of this act.
- 25 (73) \$2,000,000 to OSBM to allocate to the Carolina Small Business Development  
26 Fund, a community development financial institution, to be used for business  
27 advisory services to and deploying capital to small businesses in North  
28 Carolina to assist those businesses with losses due to a disruption of services  
29 resulting from the COVID-19 pandemic. Funding provided in this subdivision  
30 shall be used for financial assistance, business solutions and research,  
31 technology for applications for and reporting on aid, underwriting and loan  
32 servicing, technical assistance and advisory services, consulting for technical  
33 assistance workshops, and marketing and communication regarding services.
- 34 (74) \$3,750,000 to OSBM to be allocated in the form of a grant to CAGC  
35 Foundation, Inc., a nonprofit organization, to be used in accordance with  
36 Section 4.14 of this act.
- 37 (75) \$87,000,000 to the Department of Commerce, Division of Employment  
38 Security, to be credited to the Unemployment Insurance Trust Fund and used  
39 to provide the increased benefit amount payable under G.S. 96-14.2(e). If the  
40 increased benefits paid under G.S. 96-14.2(e) exceed \$87,000,000, then there  
41 is appropriated from the General Fund to the Unemployment Insurance Trust  
42 Fund an amount equal to the amount of increased benefits paid under  
43 G.S. 96-14.2(e) less \$87,000,000. The intent of the General Assembly is to  
44 hold harmless the Unemployment Insurance Trust Fund for any increased  
45 benefits paid under G.S. 96-14(e).
- 46 (75a) \$50,000,000 to the OSBM to fulfill any outstanding State match requirement  
47 due to FEMA under the federal Lost Wage Assistance program at the close of  
48 that program. If this amount falls short of the State match required under the  
49 Lost Wages Assistance program, then OSBM is authorized to use funds  
50 allocated under Section 3.3(3) of S.L. 2020-4 to meet the remainder of the  
51 State match requirement. If any funds allocated under this subdivision are not

2                    federal Lost Wage Assistance program, then they are allocated to be used for  
3                    the continuity of operation needs across State government, in accordance with  
4                    Section 3.3(3) of S.L. 2020-4.

6                    used for emergency support of milk producers in accordance with Section 4.15  
7                    of this act.
- 8                    (77) \$750,000 to the Department of Agriculture and Consumer Services to provide  
9                    emergency aid for farmers market operators and local food enterprises. The  
10                   aid will allow those operations to adapt to new market conditions and further  
11                   support communities experiencing food insecurity. Eligible categories for  
12                   emergency aid include, but are not limited to, labor, technology or software

14       accordance with Section 4.18 of this act.  
15       (110) \$400,000 to OSBM to provide a grant to Bridge to Recovery, Inc., a nonprofit  
16       organization, to offset the costs of increased demand for substance use  
17       disorder services related to the impacts of COVID-19 and to fund the  
18       development of innovative substance use disorder programs designed to  
19       address growing substance use disorder concerns in Union County, Stanly  
20       County, and surrounding areas as a result of COVID-19.  
21       (111) \$500,000 to OSBM to provide a grant to Triangle Residential Options for  
22       Substance Abusers, Inc., a nonprofit corporation, to be used for (i) offsetting  
23       increased operational expenses incurred for providing comprehensive  
24       residential substance use disorder treatment associated with the COVID-19  
25       pandemic, for the period beginning March 1, 2020, and ending December 30,  
26       2020, and (ii) any other COVID-19 related losses or expenses incurred during  
27       that time period, as allowed under the Coronavirus Aid, Relief, and Economic  
28       Security (CARES) Act, P.L. 116-136.  
29       (112) \$1,000,000 to OSBM to be allocated to Nurse Family Partnership, a nonprofit  
30       corporation located in North Carolina, to help offset COVID-19 related  
31       expenses incurred for the following services provided and supplies used  
32       within the State between March 1, 2020, and December 30, 2020:  
33       a.       Overtime, additional staffing requirements, teaching program  
34       participants and their families preventive measures, supporting  
35       program participants and their families in coping with preventive  
36       social distancing or quarantine, and translating, as needed, educational  
37       and health interventions to a distance platform.  
38       b.       Personal protective equipment for distribution, free of charge, to  
39       program participants, their families, and the visiting nurses serving  
40       program participants.  
41       c.       Any other allowed uses under the Coronavirus Aid, Relief, and  
42       Economic Security (CARES) Act, P.L. 116-136.  
43       (114) \$750,000 to OSBM to be allocated to North Carolina Assisted Living  
44       Association (NCALA), a nonprofit organization, to facilitate safe visitation  
45       and communication between residents and family members and to maintain  
46       Centers for Disease Control and Prevention infection control guidance and  
47       safety standards. NCALA shall distribute these funds as follows:  
48       a.       \$500,000 to be distributed equally among its member facilities for the  
49       purchase of communications equipment and technology, such as smart  
50       devices for residents.



- 1                   b.       \$250,000 to be distributed equally among its member facilities for the  
2                               purchase of environmental supplies and the development of plans to  
3                               redesign visitation or common areas to address resident isolation.
- 4       (114a) \$34,000 to OSBM to provide a grant to the Iredell County Health Department,  
5                   to be used to purchase a cargo trailer, temporary fencing, and a canopy to  
6                   support a mobile mass-testing site for COVID-19.
- 7       (114b) \$25,000,000 to OSBM to allocate to the North Carolina Medical Society  
8                   Foundation to ensure access to medical care for the citizens of this State by  
9                   distributing these funds to independent medical practices in this State with  
10                   demonstrable financial needs related to COVID-19.
- 11       (114c) \$10,000 to OSBM to be allocated to Watauga County to be used to purchase  
12                   a portable broadband kit for the local health department to facilitate the  
13                   real-time transmission of testing data from COVID-19 mobile testing sites  
14                   located in rural areas served by the local health department. These funds shall  
15                   not be used for either of the following:
- 16                   a.       Any purpose other than to purchase the equipment described in this  
17                               subdivision.
- 18                   b.       To purchase subscription services.
- 19       (114d) \$6,000,000 to be allocated to the Department of Health and Human Services  
20                   to purchase personal protective equipment and sanitizing supplies for  
21                   prevention efforts to combat COVID-19 in child care settings regulated by the  
22                   State.
- 23       (114e) \$23,000,000 to OSBM to be allocated in equal amounts to the nonprofit  
24                   organizations known as North Carolina Senior Living Association (NCSLA),  
25                   North Carolina Health Care Facilities Association (NCHCFA), and North  
26                   Carolina Assisted Living Association (NCALA). NCSLA, NCHCFA, and  
27                   NCALA shall use these funds to purchase and distribute, free of charge, to  
28                   their member facilities (i) COVID-19 related supplies and equipment  
29                   necessary for life safety, health, and sanitation, such as ventilators, touch-free  
30                   thermometers, gowns, disinfectant, and sanitizing wipes, and (ii) personal  
31                   protective equipment, such as surgical and respiratory masks and gloves, that  
32                   meets Centers for Disease Control and Prevention standards and guidelines.  
33                   By February 1, 2021, NCSLA, NCHCFA, and NCALA shall each submit a  
34                   report on their use of these allocated funds to the Joint Legislative Oversight  
35                   Committee on Health and Human Services and the Fiscal Research Division.
- 36       (114f) \$38,000,000 to the Department of Health and Human Services, Division of  
37                   Mental Health, Developmental Disabilities, and Substance Abuse Services  
38                   (DMH/DD/SAS), to be distributed to local management entities/managed care  
39                   organizations (LME/MCOs) as additional lump sum single-stream  
40                   allocations. LME/MCOs shall not use these funds for any purpose other than  
41                   to provide eligible individuals direct services associated with the COVID-19  
42                   pandemic. The DMH/DD/SAS shall distribute these funds among the  
43                   LME/MCOs as follows:
- 44                   a.       \$5,899,330 to Alliance Behavioral Healthcare.
- 45                   b.       \$9,166,016 to Cardinal Innovations Healthcare.
- 46                   c.       \$4,027,152 to Eastpointe.
- 47                   d.       \$4,375,407 to Partners Behavioral Health Management.
- 48                   e.       \$4,631,095 to Sandhills Center.
- 49                   f.       \$5,292,267 to Trillium Health Resources.
- 50                   g.       \$4,608,733 to Vaya Health.

1           (115) \$30,000,000 to the Department of Information Technology to use for the  
2           Growing Rural Economies with Access to Technology Fund to provide  
3           funding for a special supplementary GREAT Act grant process in accordance  
4           with Section 4.17 of this act."

5           **SECTION 1.3.** S.L. 2020-4 is amended by adding the following new sections to  
6 read:

7 **"EXTRA CREDIT GRANT PROGRAM**

8           **"SECTION 4.12.(a)** Purpose, Use, Appropriation. – The purpose of this section is to use  
9 funds from the Coronavirus Relief Fund to help families with qualifying children in North  
10 Carolina by providing economic support to assist with virtual schooling and child-care costs  
11 during the COVID-19 pandemic. The Department of Revenue may use up to \$5,000,000 of the  
12 funds allocated in subdivision (72) of Section 3.3 of this act for the administration of the grant  
13 program and shall use the remainder of the funds to provide grants under this program. If the  
14 amount of grants awarded under this program exceeds the amount of funds allocated under this  
15 act for this program, then there is appropriated from the General Fund for the 2020-2021 fiscal  
16 year to the Department of Revenue an amount equal to the amount of grants awarded under this  
17 program less the amount of funds allocated under this section from the Coronavirus Relief Fund  
18 for this program.

19           **"SECTION 4.12.(b)** Extra Credit Grant Program. – There is created the Extra Credit Grant  
20 Program to be administered by the Department of Revenue. The Department must provide a  
21 one-time grant to an individual that meets the conditions of this section.

22           The Department must include with each grant award an explanatory insert provided by the  
23 State Controller. The insert must specify that the grant award is intended to assist with the  
24 additional virtual schooling or child care expenses incurred due to COVID-19. The insert cannot  
25 include the name of an elected official.

26           **"SECTION 4.12.(c)** Grant Award. – The grant amount is three hundred thirty-five dollars  
27 (\$335.00) per eligible individual. For purposes of this section, spouses who filed a joint 2019  
28 State income tax return are considered one eligible individual. The Department of Revenue must  
29 award the grants as soon as practicable, but no later than December 15, 2020. If an individual  
30 meets all the requirements of this section for a grant award, but the return is not processed by the  
31 Department on or before December 15, 2020, then the Department may issue a grant award to  
32 the individual upon the processing of the return but in no event may an award be issued on or  
33 after January 1, 2021. The Department cannot disclose information regarding individual grants  
34 awarded under this program except as allowed for tax information in G.S. 105-259(b)(1)-(55).  
35 The Department may report on the aggregate grant awards provided under this program.

36           A grant may be issued by direct deposit if the individual received a 2019 State tax refund by  
37 direct deposit. In such circumstances, the direct deposit should be to the account to which the  
38 individual's 2019 State tax refund was deposited. If the Department becomes aware that such  
39 account is no longer associated with the individual or that the owner of the account has not  
40 remitted the grant to the individual entitled to the grant, then the Department may demand that  
41 the recipient of the deposit return the grant. In such circumstances, the Department may also  
42 reissue the grant to the individual by virtue of a check mailed to the address on the individual's  
43 2019 State income tax return. Grants issued by checks will be mailed to the address on the  
44 individual's 2019 State income tax return unless an updated address is available or the address  
45 on the individual's application. Checks issued by the Department under this subsection are valid  
46 for 90 days.

47           **"SECTION 4.12.(d)** Eligibility. – The Department of Revenue must award a grant to the  
48 following individuals:

- 49           (1) Automatic grant award. – An individual who filed a 2019 State income tax  
50 return on or before October 15, 2020, as provided under G.S. 105-263 and  
51 meets both of the following conditions:

- 1 a. The taxpayer reported on Form D-400 that either the taxpayer or, if  
2 filing a joint return, the taxpayer's spouse, was a resident of the State  
3 for the entire 2019 calendar year.
- 4 b. The taxpayer reported at least one qualifying child on line 10a of Form  
5 D-400.
- 6 (2) Application for grant award. – An individual who applied for a grant under  
7 this program on a form prescribed by the Secretary of Revenue postmarked  
8 on or before October 15, 2020, and meets all the following conditions:
- 9 a. The applicant did not file a 2019 State income tax return solely  
10 because the applicant's gross income for the 2019 taxable year did not  
11 exceed the State filing requirements for the taxpayer's filing status.
- 12 b. The applicant provides a name, mailing address, and any other  
13 information required by the Secretary.
- 14 c. The applicant reports that the applicant was a resident of the State for  
15 the entire 2019 calendar year.
- 16 d. The applicant reports the applicant had at least one child that met the  
17 conditions of a qualifying child, as that term is defined in Section 24  
18 of the Internal Revenue Code, for the 2019 calendar year. The  
19 applicant must include the name, age, and social security number of  
20 the qualifying child. A child can only be claimed as a qualifying child  
21 by one applicant.  
22

### 23 **"TEMPORARY FLEXIBILITY FOR TRANSPORTATION ALLOTMENT**

24 **"SECTION 4.13.** For the 2020-2021 school year, local school administrative units may use  
25 funds provided from the transportation allotment for the following additional purposes related to  
26 the COVID-19 pandemic:

- 27 (1) School nutrition.
- 28 (2) School- and community-based child care.
- 29 (3) Sanitizing schools and buses.
- 30 (4) In order to facilitate in-person instruction, personal protective equipment that  
31 meets applicable federal standards and guidelines from the Centers for  
32 Disease Control and Prevention.
- 33 (5) Remote instruction.  
34

### 35 **"CONSTRUCTION PPE & EDUCATION**

36 **"SECTION 4.14.(a)** The General Assembly finds that the coronavirus pandemic requires  
37 enactments that promote the general welfare, serve the public interest, and further the public  
38 purpose of helping to better protect our citizens from the coronavirus.

39 **"SECTION 4.14.(b)** The funds allocated in subdivision (74) of Section 3.3 of this act to the  
40 Office of State Budget and Management (OSBM) shall be used to provide grants to CAGC  
41 Foundation, Inc., (Foundation), a nonprofit organization, as follows:

- 42 (1a) The sum of \$3,000,000 in the form of a grant to the Foundation to be used to  
43 make subgrants to entities listed in subdivision (2) of this subsection and as  
44 authorized under the federal CARES Act and U.S. Treasury Department  
45 Guidance for coronavirus pandemic mitigation in the construction workplace.  
46 Mitigation efforts shall relate to health and safety measures that may include,  
47 but are not limited to, providing medical staffing and equipment needed to  
48 screen and protect individuals in the workplace, the purchase of personal  
49 protective equipment for individual worker use while on a jobsite, rapid  
50 response testing kits, implementing computer or smartphone applications that  
51 enable workers to answer daily screening questions before reporting to the

- 1 jobsite, purchase of jobsite sanitization equipment for use in disinfecting  
2 jobsites, mental health support, and other pandemic-related safety gear for  
3 construction workers. The Foundation shall determine a formula and protocols  
4 for making grants that is subject to the approval of OSBM.
- 5 (1b) The sum of \$750,000 in the form of a grant to the Foundation to be used to  
6 make subgrants to entities listed in subdivision (2) of this subsection for (i)  
7 multilingual education, training, and community outreach programs with  
8 accompanying educational materials using various media to reach  
9 construction workers, including those who lack proficiency in the English  
10 language and (ii) online and in-person construction industry job safety events  
11 related to coronavirus pandemic mitigation measures. The Foundation shall  
12 determine a formula and protocols for making grants that is subject to the  
13 approval of OSBM.
- 14 (2) The following entities are eligible to apply for grants to implement the  
15 activities authorized in this section:
- 16 a. Nonprofit organizations, including, but not limited to, trade  
17 organizations and affinity groups and churches for nonsectarian  
18 educational purposes.
- 19 b. Businesses with a physical presence in the State that did not receive  
20 other forms of federal or State coronavirus-related aid, with outreach  
21 to rural, minority-owned, and women-owned small businesses.
- 22 c. Media organizations that will produce public service materials in  
23 English and other languages related to the health, safety, and welfare  
24 of construction industry workers during the coronavirus pandemic.
- 25 d. Other entities determined eligible by OSBM to carry out the purposes  
26 of the grants in accordance with federal CARES Act requirements.  
27 This may include established grant-making organizations capable of  
28 administering Fund grants in the manner required by law.
- 29 (3) With strict guidelines to achieve adherence to the requirements of the federal  
30 CARES Act and U.S. Treasury Department guidance.
- 31 (4) In collaboration with the Department of Labor and the Department of Health  
32 and Human Services, as necessary for the full implementation of this act.
- 33 (5) All contractual and interagency agreements necessary to implement this  
34 section shall be executed within 30 days of this section becoming law.  
35

### 36 **"EMERGENCY GRANTS FOR MILK PRODUCERS**

37 **"SECTION 4.15.(a)** Findings. – The General Assembly finds that the COVID-19  
38 emergency has resulted in serious and substantial impacts on the food supply chain, including  
39 the State's dairy industry. Dairy producers and processors in the State lost more than half of their  
40 market with COVID-19 related shutdowns of the school systems and food service industries.  
41 This resulted in milk being dumped and a devastating decrease in milk pay prices, which were  
42 already at a historical low. The additional bottlenecks caused by shutdowns in the meat  
43 processing plants and lack of facilities to process dairy animals for beef left producers with no  
44 income options from the sale of cows culled from their herds. The General Assembly further  
45 finds that financial assistance to these producers is necessary in order to reduce disruptions in the  
46 supply chain for fresh dairy products and to help dairy producers in the State stay in business.

47 **"SECTION 4.15.(b)** Allocation of Funds. – The funds allocated in this act to the Department  
48 of Agriculture and Consumer Services for emergency support of milk producers shall be  
49 allocated by the Department to the North Carolina Dairy Stabilization and Growth Fund to  
50 provide grants as specified in subsection (c) of this section to compensate eligible dairy producers  
51 for losses incurred as a result of the collapse in dairy prices due to the COVID-19 pandemic or

1 to improve the resiliency and adaptability of the dairy supply chain to future pandemics. These  
2 funds may only be used for purposes consistent with the Coronavirus Relief Fund Guidance for  
3 State, Territorial, Local, and Tribal Governments provided by the United States Department of  
4 the Treasury or with any subsequent act of Congress.

5 **"SECTION 4.15.(c)** Grant Procedures. – The Department shall develop policies and  
6 procedures for the disbursement of grants that include, at a minimum, the following:

- 7 (1) Notwithstanding any provision of Article 68A of Chapter 106 of the General  
8 Statutes to the contrary, the Department shall make a monthly grant payment  
9 from the Dairy Stabilization and Growth Fund to each eligible dairy producer  
10 for any month in which the baseline price exceeds the announced price. The  
11 amount of the payment shall be the difference between the baseline price and  
12 the announced price, times the hundredweight of milk produced by the  
13 producer for each month beginning with April 2020 and continuing until the  
14 earlier of the month in which the funds appropriated by this act have been  
15 expended or December 30, 2020. Payments for months ending prior to the  
16 effective date of this act shall be included with the first monthly payment to  
17 each eligible dairy producer.
- 18 (2) The maximum grant amount provided to any producer in any month shall be  
19 twenty-five thousand dollars (\$25,000).
- 20 (3) If the funds appropriated by this act are insufficient to make a full payment to  
21 each producer in any month, the Department may either award a partial grant  
22 to each eligible producer calculated based on the ratio of available funds to  
23 needed funds or may supplement the appropriated funds with other funds  
24 available to the Department in order to award the full grant amount or a  
25 uniformly increased grant to each eligible producer.
- 26 (4) The Department may use up to one percent (1%) of the funds allocated by  
27 subdivision (76) of Section 3.3 of this act for administrative expenses related  
28 to administration of the grants authorized by this act.

29 **"SECTION 4.15.(d)** Definitions. – The following definitions apply in this act:

- 30 (1) Announced price. – The monthly Class I Milk Price for the Appalachian Milk  
31 Marketing Order area reported by the Agricultural Marketing Service of the  
32 United States Department of Agriculture.
- 33 (2) Baseline price. – Twenty dollars and thirty-eight cents (\$20.38), the average  
34 monthly Class I Milk Price for the Appalachian Milk Marketing Order area  
35 for 2019 reported by the Agricultural Marketing Service of the United States  
36 Department of Agriculture.
- 37 (3) Eligible producer. – A Grade A milk producer who can demonstrate to the  
38 satisfaction of the Department that the producer is complying with federal  
39 Grade A milk regulations.

40 **"SECTION 4.15.(e)** Report Requirements. – The Department of Agriculture and Consumer  
41 Services shall report to the Joint Legislative Oversight Committee on Agriculture and Natural  
42 and Economic Resources and the Fiscal Research Division by November 1, 2020, on its  
43 distribution of the funds appropriated by this act and by February 1, 2021, on the use of funds by  
44 recipients.

45 **"SECTION 4.15.(f)** Study. – Up to \$50,000 of the funds allocated by this section may be  
46 used by the Department to study issues arising from the COVID-19 pandemic with transportation  
47 and product diversification within the North Carolina dairy industry. The Department shall report  
48 its findings and any recommendations for legislative action to the Joint Legislative Oversight  
49 Committee on Agriculture and Natural and Economic Resources and the Fiscal Research  
50 Division no later than April 1, 2022. Nothing in this subsection shall be construed as allowing  
51 the expenditure of funds from the Coronavirus Relief Fund past December 30, 2020.

1  
2 **"SMART SCHOOL BUS SAFETY PILOT PROGRAM**

3 **"SECTION 4.16.(a)** Pilot Program; Purpose. – The Department of Public Instruction shall  
4 establish the Smart School Bus Safety Pilot Program (Program), beginning no later than  
5 November 23, 2020, and ending on or before January 1, 2024. The purpose of the Program is to  
6 transform and improve the transportation of public school students through technology in  
7 response to the COVID-19 pandemic. Nothing in this subsection shall be construed as allowing  
8 the expenditure of funds from the Coronavirus Relief Fund past December 30, 2020.

9 **"SECTION 4.16.(b)** Participation. – As part of the Program, participating local school  
10 administrative units shall identify and contract with qualifying vendors to provide technology  
11 and services for school buses in accordance with this section. The following local school  
12 administrative unit is authorized to participate in the Program, subject to the requirements of this  
13 section: Mount Airy City Schools. Any local board of education of a local school administrative  
14 unit authorized to participate in the Program may elect not to participate. For each local school  
15 administrative unit that elects not to participate in the Program, the Department may authorize  
16 one replacement local school administrative unit to participate in the Program.

17 **"SECTION 4.16.(c)** Technology and Services. – Qualifying vendors shall provide  
18 technology and services for school buses to participating local school administrative units.  
19 Participating units shall have discretion over the specific technology and services provided as  
20 long as the technology and services meet the following minimum requirements:

- 21 (1) Improve overall communications and reporting on school buses.
- 22 (2) Include automated school bus safety cameras, as defined in G.S. 115C-242.1,  
23 and on-board integration with those cameras.
- 24 (3) Enable employee time tracking, student ridership tracking, and contact tracing  
25 in the event of a COVID-19 infection.
- 26 (4) Enable global positioning system (GPS) tracking of school buses.
- 27 (5) Enable turn-by-turn navigation along bus routes.
- 28 (6) Optimize time, expenditure, and safety of bus routes.
- 29 (7) Provide pre- and post-trip vehicle inspections that may be transmitted to the  
30 Department of Public Instruction on a regular basis.
- 31 (8) Communicate ridership information to the student information management  
32 system.
- 33 (9) Permit parents or legal guardians to access applicable information.
- 34 (10) Conform to applicable guidance provided by the North Carolina Department  
35 of Health and Human Services for the transportation of students during the  
36 COVID-19 pandemic.
- 37 (11) Include implementation and project management assistance, training,  
38 radio-frequency identification technology, and check-in and check-out  
39 security stickers or other badges for students.

40 **"SECTION 4.16.(d)** Requirements and Contingencies. – The following requirements and  
41 contingencies shall apply to each participating local school administrative unit:

- 42 (1) Every school bus in a participating local school administrative unit designed  
43 for the transportation of children with disabilities shall be outfitted with  
44 technology provided pursuant to the Program as long as the technology is  
45 appropriate for children with disabilities and can be provided in a  
46 cost-effective manner.
- 47 (2) At the conclusion of the Program, all hardware provided to a participating  
48 local school administrative unit shall become the property of the unit.

49 **"SECTION 4.16.(e)** Reports. – No later than November 1 and March 1 of each year the  
50 Program is in effect, the Department of Public Instruction, in consultation with each participating  
51 local school administrative unit, shall report at least all the following information to the Joint

1 Legislative Education Oversight Committee, any committee constituted by the House of  
2 Representatives or Senate to address school safety, and the Fiscal Research Division:

- 3 (1) An itemized breakdown of software infrastructure, hardware infrastructure,  
4 and equipment provided by qualifying vendors to participating local school  
5 administrative units pursuant to the Program.
- 6 (2) A description of all services provided by qualifying vendors to participating  
7 local school administrative units pursuant to the Program.
- 8 (3) A list of qualifying vendors contracting with participating local school  
9 administrative units pursuant to the Program.
- 10 (4) The impact and effectiveness of the Program.
- 11 (5) All expenditures of State funds pursuant to the Program.

### 12 **"SPECIAL SUPPLEMENTARY GREAT ACT GRANT PROCESS**

13 **"SECTION 4.17.(a)** From the funds appropriated in Section 3.3(115) of this act, the  
14 Department of Information Technology shall provide a special supplementary grant process to  
15 accelerate the provision of broadband access through the Growing Rural Economies with Access  
16 to Technology grant program. Grants may be awarded with funds appropriated in this act for  
17 applications submitted on or before October 23, 2020. The Department shall post applications no  
18 later than October 28, 2020, and shall begin issuing awards no later than November 9, 2020. The  
19 Department shall award all grants pursuant to this act on or before December 30, 2020. Except  
20 as otherwise provided in this Part, notwithstanding any provision of G.S. 143B-1373 to the  
21 contrary, the Department may establish a final schedule and process for the special  
22 supplementary grant process.

23  
24 **"SECTION 4.17.(b)** Grant applications shall be submitted and grant funds shall be awarded  
25 pursuant to G.S. 143B-1373, with the exception of the following:

- 26 (1) The 30-day period for posting of applications on the Department's Web site in  
27 G.S. 143B-1373(e) is reduced to 10 calendar days. Protest submissions must  
28 be submitted within the 10-day period.
- 29 (2) The definition of "eligible economically distressed county" in  
30 G.S. 143B-1373(a)(5) shall include counties designated as development tier  
31 one and tier two areas, and rural census tracts located in development tier three  
32 areas, as defined in G.S. 143B-437.08. For the purposes of this subdivision,  
33 the term "rural census tract" has the same meaning as contained in  
34 G.S. 143B-472.127(a)(2). Counties with total employment of 500,000 or  
35 more, as of January 1, 2020, as measured pursuant to G.S. 143B-437.52(c)(3),  
36 are not eligible.
- 37 (3) An "eligible project" is as defined in G.S. 143B-1373(a)(6), except that a  
38 project is limited to those project areas where no more than an incidental  
39 number of households or businesses, not to exceed ten percent (10%) of the  
40 total households or businesses within the boundaries of the project area  
41 submitted by the applicant, may have terrestrially deployed Internet access

(7) The matching fund requirements contained in G.S. 143B-1373(j) are replaced with the following:

Up to fifty percent (50%) of matching funds paid by the grant recipient may be comprised of third-party funding including funds from other grant programs. Funds from the Universal Service Fund shall not be used for any portion of the required matching funds. Any other current or future federal funds may be used, including any future phase of the Connect America Fund, for the required matching funds within the parameters of this program.

(8) For the purposes outlined in this act, notwithstanding G.S. 143B-1373(i), the Office shall use the following guidelines in awarding and administering grants:

Applications receiving the highest score shall receive priority status for the awarding of grants pursuant to G.S. 143B-1373. The agreement shall contain a provision governing the time line and minimum requirements and thresholds for disbursement of grant funds measured by the progress of the project; provided, however, that an applicant awarded a grant shall, upon finalizing the agreement, receive an initial lump sum grant fund disbursement equal to the total grant award amount minus amounts assessed to the grant recipient for the matching requirement in G.S. 143B-1373(j). A grant recipient receiving the initial lump sum disbursement must provide evidence satisfactory to the Office that the recipient is financially solvent and has provided all required documentation to the Office for any prior GREAT grant application or award and an attestation that the matching funds required pursuant to G.S. 143B-1373(j) are available at the time the agreement is executed. At



1 project completion, the grant recipient shall certify and provide to the Office  
2 evidence consistent with Federal Communications Commission attestation  
3 that either speeds greater than those identified in the application guidelines or  
4 the proposed upstream and downstream broadband speeds identified in the  
5 application guidelines, and for which a base speed multiplier was awarded  
6 pursuant to G.S. 143B-1373(g)(6), are available throughout the project area  
7 prior to any end user connections. A single grant award shall not exceed two  
8 million eight hundred thousand dollars (\$2,800,000). No combination of grant

16 if it fails to perform, in material respect, the obligations established in the

19 the application score to the extent that the lower score would have impacted

## 29 **"ESTABLISH STUDENT HEALTH COLLABORATIVE PILOT PROGRAM**

37 as amended, the Department of Health and Human Services, Division of Social Services, shall  
38 establish a student health collaborative pilot program allowing a local education agency (LEA)  
39 to collaborate with the county department of social services to assist students with their mental  
40 and physical well-being while in a public school setting in response to the COVID-19 pandemic.  
41 The Division of Social Services, in collaboration with the State Board of Education and the  
42 Department of Public Instruction, shall select at least one LEA to participate in the pilot program  
43 upon providing the required local match to funds allocated in this act for the collaborative pilot.  
44 Nothing in this subsection shall be construed as allowing the expenditure of funds from the  
45 Coronavirus Relief Fund past December 30, 2020.

46 **"SECTION 4.18.(c)** The Division of Social Services shall submit a progress report six  
47 months after implementing the pilot program established under this section to the Joint

50 each of the following:

- 51 (1) The number of students served by age, gender, and ethnicity.

- 1 (2) The types of services or supports provided to students, including student

4 (4) The amount of funds needed to expand the program to other counties or

17 **SECTION 1.4A.** Section 4.2A of S.L. 2020-4, as amended by Section 1.1(e) of S.L.  
18 2020-80, reads as rewritten:

19 "**SECTION 4.2A.(a)** Findings. – The General Assembly finds that the COVID-19  
20 emergency has resulted in serious and substantial impacts on the food supply chain. In particular,  
21 small livestock producers in the State have found that bottlenecks and lack of capacity among  
22 the small and independent meat processors who serve small livestock producers due to  
23 COVID-19 related slowdowns and capacity reductions have had a substantial negative impact on

- c. Planning grant. – This grant is available to a nonprofit entity or institution of higher education to complete feasibility or siting studies for a new eligible meat processing facility.
- (2) Eligible facility. – For purposes of this section, an eligible meat processing facility is a ~~meat-food~~ processing facility that ~~either:~~
  - ~~a. Meets-meets~~ both of the following requirements:
    - ~~1.a.~~ The plant contracts with independent livestock producers or seafood harvesters to process animals ~~owned by the producers or seafood.~~
    - ~~2.b.~~ The United States Department of Agriculture (USDA) contracts with Department inspectors to conduct federal inspection activities authorized by the Talmadge-Aiken Act of 1962 (7 U.S.C. § 1633) at the plant, the plant is otherwise regulated by the ~~USDA, USDA or the FDA,~~ or the plant is a State-inspected ~~facility; or~~
  - ~~b. Is a catfish aquaculture operation that raises and processes catfish facility.~~
- (3) The Department may prioritize projects that will create additional jobs.
- (4) Recipients shall provide matching funds for the grant in the amount of one dollar (\$1.00) from nongrant sources for every two dollars (\$2.00) provided by the grant.

...."

**SECTION 1.5.(a)** Section 4.2B(e) and (g) of S.L. 2020-4, as enacted by Section 1.1(e) of S.L. 2020-80, reads as rewritten:

10 c. Experienced an economic loss as provided under subsection (c)(2) of  
11 this section.  
12 d. Did not participate in the programs listed under subsection (c)(3) of  
13 this section.
- 14 (3) The application for a grant under Round II of the Program must be filed with  
15 the Economic Investment Committee on or before Friday, September 25,  
16 2020. The Committee may not accept late applications. An application  
17 submitted by a business or nonprofit with 20 or fewer full-time employees  
18 under Round I of the Program that was found ineligible solely for failure to  
19 meet the job retention requirement of Section 4.2B(c)(1) will be reconsidered  
20 under Round II of the Program without further action on the part of the  
21 applicant.
- 22 (4) A business or nonprofit may only receive one grant under this Program.
- 23 **"SECTION 4.2B.(i)** The Office of Historically Underutilized Businesses, Department of  
24 Administration, is directed to inform and educate minority-owned businesses that may be eligible  
25 to apply for the grants provided by this Program as soon as practicable so they may have the  
26 opportunity to access the grants provided by it."
- 27 **SECTION 1.6.** Section 4.2 of S.L. 2020-4 reads as rewritten:
- 28 **"SECTION 4.2.(a)** Program. – Of the funds allocated in subdivision (45) of Section 3.3 of  
29 this act, Golden LEAF shall provide grants to entities for the purpose of making emergency loans

50 federal assistance programs.

2 of a triggering event and an interest rate of at least five and one-half percent  
3 (5.5%) on and after the date of a triggering event.
- 4 (5) The term of the loan shall not exceed ~~66~~120 months and shall be amortized  
5 over the term of the loan.
- 6 (6) A qualifying business shall certify in writing that it will use a loan provided  
7 under the program for employee compensation, mortgage, rent, utilities, and  
8 other operating costs and expenses incurred on behalf of a business located in  
9 this State.
- 10 (7) A loan provided under the program is limited to no more than two hundred  
11 fifty thousand dollars ~~(\$50,000)~~ ~~(\$250,000)~~ per qualifying business.
- 12 (8) Upon the occurrence of a triggering event, repayment of the loan shall  
13 commence. A triggering event occurs ~~six~~18 months following the closing of  
14 a loan made under the program.
- 15 (9) Loans are made pursuant to an agreement with a qualifying business that  
16 includes at least the following:
- 17 a. A provision requiring a qualifying business to certify in writing that it  
18 will use a loan provided under the program for employee compensation, mortgage, rent, utilities, and other operating costs and  
19 expenses incurred on behalf of a business located in this State.
- 20 b. A provision establishing the method for determining compliance with  
21 the program.
- 22 c. A provision requiring the qualifying business to first repay the loan  
23 amount with any federal assistance received by the business that  
24 represents a duplication of benefits; provided, that the repayment does  
25 not disqualify or impair the federal assistance available to the business.
- 26 d. A provision requiring the loan is secured through a Uniform  
27 Commercial Code financing statement.
- 28 e. A provision requiring recapture of loan funds if a business fails to  
29 comply with the requirements of the program. The lender shall  
30 recapture loan funds only if the lender determines there is a reasonable  
31 expectation that the recovery of funds will exceed the cost of recovery.
- 32 (10) The awarding of new loans using State funds appropriated in this section shall  
33 cease ~~upon six months following the date the State of Emergency ends.~~ on the

7 (\$125.00) of State funds allocated in this section. State funds allocated in this section may be  
8 matched with any prior expenditure by Golden LEAF of non-State funds for entities making

43           **SECTION 1.9.(c)** Reporting. – Beginning November 30, 2020, the Office of State  
44 Budget and Management shall report to the Fiscal Research Division weekly on the reallocations  
45 made pursuant to this section.

## 46 **PART II. DISASTER RECOVERY**

### 47 **CREATION OF EARTHQUAKE DISASTER RECOVERY RESERVE**

48           **SECTION 2.1.** The State Controller shall establish an Earthquake Disaster Recovery  
49 Reserve in the State General Fund to maintain funds reserved for disaster recovery in this Part.  
50  
51

1 The State Controller shall transfer funds to the Earthquake Disaster Recovery Fund only as  
2 needed to meet the appropriations set out in this Part or other related acts of the General Assembly  
3 and only upon request by the Director of the Budget. Funds shall remain in the Reserve until  
4 funds are needed to comply with the allocations as set forth in this Part. Funds reserved in the  
5 Reserve do not constitute an "appropriation made by law," as that phrase is used in Section 7(1)  
6 of Article V of the North Carolina Constitution.

## 8 **CREATION OF EARTHQUAKE DISASTER RECOVERY FUND**

9 **SECTION 2.2.(a)** The Earthquake Disaster Recovery Fund is established. The  
10 purpose of the Fund is to provide necessary and appropriate relief and assistance from the effects  
11 of the M5.1 earthquake that occurred on August 9, 2020, in Alleghany County, North Carolina,  
12 consistent with the provisions of this Part. The Fund shall be maintained as a special fund and  
13 administered by the Office of State Budget and Management or by another State agency, as  
14 determined by the Governor, to carry out the provisions of this Part. All State and federal funds  
15 appropriated for earthquake relief and recovery efforts shall be budgeted and accounted for in  
16 the Fund established in this section.

17 **SECTION 2.2.(b)** Funds shall be drawn from the Fund only as needed upon  
18 justification by a State agency as evidence of the need for funds is determined for earthquake  
19 recovery efforts in Alleghany County.

20 **SECTION 2.2.(c)** Funds in the Fund that are not expended, made subject to an  
21 encumbrance, or disbursed shall remain available to implement the provisions of this Part until  
22 the General Assembly directs the reversion of the unexpended funds. Funds received by a State  
23 agency from the Fund that are not expended, made subject to an encumbrance, or disbursed to  
24 another entity at the end of each fiscal year shall revert to the Fund. Funds received by a non-State  
25 entity from the Fund that, after three years, are not expended, made subject to an encumbrance,  
26 or disbursed to a subgrantee shall be returned to the Fund.

27 **SECTION 2.2.(d)** The funds are to be spent only for earthquake relief and recovery  
28 efforts in Alleghany County, and in any counties that are (i) part of the emergency area set forth  
29 in any gubernatorial executive order or (ii) declared as a major disaster by the President of the  
30 United States under the Stafford Act (P.L. 93-288) as a result of the earthquake.

## 31 **TRANSFERS OF FUNDS FOR EARTHQUAKE DISASTER RELIEF**

32 **SECTION 2.3.(a)** The State Controller shall transfer the sum of twenty-four million  
33 dollars (\$24,000,000) for the 2020-2021 fiscal year from the Savings Reserve in the General  
34 Fund to the Earthquake Disaster Recovery Reserve established in Section 2.1 of this act.

35 **SECTION 2.3.(b)** The State Controller shall transfer the sum of twenty-four million  
36 dollars (\$24,000,000) for the 2020-2021 fiscal year from the Earthquake Disaster Recovery  
37 Reserve established in Section 2.1 of this act, to the Earthquake Disaster Recovery Fund  
38 established in Section 2.2 of this act.

## 39 **APPROPRIATION AND ALLOCATION OF FUNDS FOR EARTHQUAKE DISASTER 40 RELIEF**

41 **SECTION 2.4.** There is appropriated from the Earthquake Disaster Recovery Fund  
42 the sum of twenty-four million dollars (\$24,000,000) in nonrecurring funds for the 2020-2021  
43 fiscal year to the Department of Public Safety, Division of Emergency Management to allocate  
44 as follows:

- 45 (1) \$600,013 to Alleghany County for repairs and renovations for the county  
46 courthouse caused by damages from the earthquake.
- 47 (2) \$160,000 to the Bruce Wayne Osbourne Post No. 7034, Veterans of Foreign  
48 Wars of the United States, a nonprofit corporation, to repair damage to the  
49  
50



- 1 Veterans of Foreign Wars Post No. 7034 building located in Alleghany  
2 County caused by the earthquake.
- 3 (3) The remainder of the funds appropriated in this section shall be used for the  
4 following purposes related to the effects of the earthquake:
- 5 a. Short-term housing.
  - 6 b. Short-term rental assistance.
  - 7 c. Demolition for reconstruction.
  - 8 d. Home reconstruction.
  - 9 e. Septic system reconstruction.
  - 10 f. Home repair reimbursements.
  - 11 g. County and municipal water and sewer repair.
  - 12 h. Other county assistance.
  - 13 i. Other earthquake-related recovery efforts.
  - 14 j. State and county project management administration.
  - 15 k. State match for federal disaster assistance programs.
- 16 (4) Funds allocated under subdivision (3) of this section shall not be used to  
17 provide grants to for-profit businesses through a disaster recovery grant  
18 program.  
19

## 20 REIMBURSEMENT FOR FUNDS PROVIDED FOR EARTHQUAKE DISASTER 21 RELIEF

22 **SECTION 2.5.(a)** A recipient of State funds under Section 2.4 of this act shall use  
23 best efforts and take all reasonable steps to obtain alternative funds that cover the losses or needs  
24 for which the State funds are provided, including funds from insurance policies in effect and  
25 available federal aid. State funds paid under this act are declared to be excess over funds received  
26 by a recipient from the settlement of a claim for loss or damage covered under the recipient's  
27 applicable insurance policy in effect.

28 **SECTION 2.5.(b)** If a recipient obtains alternative funds pursuant to subsection (a)  
29 of this section, the recipient shall remit the funds to the State agency from which the State funds  
30 were received. A recipient is not required to remit any amount in excess of the State funds  
31 provided to the recipient under this act. The State agency shall transfer these funds to the  
32 Earthquake Disaster Recovery Fund. Funds deposited into the Fund under this subsection are  
33 receipts that do not constitute an "appropriation made by law," as that phrase is used in Section  
34 7(1) of Article V of the North Carolina Constitution.

35 **SECTION 2.5.(c)** Any contract or other instrument entered into by a recipient for  
36 receipt of funds under this act shall include the requirements set forth in subsections (a) and (b)  
37 of this section.

38 **SECTION 2.5.(d)** For purposes of this section, the term "recipient" means a local  
39 political subdivision of the State, a State agency, a State department, or a non-State entity.  
40

## 41 APPROPRIATION AND ALLOCATION OF FUNDS FOR HURRICANE DISASTER 42 RELIEF

43 **SECTION 2.6.(a)** Hurricane Florence Disaster Recovery Reserve. – The State  
44 Controller shall transfer the sum of twenty-seven million seven hundred ninety-six thousand six  
45 hundred ten dollars (\$27,796,610) from the Savings Reserve in the General Fund to the Hurricane  
46 Florence Disaster Recovery Reserve created in S.L. 2018-136.

47 **SECTION 2.6.(b)** Hurricane Florence Disaster Recovery Fund. – The State  
48 Controller shall transfer the sum of twenty-seven million seven hundred ninety-six thousand six  
49 hundred ten dollars (\$27,796,610) from the Hurricane Florence Disaster Recovery Reserve to the  
50 Hurricane Florence Disaster Recovery Fund created in S.L. 2018-134 for the Department of

1 Public Safety and those funds are appropriated within the Fund to be used to provide State match  
2 for Hurricane Florence federal disaster assistance programs.

3 **SECTION 2.6.(c)** Allocation. – Of the funds appropriated in subsection (b) of this  
4 section to the Hurricane Florence Disaster Recovery Fund the sum of three hundred thousand  
5 dollars (\$300,000) is allocated to the Office of State Budget and Management to provide a grant  
6 to the Town of Bladenboro for the demolition, reconstruction, and repair of public infrastructure  
7 and public buildings damaged by Hurricane Florence.

8 **SECTION 2.6.(d)** State Emergency Response and Disaster Relief Fund. – The State  
9 Controller shall transfer the sum of thirteen million two hundred three thousand three hundred  
10 ninety dollars (\$13,203,390) from the Savings Reserve in the General Fund to the State  
11 Emergency Response and Disaster Relief Fund and those funds are appropriated for the  
12 Department of Public Safety, Division of Emergency Management, to be used as follows:

13 (1) \$10,423,729 to provide State match for federal disaster assistance programs  
14 related to Hurricane Matthew.

15 (2) \$2,779,661 to provide State match for federal disaster assistance programs  
16 related to Hurricane Dorian.

17 **SECTION 2.6.(e)** Other Disaster Relief. – The sum of up to three million five  
18 hundred thousand dollars (\$3,500,000) is reallocated and appropriated from the cash balance of  
19 the State Emergency Response and Disaster Relief Fund to the Department of Public Safety,  
20 Division of Emergency Management, to provide State match for federal disaster assistance  
21 programs related to Hurricane Isaias, as approved by the Federal Emergency Management  
22 Agency in EM-3534-NC on August 2, 2020, as a federal disaster.

## 23 24 **APPROPRIATION OF FEDERAL FUNDS**

25 **SECTION 2.7.** Appropriation/Federal Funds. – Funds received on or after  
26 September 1, 2020, under the federal Stafford Act (P.L. 93-288) and other federal disaster  
27 assistance programs for State disasters as a result of Hurricanes Florence, Dorian, Matthew, or  
28 Isaias, or the earthquake described in Section 2.2(a) of this act, are appropriated in the amounts  
29 provided in the notifications of award from the federal government or any entity acting on behalf  
30 of the federal government to administer federal disaster recovery funds. The Office of State  
31 Budget and Management and affected State agencies shall report all notifications of award to the  
32 Joint Legislative Commission on Governmental Operations and the Fiscal Research Division of  
33 the General Assembly.

## 34 35 **REPORTING REQUIREMENTS**

36 **SECTION 2.8.** Beginning January 1, 2021, the Department of Public Safety,  
37 Division of Emergency Management (Division), shall report to the Chairs of the House of  
38 Representatives and Senate Appropriations Committees and to the Fiscal Research Division of  
39 the General Assembly on the implementation of Section 2.4 and Section 2.6(e) of this Part on a  
40 quarterly basis and shall also provide any additional reports or information requested by the  
41 Fiscal Research Division. The final report is due on January 1, 2022. Each report required by this  
42 section shall include information about all funds expended or encumbered pursuant to Section  
43 2.4 and Section 2.6(e) as of the date of the report, regardless of which State agency or non-State  
44 entity administers the funds. Non-State entities that administer or receive any funds appropriated  
45 in this act shall assist and fully cooperate with the Division in meeting the Division's obligations  
46 under this section.

## 47 48 **PART III. OTHER REVISIONS OF LAW**

## 49 50 **AVERAGE DAILY MEMBERSHIP/HOLD HARMLESS**

1           **SECTION 3.1.** Notwithstanding Section 7.15(b) of S.L. 2007-323, for the  
2 2020-2021 fiscal year, the following applies:

- 3           (1) In making adjustments pursuant to G.S. 115C-75.10, 115C-218.105,  
4 115C-238.70, 115C-238.82, 116-239.11, and Section 8.35(e) of S.L.  
5 2014-100, as amended by Section 7.13 of S.L. 2018-5, the State Board of  
6 Education shall not reduce allocations to applicable public school units due to  
7 a discrepancy between their actual and anticipated average daily membership.  
8           (2) After funding adjustments are made pursuant to subdivision (1) of this section,  
9 the State Board of Education shall not reduce allotments for local school  
10 administrative units due to a discrepancy between actual and anticipated  
11 average daily membership.  
12

### 13 **REVISE DEFINITION OF ADM IN PRINCIPAL SALARY SCHEDULE TO CONTINUE** 14 **USING MEMBERSHIP AMOUNTS FROM THE 2019-2020 SCHOOL YEAR**

15           **SECTION 3.1A.** Section 4.(b) of S.L. 2020-45 reads as rewritten:

16           "**SECTION 4.(b)** For purposes of determining the average daily membership of a principal's  
17 school, ~~the following amounts shall be used during the following time periods:~~

- 18           (1) ~~Between July 1, 2020, and December 31, 2020, the average daily membership~~  
19 ~~for the school from the 2019-2020 school year-year shall be used.~~ If the school  
20 did not have an average daily membership in the 2019-2020 school year, the  
21 projected average daily membership for the school for the 2020-2021 school  
22 year-year shall be used.  
23           (2) ~~Between January 1, 2021, and June 30, 2021, the average daily membership~~  
24 ~~for the school for the 2020-2021 school year."~~  
25

### 26 **VIRTUAL CHARTER SCHOOL ENROLLMENT**

27           **SECTION 3.2.(a)** Notwithstanding Section 8.35(b) of S.L. 2014-100, as amended  
28 by Section 7.13 of S.L. 2018-5, the two virtual charter schools participating in the pilot program  
29 pursuant to Section 8.35 of S.L. 2014-100, as amended, shall be permitted to increase student  
30 enrollment for the 2020-2021 school year only as follows: (i) North Carolina Cyber Academy  
31 shall be permitted to increase its enrollment by 1,000 students and (ii) North Carolina Virtual  
32 Academy shall be permitted to increase its enrollment by 2,800 students. A virtual charter school  
33 permitted an increase in student enrollment pursuant to this section shall give enrollment priority  
34 to students for the 2021-2022 school year who were enrolled in the school for the 2020-2021  
35 school year prior to the date this act became law.

36           **SECTION 3.2.(b)** The virtual charter schools shall provide an interim report by  
37 March 15, 2021, and a final report by November 15, 2021, to the Joint Legislative Education  
38 Oversight Committee, on the impact of the increase in student enrollment permitted by  
39 subsection (a) of this section, including data on where students had been previously enrolled by  
40 local school administrative unit, charter school, or nonpublic school, the grade level of students,  
41 the withdrawal rate of students after enrollment, and any student performance and accountability  
42 data.  
43

### 44 **CHANGES TO THE OPPORTUNITY SCHOLARSHIP GRANT PROGRAM**

45           **SECTION 3.3.(a)** Remove Cap on K-1 Grade Funds. – G.S. 115C-562.2(a) reads as  
46 rewritten:

47           "(a) The Authority shall make available no later than February 1 annually applications to  
48 eligible students for the award of scholarship grants to attend any nonpublic school. Information  
49 about scholarship grants and the application process shall be made available on the Authority's  
50 Web site. Beginning March 15, the Authority shall begin awarding scholarship grants according  
51 to the following criteria:

- 1 (1) First priority shall be given to eligible students who received a scholarship  
2 grant for the school year prior to the school year for which the students are  
3 applying if those students have applied by March 1.
- 4 (2) After scholarship grants have been awarded to prior recipients as provided in  
5 subdivision (1) of this subsection, scholarships shall be awarded with  
6 remaining funds as follows:
- 7 a. At least fifty percent (50%) of the remaining funds shall be used to  
8 award scholarship grants to eligible students residing in households  
9 with an income level not in excess of the amount required for the  
10 student to qualify for the federal free or reduced-price lunch program.
- 11 ~~b. No more than forty percent (40%) of the remaining funds shall be used  
12 to award scholarship grants to eligible students entering either  
13 kindergarten or first grade.~~
- 14 c. Any remaining funds shall be used to award scholarship grants to all  
15 other eligible students."

16 **SECTION 3.3.(b)** Applicability of Removing the K-1 Grade Cap. – Subsection (a)  
17 of this section applies beginning with applications for scholarship grants for the 2020-2021  
18 school year. From the funds made available pursuant to subsection (a) of this section, the State  
19 Education Assistance Authority shall award scholarship funds for the fall semester of the  
20 2020-2021 school year to provide an alternative educational option during the coronavirus  
21 disease 2019 (COVID-19) pandemic to eligible students who (i) had applied for scholarship  
22 funds for the 2020-2021 school year within the application deadlines established by the Authority  
23 and (ii) had not been awarded scholarship funds as of the date this act becomes law.

24 **SECTION 3.3.(c)** Change to Income Eligibility Threshold. – G.S. 115C-562.1(3)b.  
25 reads as rewritten:

- 26 "b. Resides in a household with an income level not in excess of ~~one~~  
27 ~~hundred thirty three percent (133%)~~ one hundred fifty percent (150%)  
28 of the amount required for the student to qualify for the federal free or  
29 reduced-price lunch program. The Authority shall not count any  
30 distribution from the estate of a decedent in calculating the income  
31 level of the applicant's household for the purposes of determining  
32 eligibility for a scholarship under this sub-subdivision."

33 **SECTION 3.3.(d)** Applicability of Change to Income Eligibility Threshold. –  
34 Subsection (c) of this section applies beginning with applications for the spring semester of the  
35 2020-2021 school year.

### 37 NC PATRIOT STAR FAMILY SCHOLARSHIP PROGRAM

38 **SECTION 3.4.(a)** Transfer of Funds. – By October 1, 2020, the Department of  
39 Public Instruction shall transfer the sum of one million dollars (\$1,000,000) in nonrecurring funds  
40 from the cash balance in the School Bus Replacement Fund (Budget Code: 73510; Fund Code:  
41 7200) to UNC System Office (Budget Code: 16015).

42 **SECTION 3.4.(b)** Appropriation of Funds. – The funds transferred in subsection (a)  
43 of this section are appropriated to the Board of Governors of The University of North Carolina  
44 for the 2020-2021 fiscal year to be allocated by the Board of Governors as grants to establish and  
45 administer the North Carolina Patriot Star Family Scholarship Program in accordance with this  
46 section as follows:

- 47 (1) The sum of five hundred thousand dollars (\$500,000) to the Patriot  
48 Foundation, a nonprofit corporation.
- 49 (2) The sum of five hundred thousand dollars (\$500,000) to the Marine Corps  
50 Scholarship Foundation, Inc., a nonprofit corporation.

1           **SECTION 3.4.(c)** Establishment of the Scholarship Program. – From the funds  
2 appropriated for the North Carolina Patriot Star Family Scholarship Program (Program) by  
3 subsection (b) of this section, the Patriot Foundation and the Marine Corps Scholarship  
4 Foundation, Inc., respectively, shall provide for scholarships to eligible children and eligible  
5 spouses of certain veterans and eligible children of certain currently serving members of the  
6 Armed Forces to attend eligible postsecondary institutions in accordance with the requirements  
7 of this section.

8           **SECTION 3.4.(d)** Definitions. – For the purposes of this section, the following  
9 definitions apply:

10           (1) Armed Forces. – A component of the United States Army, Navy, Marine  
11 Corps, Air Force, and Coast Guard, including their reserve components.

12           (2) Eligible child or eligible children. – Any person (i) who is attending or has  
13 been accepted to enroll in an eligible postsecondary institution, (ii) who is a  
14 legal resident of North Carolina when scholarship documentation is  
15 completed, provided that if a child is claimed as a dependent by the child's  
16 parent, residency may be established based on a parent meeting  
17 sub-sub-subdivision 4. of sub-subdivision a. of this subdivision, (iii) has  
18 complied with the requirements of the Selective Service System, if applicable,  
19 and (iv) whose parent is a veteran or a currently serving member of the Armed  
20 Forces that meets the following:

21           a. Meets one of the following residency conditions:

- 22                   1. Is a resident of North Carolina at the time of scholarship  
23 documentation completion.
- 24                   2. Was a resident of North Carolina at the time of entrance into  
25 service in the Armed Forces.
- 26                   3. Was permanently stationed in North Carolina at the time of his  
27 or her death.
- 28                   4. Is an active duty service member permanently stationed in  
29 North Carolina at the time of documentation completion.

30           b. Meets one of the following service conditions:

- 31                   1. Was a member of the Armed Forces who was killed in action  
32 or in the line of duty, or died of wounds or other causes not due  
33 to the service member's willful misconduct during a period of  
34 war or national emergency.
- 35                   2. Was a member of the Armed Forces who died of  
36 service-connected injuries, wounds, illness, or other causes  
37 incurred or aggravated while a member of the Armed Forces  
38 during a period of war or national emergency. Standard  
39 documentation of the parent's death, wounds, injury, or illness  
40 must be supplied by a scholarship recipient at the time of  
41 scholarship request.
- 42                   3. Is a veteran of the Armed Forces who incurred traumatic  
43 injuries or wounds or sustained a major illness while a member  
44 of the Armed Forces during a period of war or national  
45 emergency and is receiving compensation for a wartime  
46 service-connected disability of at least fifty percent (50%) as  
47 rated by the U.S. Department of Veterans Affairs.
- 48                   4. Is a current member of the Armed Forces who incurred  
49 traumatic injuries or wounds or sustained a major illness while  
50 a member of the Armed Forces during a period of war or  
51 national emergency. The parent's traumatic wounds, injury, or

1 major illness must be documented by the U.S. Department of  
2 Defense.

- 3 (3) Eligible spouse. – Any person (i) who is attending or has been accepted to  
4 enroll in an eligible postsecondary institution, (ii) who is a legal resident of  
5 North Carolina when scholarship documentation is completed, (iii) has  
6 complied with the requirements of the Selective Service System, if applicable,  
7 and (iv) whose spouse was a member of the Armed Forces who was killed in  
8 action or in the line of duty, or died of wounds or other causes not due to the  
9 service member's willful misconduct during a period of war or national  
10 emergency.
- 11 (4) Eligible postsecondary institution. – A school that is any of the following:  
12 a. A constituent institution of The University of North Carolina.  
13 b. A community college under the jurisdiction of the State Board of  
14 Community Colleges.  
15 c. A private educational institution as defined in G.S. 143B-1224.  
16 d. An accredited, private vocational institution.
- 17 (5) Veteran. – An individual who has served and is no longer serving in the Armed  
18 Forces of the United States. For the purposes of this section, the veteran must  
19 have separated from the Armed Forces under honorable conditions or whose  
20 death or disability of at least fifty percent (50%) or more was incurred as a  
21 direct result of service in the line of duty.

22 **SECTION 3.4.(e)** Administration; Awards. – Within the funds made available for  
23 the Program, the Patriot Foundation and the Marine Corps Scholarship Foundation shall each  
24 separately administer and award scholarships to eligible children and eligible spouses in  
25 accordance with the requirements of the North Carolina Patriot Star Family Scholarship Program.  
26 In administering the Program, each nonprofit corporation shall be responsible for program  
27 oversight for the scholarships awarded through its organization to ensure compliance with the  
28 provisions of this section.

29 Each nonprofit corporation shall, at a minimum, establish criteria and procedures  
30 related to scholarship documentation completion, the amount of individual scholarships, the  
31 permissible uses of scholarship funds, the period of eligibility for award of a scholarship, the  
32 conditions for a revocation of a scholarship, and any other procedures it deems necessary for its  
33 administration of the Program. A scholarship awarded to an eligible child or eligible spouse shall  
34 not exceed the cost of attendance at the eligible postsecondary institution.

35 If an eligible child or eligible spouse receives a scholarship or other grant covering  
36 the cost of attendance at an eligible postsecondary institution for which the scholarship is  
37 awarded, then the amount of a scholarship awarded under this section shall be reduced so that  
38 the sum of all grants and scholarships covering the cost of attendance received by the eligible  
39 child or eligible spouse does not exceed the cost of attendance for the institution. For the purposes  
40 of this subsection, cost of attendance shall be deemed to include monies for tuition, fees, books,  
41 supplies, and equipment required for study at an eligible postsecondary institution, as well as  
42 room and board as long as the scholarship recipient is enrolled as at least a half-time student at  
43 the institution. Off-campus housing costs for room and board are also included to the extent the  
44 eligible postsecondary institution includes it in its cost of attendance.

45 **SECTION 3.4.(f)** Reporting. – The Patriot Foundation shall submit a report by April  
46 1, 2021, to the Joint Legislative Education Oversight Committee and the Fiscal Research  
47 Division on the activities described by this section and the use of the State funds.

48 The Marine Corps Scholarship Foundation, Inc., shall submit a report by April 1,  
49 2021, to the Joint Legislative Education Oversight Committee and the Fiscal Research Division  
50 on the activities described by this section and the use of the State funds.  
51

**UNC ENROLLMENT FUNDING FOR COMPREHENSIVE TRANSITION PROGRAMS**

**SECTION 3.5.** For the purposes of allocating enrollment funding to constituent institutions of The University of North Carolina, beginning with the 2021-2022 fiscal year, the Board of Governors shall allocate funds each fiscal year to constituent institutions on the same basis as full-time students enrolled in a curriculum program for up to 100 resident full-time students enrolled in either a four-semester or eight-semester certificate accomplishment program approved by the United States Department of Education as a Comprehensive Transition Program (CTP) pursuant to the Higher Education Opportunity Act of 2008, 20 U.S.C. §§ 1140f–1140i. If more than 100 resident full-time students are enrolled in CTPs at constituent institutions in any academic year, the Board of Governors shall allocate funds to each eligible constituent institution on a pro rata basis.

**EXPANSION OF AUTHORITY FOR UNC TO DESIGNATE COUNSEL**

**SECTION 3.6.** G.S. 116-11(13b) reads as rewritten:

"(13b) ~~Subject to the approval required in G.S. 114-2.3(a) and G.S. 147-17(a), the~~ Notwithstanding G.S. 114-2.3, G.S. 147-17, or any other provision of law, the Board may authorize the President to designate legal counsel, including private counsel, as the President deems necessary to represent the interests of the Board, The University of North Carolina, any constituent institution, or officer or employee of The University of North Carolina in any matter, case, or proceeding in or before any court or agency of this State, any other state, or the United States. The authority provided pursuant to this subdivision includes the discretion to designate whether legal representation in any given matter is provided by the Attorney General's office, attorneys employed on the legal affairs staff of The University of North Carolina, private counsel, or a combination thereof. In those instances when the President employs counsel in addition to or other than the Attorney General, the President may designate lead counsel to possess final decision-making authority with respect to the representation, counsel, or service for The University of North Carolina. Other counsel for The University of North Carolina shall, consistent with the Rules of Professional Conduct, cooperate with such designated lead counsel. The Board may authorize the expenditure of funds to hire private counsel to represent the Board, The University of North Carolina, and any constituent institution. G.S. 114-2.3(d), 143C-6-9(b), and 147-17(c1) shall not apply to these expenditures."

**MEDICAID NONTAX REVENUE/CLARIFICATION OF AMOUNT TO BE TRANSFERRED**

**SECTION 3.7.(a)** Section 2.3(b) of S.L. 2019-242 reads as rewritten:

"**SECTION 2.3.(b)** For the 2019-2020 fiscal year, the Department of Health and Human Services (DHHS) shall deposit from its revenues one hundred sixty-five million three hundred thousand dollars (\$165,300,000) with the Department of State Treasurer to be accounted for as nontax revenue. For the 2020-2021 fiscal year, the Department of Health and Human Services ~~shall~~ shall, from its revenues, deposit from its revenues one hundred thirty million dollars (\$130,000,000) with the Department of State Treasurer funds to be accounted for as nontax revenue. These deposits shall represent revenue that represent the return of General Fund appropriations, nonfederal revenue, fund balances, or other resources from State-owned and State-operated hospitals that are used to provide indigent and nonindigent care services. ~~services~~ in the amount of one hundred thirty million dollars (\$130,000,000). If the funds returned to DHHS exceed one hundred thirty million dollars (\$130,000,000) for the 2020-2021 fiscal year,

1 then DHHS shall deposit the greater amount actually received. The return from State-owned and  
2 State-operated hospitals to the Department of Health and Human Services will be made from  
3 nonfederal resources in an amount equal to the amount of the payments from the Division of  
4 Health Benefits for uncompensated care. The treatment of any revenue derived from federal  
5 programs shall be in accordance with the requirements specified in the Title 2, Code of Federal  
6 Regulations, Part 225."

7 **SECTION 3.7.(b)** This section is effective July 1, 2020, and applies to the 2020-2021  
8 fiscal year only.

## 10 **FLEXIBILITY FOR CERTAIN CHILD CARE LICENSING REQUIREMENTS**

11 **SECTION 3.7A.(a)** Article 7 of Chapter 110 of the General Statutes is amended by  
12 adding a new section to read:

### 13 **"§ 110-98.5. Care for school-age children during state of emergency.**

14 Notwithstanding any provision of law or rule to the contrary, when remote or virtual learning  
15 is required due to a declared state of emergency issued under G.S. 166A-19.20, the following  
16 shall apply:

17 (1) A community-based organization is authorized to provide care for school-age  
18 children at a remote learning facility, provided the community-based  
19 organization is registered with the Department through a process consistent  
20 with the registration process the Department uses for licensed child care  
21 facilities. For purposes of this subdivision, the following definitions shall  
22 apply:

23 a. Community-based organizations. – Organizations of demonstrated  
24 effectiveness that are representative of a community or significant  
25 segments of a community that provide educational or related services  
26 to individuals in the community, such as parks and recreation  
27 programs, YMCAs, YWCAs, and Boys and Girls Clubs.

28 b. Remote learning facility. – A building or space used to house  
29 school-age children during the school year for the purpose of  
30 facilitating online or remote learning.

31 (2) When providing care to school-age children pursuant to this section, the  
32 limitations regarding the maximum amount of screen time for children three  
33 years of age and older shall not apply.

34 (3) Care provided to school-age children pursuant to this section is not considered  
35 child care as defined under G.S. 110-86."

36 **SECTION 3.7A.(b)** G.S. 110-86 reads as rewritten:

### 37 **"§ 110-86. Definitions.**

38 Unless the context or subject matter otherwise requires, the terms or phrases used in this  
39 Article shall be defined as follows:

40 ...  
41 (2) Child care. – A program or arrangement where three or more children less  
42 than 13 years old, who do not reside where the care is provided, receive care  
43 on a regular basis of at least once per week for more than four hours but less  
44 than 24 hours per day from persons other than their guardians or full-time  
45 custodians, or from persons not related to them by birth, marriage, or adoption.  
46 Child care does not include the following:

47 ...  
48 i. Cooperative arrangements among parents to provide care for their own  
49 children as a convenience rather than for ~~employment;~~employment.  
50 This exemption shall include arrangements between a group of  
51 parents, regardless of whether the parents are working, to provide for



1 the instructional needs of their children, provided the arrangement  
2 occurs in the home of one of the cooperative participants;

3 ...."

4 **SECTION 3.7A.(c)** Any community-based organization operating pursuant to  
5 subsection (a) of this section during the COVID-19 pandemic shall comply with the same  
6 COVID-19 related sanitation requirements as required of licensed child care facilities.

24 **DETERMINING IMPACT OF PRIOR VIOLATIONS AND COMPLIANCE HISTORY**  
25 **ON NEW AND RENEWAL ADULT CARE HOME LICENSES**

26 **SECTION 3.7C.(a)** G.S. 131D-2.4 reads as rewritten:

27 "**§ 131D-2.4. Licensure of adult care homes for aged and disabled individuals; impact of**  
28 **prior violations on licensure; compliance history review; license renewal.**

29 (a) Definitions. – The following definitions apply in this section:

30 (1) Person. – An individual; a trust or estate; a partnership; a corporation; or any  
31 grouping of individuals, each of whom owns five percent (5%) or more of a  
32 partnership or corporation, who collectively own a majority interest of either  
33 a partnership or a corporation.

34 (2) Owner. – Any person who has or had legal or equitable title to or a majority  
35 interest in an adult care home.

36 (3) Affiliate. – An adult care home that shares with another adult care home any  
37 of the following:

38 a. A common owner.

39 b. A common principal.

40 c. A common licensee.

41 (4) Principal. – Any person who is or was the owner or operator of an adult care  
42 home, an executive officer of a corporation that does or did own or operate an  
43 adult care home, a general partner of a partnership that does or did own or  
44 operate an adult care home, or a sole proprietorship that does or did own or  
45 operate an adult care home.

46 (a1) Licensure. – Except for those facilities exempt under G.S. 131D-2.3, the Department  
47 of Health and Human Services shall inspect and license all adult care homes. The Department  
48 shall issue a license for a facility not currently licensed as an adult care home for a period of six  
49 months. If the licensee demonstrates substantial compliance with Articles 1 and 3 of this Chapter  
50 and rules adopted thereunder, the Department shall issue a license for the balance of the calendar  
51 year. A facility not currently licensed as an adult care home that was licensed as an adult care

1 home within the preceding 12 months is considered an existing health service facility for the  
2 purposes of G.S. 131E-184(a)(8).

3 (b) Compliance History Review. – Prior to issuing a new license or renewing an existing  
4 license, the Department shall conduct a compliance history review of the facility and its  
5 principals and affiliates. The Department may refuse to license a facility when the compliance  
6 history review shows a pattern of noncompliance with State law by the facility or its principals  
7 or affiliates, or otherwise demonstrates disregard for the health, safety, and welfare of residents  
8 in current or past facilities. The Department shall require compliance history information and  
9 make its determination according to rules adopted by the Medical Care Commission.

10 (c) Prior Violations. – No new license shall be issued for any adult care home to an  
11 applicant for licensure under any of the following circumstances for the period of time indicated:

12 (1) Was the owner, principal, or affiliate of a licensable facility under this  
13 Chapter, Chapter 122C, or Article 7 of Chapter 110 of the General Statutes  
14 and was responsible for the operation of the facility that had its license  
15 revoked until five years after the date the revocation became effective.

16 (1a) Was the owner, principal, or affiliate of a licensable facility under this  
17 Chapter, Chapter 122C, or Article 7 of Chapter 110 of the General Statutes  
18 and was responsible for the operation of the facility that had its license  
19 summarily suspended until five years after the date the suspension was lifted  
20 or terminated.

21 (2) Is the owner, principal, or affiliate of an adult care home and is responsible  
22 for the operation of the facility that was assessed a penalty for a Type A or  
23 Type B violation until the earlier of one year from the date the penalty was  
24 assessed or until the home has substantially complied with the correction plan  
25 established pursuant to G.S. 131D-34 and substantial compliance has been  
26 certified by the Department.

27 (3) Is the owner, principal, or affiliate of an adult care home and is responsible  
28 for the operation of the facility that had its license downgraded to provisional  
29 status or had its admissions suspended as a result of violations under this  
30 Article, Chapter 122C, or Article 7 of Chapter 110 of the General Statutes  
31 until ~~six months from~~ the date of restoration from provisional to full licensure,  
32 termination of the provisional license, or lifting or termination of the  
33 suspension of admissions, as applicable. A provisional license or suspension  
34 of admissions for which an appeal is pending is exempt from consideration  
35 under this subdivision.

36 (4) Repealed by Session Laws 2017-184, s. 1, effective October 1, 2017.

37 (5) Is or was the owner, principal, or affiliate of an adult care home and is  
38 responsible for the operation of the facility where outstanding fees, fines, and  
39 penalties imposed by the State against the facility have not been paid. Fines  
40 and penalties for which an appeal is pending are exempt from consideration  
41 under this subdivision.

42 An applicant for new licensure may appeal a denial of certification of substantial compliance  
43 under subdivision (2) of this subsection by filing with the Department a request for review by the  
44 Secretary within 10 days ~~of~~ after the date of denial of the certification. Within 10 days ~~of~~ after  
45 receipt of the request for review, the Secretary shall issue to the applicant a written determination  
46 that either denies certification of substantial compliance or certifies substantial compliance. The  
47 decision of the Secretary is final.

48 (d) License Renewals. – License renewals shall be valid for one year from the date of  
49 renewal unless revoked earlier by the Secretary for failure to comply with any part of this section  
50 or any rules adopted ~~hereunder~~ under this section. Licenses shall be renewed annually upon  
51 filing and the Department's approval of the renewal application. The Department shall not renew

1 a license if outstanding fees, fines, and penalties imposed by the State against the home have not  
2 been paid. Fines and penalties for which an appeal is pending are exempt from consideration.  
3 The renewal application shall contain all necessary and reasonable information that the  
4 Department may require.

5 (e) In order for an adult care home to maintain its license, it shall not hinder or interfere  
6 with the proper performance of duty of a lawfully appointed community advisory committee, as  
7 defined by G.S. 131D-31 and G.S. 131D-32.

8 (f) The Department shall not issue a new license for a change of ownership of an adult  
9 care home if outstanding fees, fines, and penalties imposed by the State against the home have  
10 not been paid. Fines and penalties for which an appeal is pending are exempt from consideration.  
11 The consent of the current licensee is not a required prerequisite to a change of ownership of an  
12 adult care home if the current licensee has (i) been removed from the facility pursuant to Articles  
13 3 and 7 of Chapter 42 of the General Statutes or (ii) abandoned the facility, as determined by the  
14 Department's reasonable discretion.

15 (g) Any applicant for licensure who wishes to contest the denial of a license is entitled to  
16 an administrative hearing as provided in Chapter 150B of the General Statutes. The applicant  
17 shall file a petition for a contested case within 30 days after the date the Department mails a  
18 written notice of the denial to the applicant."

19 **SECTION 3.7C.(b)** This section supersedes any provision of 10A NCAC 13F.0201,  
20 or any other provision of the North Carolina Administrative Code, to the contrary. As promptly  
21 as practicable, the Medical Care Commission shall amend and update 10A NCAC 13F.0201 and  
22 any other impacted rule to reflect the changes enacted by this section.

23 **SECTION 3.7C.(c)** This section applies to (i) applications for new licenses  
24 submitted to the Department of Health and Human Services, Division of Health Service  
25 Regulation (DHSR), on or after the effective date of this section, (ii) applications for the renewal  
26 of existing licenses submitted to the DHSR on or after the effective date of this section, and (iii)  
27 licenses downgraded by DHSR within the six-month period preceding the effective date of this  
28 section.

### 29 **FORT FISHER AQUARIUM FUNDING FLEXIBILITY**

30 **SECTION 3.8.** Notwithstanding Section 3.1(b) of S.L. 2018-134 or any other  
31 provision of law restricting the purposes for which funds drawn from the Hurricane Florence  
32 Disaster Recovery Fund may be used, funds appropriated from that Fund in S.L. 2019-224 and  
33 allocated to the Department of Natural and Cultural Resources for the aquarium at Fort Fisher  
34 may be used for the renovation or expansion of the aquarium.  
35

### 36 **REDIRECT FOREST SERVICE FUNDS**

37 **SECTION 3.9.** The funds allocated to the North Carolina Forest Service by  
38 subdivision (10) of Section 4.1 of S.L. 2016-124 and that are unencumbered and unexpended for  
39 those purposes or for the additional purposes authorized by Section 12.9 of S.L. 2017-57 may be  
40 used by the Department of Agriculture and Consumer Services for either of the following  
41 purposes:

- 43 (1) The purchase and renovation of an existing facility for use as a regional  
44 headquarters and training facility for the North Carolina Forest Service.
- 45 (2) Support of operations and other receipt-supported activities such as

5 (Budget Code: 63011; Fund Code: 6201) to the North Carolina Housing Finance Agency the sum

37 (1) Agriculture. – Activities defined in G.S. 106-581.1.

38 (2) Broadband service. – For the purposes of this section, terrestrially deployed  
39 Internet access service with transmission speeds of at least ~~40-25~~ megabits per  
40 second (Mbps) download and at least ~~one megabit-3 megabits~~ per second  
41 upload ~~(40:1)-(25:3)~~.

42 (2a) Business. – Any lawful trade, investment, or other purpose or activity, whether  
43 or not conducted or undertaken for profit. The term also includes community  
44 anchor points, agricultural operations, and agricultural processing facilities.

45 ...

46 (6) Eligible project. – An eligible project is a discrete and specific project located  
47 in an unserved area of an economically distressed county seeking to provide  
48 broadband service to homes, businesses, and community anchor points not  
49 currently served. Eligible projects do not include middle mile, backhaul, and  
50 other similar projects not directed at broadband service to end users. If a  
51 contiguous project area crosses from one eligible county into one or more

1 eligible adjacent counties, for the purposes of this section, the project shall be  
2 deemed to be located in the county where the greatest number of unserved  
3 households are proposed to be served. To qualify for an award under this  
4 section, no more than an incidental number of households or businesses, not  
5 to exceed ten percent (10%) of the total households or businesses within the  
6 boundaries of the project area submitted by the applicant, may have  
7 terrestrially deployed Internet access service with transmission speeds greater  
8 than 10 Mbps download and 1 Mbps upload.

9 ...

10 (9) Infrastructure costs. – Costs directly related to the construction of broadband  
11 infrastructure for the extension of broadband service for an eligible project,  
12 including installation, acquiring or updating easements, backhaul  
13 infrastructure, and testing costs. The term also includes engineering and any  
14 other costs associated with securing a lease to locate or collocate infrastructure  
15 on public or private property or structures, but not including the actual  
16 monthly lease payment. The term does not include overhead or administrative  
17 costs.

18 ...

19 (14) Unserved area. – A designated geographic area that is presently without access  
20 to broadband service, as defined in this section, offered by a wireline or fixed  
21 wireless provider. Areas where a private provider has been designated to  
22 receive funds through other State or federally funded programs designed  
23 specifically for broadband deployment shall be considered served if such  
24 funding is intended to result in construction of broadband in the area within  
25 18 months.

26 (15) Unserved household or business. – A household or business that does not  
27 presently have access to broadband service, as defined in this subsection.

28 ...

29 (d) Applications for grants will be submitted at times designated by the Secretary and  
30 will include, at a minimum, the following information:

31 ...

32 (5) An illustration or description of the area to be served, identifying the number  
33 of homes, businesses, community anchor points, agricultural operations, or  
34 agricultural processing facilities ~~homes and businesses~~ that will have access  
35 to broadband as a result of the project, including any available addresses, or  
36 other identifying information satisfactory to the Office, for the foregoing. In  
37 the event that the Office is unable to identify the proposed project area with  
38 specificity, the Office may require the applicant to submit additional  
39 information. If construction of the proposed project would result in the  
40 provision of broadband service to areas that are not eligible for funding, those  
41 ineligible areas should be identified in the application along with the eligible  
42 areas.

43 ...

44 (11) For the proposed area to be served, the infrastructure cost per household or  
45 business for the project.

46 ...

47 (e) Applications shall be made publicly available by posting on the Web site of the  
48 Department of Information Technology for a period of at least 30 days prior to award. During  
49 the 30-day period, any interested party may submit comments to the Secretary concerning any  
50 pending application. A provider of broadband services may submit a protest of any application  
51 on the grounds the proposed project covers an area that is not an eligible area under this section.

1 Protests shall be submitted in writing, accompanied by all relevant supporting documentation,  
 2 and shall be considered by the Office in connection with the review of the application. Upon  
 3 submission of evidence satisfactory to the Office that the proposed project area includes  
 4 prospective broadband recipients that are served, as measured using a methodology satisfactory  
 5 to the Office, the Office may work with an applicant to amend an application to reduce the  
 6 number of unserved prospective broadband recipients in the project area to reflect an accurate  
 7 level of current broadband service. The Office may revise application scores in accordance with  
 8 amended applications. applications, however, the Office may reject any amended application  
 9 resulting in a lower application score to the extent that the lower score would have impacted the  
 10 ranking of the application in the initial scoring process. For applications with filed protests, the  
 11 Secretary shall issue a written decision to the protesting party at least 15 days prior to the approval  
 12 of that application. Following a protest that is granted for a portion of the application, the Office  
 13 may release to an applicant the locations or areas declared ineligible. The information released  
 14 to the applicant is not a public record, as that term is defined under G.S. 132-1, and shall remain  
 15 confidential. Any provider submitting a protest shall verify that the information in the protest is  
 16 accurate and that the protest is submitted in good faith. The Office may deny any protest or  
 17 application that contains inaccurate information.

18 As a means of resolving a protest, the Office may utilize speed tests to determine if the  
 19 protested area or individual households or businesses currently have access to broadband service  
 20 as defined in this section. The Department shall publish the speed test methodology it uses to  
 21 assess speed levels pursuant to this section. All decisions regarding the speed test to be utilized  
 22 and the manner by which the speed tests are applied shall be made by the Secretary or the  
 23 Secretary's designee.

 25 (g) Applications shall be scored based upon a system that awards a single point for criteria  
 26 considered to be the minimum level for the provision of broadband service with additional points  
 27 awarded to criteria that exceed minimum levels. The Office shall score project applications in  
 28 accordance with the following:

- 29 ...  
 30 (4) Unserved businesses. – The Office shall give additional points to projects that  
 31 will provide broadband service to unserved businesses located within the  
 32 eligible economically distressed county, as determined by the most recent data  
 33 published by the Federal Communications Commission or any other  
 34 information available to the Office. Points shall be given to projects that serve  
 35 unserved businesses within the project area as follows:  
 36 a. Projects proposing to serve between 1 and 4 businesses shall receive 1  
 37 point.

 (i) Applications receiving the highest score shall receive priority status for the awarding of grants pursuant this section. As a means of breaking a tie for applications receiving the same score, the Office shall give priority to the application proposing to serve the highest number of new households at the lowest cost per ~~household.~~ household or business. Applicants awarded grants pursuant to this section shall enter into an agreement with the Office. The agreement shall contain all of the elements outlined in subsection (d) of this section and any other provisions the Office may require. The agreement shall contain a provision governing the time line and minimum requirements and thresholds for disbursement of grant funds measured by the progress of the project. Grant funds shall be disbursed only upon verification by the Office that the terms of the agreement have been fulfilled according to the progress milestones contained in the agreement. 11 **SECTION 3.19.(a)** Notwithstanding G.S. 130A-336.2(a), an individual licensed as  
12 a soil scientist pursuant to Chapter 89F of the General Statutes may, at the direction of the owner  
13 of a proposed on-site wastewater system, prepare signed and sealed soil and site evaluations,  
14 specifications, plans, and reports for the site layout, construction, operation, and maintenance of  
15 a wastewater system without also obtaining further certification from the North Carolina On-Site  
16 Wastewater Contractors and Inspectors Board.

17 **SECTION 3.19.(b)** In addition to the authority granted pursuant to subsection (a) of  
18 this section, an individual licensed as a soil scientist pursuant to Chapter 89F of the General  
19 Statutes and engaged by the owner of a proposed on-site wastewater system may conduct all  
20 necessary inspections, certifications, and approvals, including the issuance of the final inspection  
21 and report certifying that the system has been installed according to the approved plans and  
22 specifications for the construction, installation, and operation of a proposed wastewater system.

23 **SECTION 3.19.(c)** Wastewater systems constructed, installed, and operated under  
24 authority of this section shall otherwise comply with the requirements of G.S. 130A-336.2 and  
25 rules adopted thereunder. The owner of a proposed wastewater system shall notify the local  
26 health department that the owner is engaging a licensed soil scientist pursuant to the authority  
27 granted in this section.

28 **SECTION 3.19.(d)** The Department of Health and Human Services, the  
29 Department's authorized agents, and local health departments shall have no liability for  
30 wastewater systems developed, constructed, installed, or approved by a licensed soil scientist

5 (3) "State agency" means an agency or an officer in the executive branch of the

12 regarding a subdivision of land, a site-specific development plan or a  
13 phased development plan, a development permit, a development  
14 agreement, or a building permit under Chapter 160D of the General  
15 Statutes.  
16 e. Any certificate of appropriateness issued by a preservation  
17 commission of a city under Chapter 160D of the General Statutes.  
18 (2) Development. – The division of a parcel of land into two or more parcels; the  
19 construction, reconstruction, conversion, structural alteration, relocation, or  
20 enlargement of any building or other structure or facility; or any grading, soil  
21 removal or relocation, excavation or landfill, or any use or change in the use  
22 of any building or other structure or land or extension of the use of land.

23 **SECTION 3.21.(b)** For any development approval that is current and valid at any  
24 point during the period beginning September 2, 2020, and ending 30 days after Executive Order  
25 No. 116 is rescinded or December 31, 2021, whichever is earlier, the expiration date of the period  
26 of the development approval and any associated vested right under G.S. 160D-108 or  
27 G.S. 160D-108.1 is automatically extended 120 days from the expiration date.

28 **SECTION 3.21.(c)** This section shall not be construed or implemented to:

- 29 (1) Extend any permit or approval issued by the United States or any of its  
30 agencies or instrumentalities.  
31 (2) Extend any permit or approval for which the term or duration of the permit or  
32 approval is specified or determined pursuant to federal law.  
33 (3) Shorten the duration that any development approval would have had in the

36 (5) Affect any administrative consent order issued by the Department of  
37 Environmental Quality in effect or issued at any time from the effective date

40 (6) Affect the ability of a government entity to revoke or modify a development  
41 approval or to accept voluntary relinquishment of a development approval by

44 by the State of the authority to implement a federal law or program.  
45 (8) Modify any person's obligations or impair the rights of any party under  
46 contract, including bond or other similar undertaking.  
47 (9) Authorize the charging of a water or wastewater tap fee that has been  
48 previously paid in full for a project subject to a development approval.
