A BILL TO BE ENTITLED

AN ACT TO INCREASE THE MAXIMUM FEE FOR APPLICATION FOR CERTIFICATION OF AND FOR RENEWAL OF A COMPANY POLICE AGENCY AND A COMPANY POLICE OFFICER AND FOR APPLICATION FOR CERTIFICATION OF AND FOR RENEWAL OF A CAMPUS POLICE AGENCY AND A CAMPUS POLICE OFFICER.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 74E-12 reads as rewritten:

"§ 74E-12. Fees.

The Attorney General may charge fees for the items listed in the following table, not to exceed the amounts listed in the table:

<u>Item</u>	<u>Maximum Fee</u>
Application for certification as a company police agency	\$250 <u>\$500.00</u>
Annual renewal of certification as a company police agency	\$200 <u>\$250.00</u>
Application for reinstatement of certification as a company police agency	\$1,000 <u>\$1,000.00</u>
Application for commission as a company police officer	\$100 <u>\$300.00</u>
Annual renewal of commission as a company police officer	\$50 <u>\$150.00</u>
Application for reinstatement of commission as a company police officer	\$150 <u>\$150.00</u>

The fees imposed under this section are not refundable. Fees collected under this section shall be applied to the cost of administering this Chapter."

SECTION 2. G.S. 74G-12 reads as rewritten:

"§ 74G-12. Fees.

The Attorney General may charge fees for the items listed in the following table, not to exceed the amounts listed in the table:
