1 A BILL TO BE ENTITLED
2 AN ACT TO ADD ONE DISTRICT COURT JUDGE TO DISTRICT 23 AND TO MANDATE
3 THAT OF THE FIVE DISTRICT COURT JUDGE POSITIONS IN DISTRICT 23, ONE
4 JUDGE SHALL RESIDE IN ASHE COUNTY, ONE IN YADKIN COUNTY, AND THREE
5 IN WILKES COUNTY, AND TO APPROPRIATE FUNDS.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.** G.S. 7A-133 reads as rewritten:
8 **"§ 7A-133. Numbers of judges by districts; numbers of magistrates and additional seats of**
9 **court, by counties.**

10 (a) Each district court district shall have the numbers of judges as set forth in the
11 following table:

 18 (b8) The qualified voters of District Court District 23 shall elect all five judges established
 19 for the District in subsection (a) of this section, but only persons who reside in Ashe County may
 20 be candidates for one judgeship, only persons who reside in Yadkin County may be candidates
 21 for one judgeship, and only persons who reside in Wilkes County may be candidates for three
 22 judgeships."

23 **SECTION 2.** There is appropriated from the General Fund to the Administrative
 24 Office of the Courts the sum of one hundred nine thousand two hundred twenty-three dollars
 25 (\$109,223) in fiscal year 2020-2021 and one hundred ninety-eight thousand five hundred
 26 eighty-eight dollars (\$198,588) in fiscal year 2021-2022.

27 **SECTION 3.** Section 1 of this act becomes effective January 1, 2021, and elections
 28 conducted in 2020 shall be conducted in accordance with the judgeship created in Section 1. The
 29 remainder of this act is effective July 1, 2020.
