2 AN ACT TO ESTABLISH STANDARDS AND CRITERIA FOR THE REGULATION AND
3 LICENSURE OF PHARMACY BENEFITS MANAGERS PROVIDING CLAIMS
4 PROCESSING SERVICES OR OTHER PRESCRIPTION DRUG OR DEVICE SERVICES
5 FOR HEALTH BENEFIT PLANS.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.** G.S. 58-56A-10 is recodified as G.S. 58-56A-40.

8 **SECTION 2.** Article 56A of Chapter 58 of the General Statutes, as amended by
9 Section 1 of this act, reads as rewritten:

10 "Article 56A.

11 "Pharmacy Benefits Management.

12 **"§ 58-56A-1. Definitions.**

13 The following definitions apply in this Article:

- 14 (1) Claim. – A request from a pharmacy or pharmacist to be reimbursed for the
15 cost of administering, filling, or refilling a prescription for a drug or for
16 providing a medical supply or device.
- 17 (2) Claims processing service. – The administrative services performed in
18 connection with the processing and adjudicating of claims relating to
19 pharmacist services that include either or both of the following:
- 20 a. Receiving payments for pharmacist services.
- 21 b. Making payments to pharmacists or pharmacies for pharmacist
22 services.
- 23 ~~(1)(3)~~ Health benefit plan. – As defined in G.S. 58-50-110(11). ~~This definition~~
24 ~~specifically excludes the State Health Plan for Teachers and State~~
25 ~~Employees-G.S. 58-3-167.~~
- 26 ~~(1a)(4)~~ Insured. – An individual covered by a health benefit plan.
- 27 ~~(2)(5)~~ Insurer. – Any entity that provides or offers a health benefit plan.
- 28 (6) Maximum allowable cost list. – A listing of generic drugs used by a pharmacy
29 benefits manager to set the maximum allowable cost price.
- 30 ~~(3)(7)~~ Maximum allowable cost price. – The maximum per unit reimbursement for
31 multiple source prescription drugs, medical products, or devices.
- 32 (8) Other prescription drug or device services. – Services, other than claims
33 processing services, provided directly or indirectly by a pharmacy benefits

1 manager, whether in connection with or separate from claims processing
 2 services, including any of the following:

- 3 a. Negotiating rebates, discounts, or other financial incentives and
 4 arrangements with drug companies.
 5 b. Disbursing or distributing rebates.
 6 c. Managing or participating in incentive programs or arrangements for
 7 pharmacist services.
 8 d. Negotiating or entering into contractual arrangements with
 9 pharmacists or pharmacies, or both.
 10 e. Developing formularies.
 11 f. Designing prescription benefit programs.
 12 g. Advertising or promoting services.

13 ~~(3a)~~(9) Pharmacist. – A person licensed to practice pharmacy under Article 4A of
 14 Chapter 90 of the General Statutes.

15 (10) Pharmacist services. – Products, goods, and services, or any combination
 16 thereof, provided as a part of the practice of pharmacy.

17 ~~(4)~~(11) Pharmacy. – A pharmacy registered with the North Carolina Board of
 18 Pharmacy.

19 ~~(5)~~(12) Pharmacy benefits manager. – An entity who contracts with a pharmacist or a
 20 pharmacy on behalf of an insurer or third-party administrator to administer or
 21 manage prescription drug ~~benefits~~ benefits to perform any of the following
 22 functions:

- 23 a. Processing claims for prescription drugs or medical supplies or
 24 providing retail network management for pharmacies or pharmacists.
 25 b. Paying pharmacies or pharmacists for prescription drugs or medical
 26 supplies.
 27 c. Negotiating rebates with manufacturers for drugs paid for or procured
 28 as described in this Article.

29 (13) Pharmacy benefits manager affiliate. – A pharmacy or pharmacist that directly
 30 or indirectly, through one or more intermediaries, owns or controls, is owned
 31 or controlled by, or is under common ownership or control with a pharmacy
 32 benefits manager.

33 ~~(6)~~(14) Third-party administrator. – As defined in G.S. 58-56-2.

34 **"§ 58-56A-2. Licensure.**

35 (a) A person or organization may not establish or operate as a pharmacy benefits manager
 36 in this State for health benefit plans without obtaining a license from the Commissioner of the
 37 Department of Insurance.

38 (b) The Commissioner shall prescribe the application for a license to operate in this State
 39 as a pharmacy benefits manager and may charge an initial application fee of two thousand dollars
 40 (\$2,000) and an annual renewal fee of one thousand five hundred dollars (\$1,500), provided the
 41 pharmacy benefits manager application form must collect all of the following information:

- 42 (1) The name, address, and telephone contact number of the pharmacy benefits
 43 manager.
 44 (2) The name and address of the pharmacy benefits manager's agent for service
 45 of process in the State.
 46 (3) The name and address of each person with management or control over the
 47 pharmacy benefits manager.
 48 (4) The name and address of each person with a beneficial ownership interest in
 49 the pharmacy benefits manager.
 50 (5) A signed statement indicating that, to the best of the applicant's knowledge,
 51 no officer with management or control of the pharmacy benefit manager has

1 been convicted of a felony or has violated any of the requirements of State or
2 federal law applicable to pharmacy benefits managers, or, if the applicant
3 cannot provide that statement, a signed statement describing the relevant
4 conviction or violation.

5 (6) In the case of a pharmacy benefits manager applicant that is a partnership or
6 other unincorporated association, limited liability company, or corporation,
7 and that has five or more partners, members, or stockholders, all of the
8 following shall apply:

9 a. The applicant shall specify its legal structure and the total number of
10 its partners, members, or stockholders who, directly or indirectly, own,
11 control, hold with the power to vote, or hold proxies representing ten
12 percent (10%) or more of the voting securities of any other person.

13 b. An agreement that, upon request by the Department, the applicant shall
14 furnish the Department with information regarding the name, address,
15 usual occupation, and professional qualifications of any other partners,
16 members, or stockholders who, directly or indirectly, own, control,
17 hold with the power to vote, or hold proxies representing ten percent
18 (10%) or more of the voting securities of any other person.

19 (c) An applicant or a pharmacy benefits manager that is licensed to conduct business in
20 the State shall, unless otherwise provided for in this Article, file a notice describing any material
21 modification of the information required to be provided under this section.

22 (d) The Commissioner shall adopt rules establishing the licensing and reporting
23 requirements of pharmacy benefits managers consistent with the provisions of this Article.

24 **"§ 58-56A-3. Consumer protections.**

25 (a) A pharmacy or pharmacist shall have the right to provide an insured information
26 regarding the amount of the insured's cost share for a prescription drug. Neither a pharmacy nor
27 a pharmacist shall be prohibited, restricted, or penalized by a pharmacy benefits manager for
28 discussing any information described in this section or for selling a lower-priced drug to the
29 insured if one is available.

30 (b) A pharmacy benefits manager shall not, through contract, prohibit restrict or penalize
31 a pharmacy or pharmacist from any of the following:

32 (1) ~~offering~~ Offering and providing direct and limited delivery services to an
33 insured as an ancillary service of the ~~pharmacy, as delineated in the contract~~
34 ~~between the pharmacy benefits manager and the pharmacy.~~

35 (2) Disclosing to any insured any health care information that the pharmacy or
36 pharmacist deems appropriate within the pharmacist's scope of practice.

37 (3) Discussing information regarding the total cost for pharmacist services for a
38 prescription drug, or from selling a more affordable alternative to the insured
39 if a more affordable alternative is available. A pharmacy benefits manager
40 shall not prohibit a pharmacy or pharmacist from sharing proprietary or
41 confidential information.

42 (4) Disclosing information to the Commissioner investigating or examining a
43 complaint or conducting a review of a pharmacy benefits manager's
44 compliance with the requirements of this Chapter. The information or data
45 acquired under this subdivision during an examination or review is considered
46 proprietary and confidential and shall not be considered a public record under
47 Chapter 132 of the General Statutes.

48 (c) A pharmacy benefits manager shall not charge, or attempt to collect from, an insured
49 ~~a co-payment~~ copayment that exceeds the lesser of the following amounts:

50 (1) The total submitted charges by the network pharmacy.

51 (2) The contracted copayment amount.

1 (3) The amount an individual would pay for a prescription drug if that individual
2 was not insured and was paying cash for the prescription drug.

3 (c1) To the extent allowable under federal and State law, when calculating an insured's
4 overall contribution to any out-of-pocket maximum or any cost-sharing requirement under a
5 health benefit plan, an insurer shall include any amounts paid by the insured or paid on behalf of
6 the insured by another person.

7 (d) ~~Any contract for the provision of a network to deliver health care services between a~~
8 ~~pharmacy benefits manager and insurer shall be made available for review by the Department.~~

9 (e) ~~The Department shall report to the Attorney General any violations of this section or~~
10 ~~G.S. 58-56A-4 in accordance with G.S. 58-2-40(5).~~

11 (f) No pharmacy benefits manager shall cause or knowingly permit the use of any
12 advertisement, promotion, solicitation, representation, proposal, or offer that is untrue, deceptive,
13 or misleading. No pharmacy benefits manager shall knowingly make any misrepresentation.

14 (g) A pharmacy benefits manager shall not require an insured to use a pharmacy benefits
15 manager affiliate for the filling of a prescription or the provision of pharmacy care services.

16 (h) An insured shall not be restricted from utilizing any in-network pharmacy or
17 pharmacist for a prescription drug covered by the health benefit plan, including specialty drugs
18 and maintenance drugs, provided the prescription drug meets all of the following criteria:

19 (1) The drug is not a limited distribution drug.

20 (2) The drug is not commonly carried at retail pharmacies.

21 (3) The drug requires special handling.

22 **"§ 58-56A-4. Pharmacy and pharmacist protections.**

23 (a) A pharmacy benefits manager may only charge a reasonable fee or adjustment for the
24 receipt and processing of a claim, or otherwise hold a pharmacy responsible for a fee relating to
25 the adjudication of a ~~claim~~ claim, if the fee is reported on the remittance advice of the adjudicated
26 claim or is set out in contract between the pharmacy benefits manager and the pharmacy. No fee
27 or adjustment for the receipt and processing of a claim, or otherwise related to the adjudication
28 of a claim, shall be charged without a justification for each adjustment or fee. This section shall
29 not apply with respect to claims under an employee benefit plan under the Employee Retirement
30 Income Security Act of 1974 or Medicare Part D.

31 (b) A pharmacy benefits manager shall not, directly or indirectly, charge a reasonable fee
32 or adjustment for the receipt and processing of a claim, or otherwise hold a pharmacy responsible
33 for a fee or adjustment relating to the adjudication of a claim, if the claim meets any of the
34 following criteria:

35 (1) The fee or adjustment is not apparent at the time of claim processing.

36 (2) The fee or adjustment is not reported on the remittance advice of an
37 adjudicated claim.

38 (3) The fee or adjustment is charged after the initial claim is adjudicated at the
39 point of sale.

40 (c) A pharmacy or pharmacist shall not be prohibited or in any way restricted by a
41 pharmacy benefits manager from dispensing any prescription drug allowed to be dispensed under
42 a license to practice pharmacy under Article 4A of Chapter 90 of the General Statutes.

43 (d) With the express intent or purpose of driving out competition or financially injuring
44 competitors, a pharmacy benefits manager shall not engage in a pattern or practice of reimbursing
45 independent pharmacies or pharmacists in this State consistently less than the amount of the
46 National Drug Average Acquisition Cost and the amount that the pharmacy benefits manager
47 reimburses a pharmacy benefits manager affiliate for providing the same pharmacist services.

48 (e) A pharmacy benefits manager shall not require the use of mail order for filling
49 prescriptions, unless required to do so by the health benefit plan.

1 (f) A pharmacy benefits manager shall not prohibit a pharmacist or pharmacy from
2 charging a shipping and handling fee to an insured requesting a prescription be mailed or
3 delivered.

4 (g) A pharmacy benefits manager shall not prohibit a pharmacist or pharmacy from
5 participating in a class action lawsuit.

6 (h) Nothing in this Article abridges the right of a pharmacist to refuse to fill or refill a
7 prescription if the pharmacist believes it would be harmful to the patient or is not in the patient's
8 best interest or if there is a question as to the prescription's validity.

9 (i) A pharmacy or pharmacists may decline to provide pharmacist services on behalf of
10 a pharmacy benefits manager or third-party administrator.

11 (j) A pharmacy benefits manager shall not penalize or retaliate against a pharmacist or
12 pharmacy for exercising rights provided under this Article.

13 **"§ 58-56A-5. Maximum allowable cost price.**

14 (a) In order to place a prescription drug on the maximum allowable cost price list, the
15 drug must be available for purchase by pharmacies in North Carolina from national or regional
16 wholesalers, must not be obsolete, and must meet one of the following conditions:

17 (1) The drug is listed as "A" or "B" rated in the most recent version of the United
18 States Food and Drug Administration's Approved Drug Products with
19 Therapeutic Equivalence Evaluations, also known as the Orange Book.

20 (2) The drug has a "NR" or "NA" rating, or a similar rating, by a nationally
21 recognized reference.

22 (b) A pharmacy benefits manager shall adjust or remove the maximum allowable cost
23 price for a prescription drug to remain consistent with changes in the national marketplace for
24 prescription drugs. A review of the maximum allowable cost prices for removal or modification
25 shall be completed by the pharmacy benefits manager at least once every seven business days,
26 and any removal or modification shall occur within seven business days of the review. A
27 pharmacy benefits manager shall provide a means by which the contracted pharmacies may
28 promptly review current prices in an electronic, print, or telephonic format within one business
29 day of the removal or modification.

30 (c) Consistent with G.S. 58-56A-4, a pharmacy benefits manager shall not engage in a
31 pattern or practice of reimbursing independent pharmacies or pharmacists in this State
32 consistently less than the amount of the National Drug Average Acquisition Cost.

33 (d) A pharmacy benefits manager shall ensure that dispensing fees are not included in the
34 calculation of maximum allowable cost price.

35 (e) A pharmacy benefits manager shall establish an administrative appeals procedure by
36 which a contracted pharmacy or pharmacist, or a designee, can appeal the provider's
37 reimbursement for a prescription drug subject to maximum allowable cost pricing if the
38 reimbursement for the drug is less than the net amount that the network provider paid to the
39 suppliers of the drug. The reasonable administrative appeal procedure must include all of the
40 following:

41 (1) A dedicated telephone number and e-mail address or Web site for the purpose
42 of submitting administrative appeals.

43 (2) The ability to submit an administrative appeal directly to the pharmacy
44 benefits manager regarding the pharmacy benefits plan or program or through
45 a pharmacy service administrative organization if the pharmacy service
46 administrative organization has a contract with the pharmacy benefits
47 manager that allows for the submission of such appeals.

48 (3) No less than 10 calendar days after the applicable fill date to file an
49 administrative appeal.

50 (4) If an appeal is initiated, then the pharmacy benefits manager shall, within 10
51 calendar days after receipt of notice of the appeal, do either of the following:

- 1 a. If the appeal is upheld, the pharmacy benefits manager shall notify the
2 pharmacy or pharmacist, or designee, of the decision, make the change
3 in the maximum allowable cost effective as of the date the appeal is
4 resolved, permit the appealing pharmacy or pharmacist to reverse and
5 rebill the claim in question, and make the change effective for each
6 similarly situated pharmacy, as defined by the payor subject to the
7 Maximum Allowable Cost List, effective as of the date the appeal is
8 resolved.
- 9 b. If the appeal is denied within 10 days of the denial, the pharmacy
10 benefits manager shall provide the appealing pharmacy or pharmacist
11 the reason for the denial, the National Drug Code number, and the
12 names of the national or regional pharmaceutical wholesalers
13 operating in this State.

14 **"§ 58-65A-15. Claims and overpayments.**

15 (a) A claim for pharmacist services may not be retroactively denied or reduced after
16 adjudication of the claim unless any of the following apply:

- 17 (1) The original claim was submitted fraudulently.
18 (2) The original claim payment was incorrect because the pharmacy or pharmacist
19 had already been paid for the pharmacist services.
20 (3) The pharmacist services were not rendered by the pharmacy or pharmacist.
21 (4) The adjustment was agreed upon by the pharmacy or pharmacist prior to the
22 denial or reduction.

23 (b) Nothing in this section shall be construed to limit overpayment recovery efforts by a
24 pharmacy benefits manager.

25 **"§ 58-56A-20. Pharmacy benefits manager networks.**

26 (a) Each pharmacy benefits manager network may require different pharmacy
27 accreditation standards or certification requirements for participating in the network, provided
28 that the pharmacy accreditation standards or certification requirements are applied without regard
29 to a pharmacy's or pharmacist's status as an independent pharmacy or pharmacy benefits manager
30 affiliate. Each individual pharmacy location, as identified by its National Council for Prescription
31 Drug Program identification number, may have access to more than one network, so long as the
32 pharmacy location meets the pharmacy accreditation standards or certification requirements of
33 each network.

34 (b) A pharmacy benefits manager shall not deny the right to any properly licensed
35 pharmacist or pharmacy to participate in a network on the same terms and conditions of other
36 participants in the network. Benefit differentials are prohibited.

37 (c) As a condition of participation in a pharmacy benefits manager network, the
38 pharmacy benefits manager shall not require pharmacy accreditation standards or recertification
39 requirements inconsistent with, more stringent than, or in addition to federal and State
40 requirements for licensure.

41 (d) Pharmacy performance measure or pay-for-performance networks shall utilize the
42 electronic quality improvement platform for plans and pharmacies, known as EQuIPP, or another
43 unbiased, nationally-recognized entity aiding in improving pharmacy performance measures.
44 The following applies to pharmacy performance measures:

- 45 (1) A pharmacy benefits manager may not impose a fee on a pharmacy, or
46 otherwise penalize the pharmacy, if the pharmacy's scores or metrics fall
47 within the criteria identified by EQuIPP, or another unbiased,
48 nationally-recognized entity aiding in improving pharmacy performance
49 measures, or if the patient is compliant with the patient's drug regimen.
50 (2) If a pharmacy benefits manager imposes a fee on a pharmacy for scores or
51 metrics that do not fall within the criteria identified by EQuIPP, or another

1 unbiased, nationally-recognized entity aiding in improving pharmacy
2 performance measures, then the pharmacy benefits manager is limited to
3 applying the fee to the professional dispensing fee as contained in the
4 pharmacy contract.

5 (3) A pharmacy benefits manager may not impose a fee relating to performance
6 metrics on the cost of goods sold by a pharmacy.

7 (e) A pharmacist or pharmacy that belongs to a pharmacy service administration
8 organization shall, upon request, receive a copy of the contract the pharmacy service
9 administration organization entered into with a pharmacy benefits manager on the pharmacy's
10 behalf.

11 (f) Termination of a pharmacy or pharmacist from a pharmacy benefits manager network
12 does not release the pharmacy benefits manager from the obligation to make any payment due to
13 the pharmacy or pharmacist for pharmacist services properly rendered according to the contract.

14 **"§ 58-65A-25. Pharmacy benefits manager affiliate disclosure; sharing of data.**

15 (a) A pharmacy benefits manager that has a pharmacy benefits manager affiliate shall
16 disclose to a health benefit plan, and any provider contracted under that health benefit plan, any
17 difference between the amount paid to a pharmacy and the amount charged to the health benefit
18 plan.

19 (b) A pharmacy benefits manager shall not transfer or share records relative to
20 prescription information containing patient-identifiable and prescriber-identifiable data to a
21 pharmacy benefits manager affiliate for any commercial purpose. Nothing in this subsection shall
22 be construed to prohibit the exchange of prescription information between a pharmacy benefits
23 manager and a pharmacy benefits manager affiliate for the limited purposes of pharmacy
24 reimbursement, formulary compliance, pharmacy care, or utilization review.

25 **"§ 58-65A-30. Reports and information to be provided to the Commissioner.**

26 (a) Any contract for the provision of a network to deliver health care services between a
27 pharmacy benefits manager and an insurer or health benefit plan shall be made available for
28 review by the Department as a condition of initial licensure or maintenance of licensure.

29 (b) All pharmacy benefits managers shall report annually to the Commissioner all of the
30 following information regarding rebates:

31 (1) The aggregate amount of all rebates that the pharmacy benefits manager
32 received from pharmaceutical manufacturers.

33 (2) The aggregate amount of all rebates that the pharmacy benefits manager
34 received from pharmaceutical manufacturers that the pharmacy benefits
35 manager did not pass through to insurers or payors.

36 **"§ 58-65A-35. Enforcement.**

37 (a) The Commissioner may examine or audit the books and records of a pharmacy
38 benefits manager providing claims processing services or other prescription drug or device
39 services for an insurer or a health benefit plan that are relevant to determining if the pharmacy
40 benefits manager is in compliance with this Article. The Commissioner may contract with
41 consultants and other professionals with relevant expertise as necessary and appropriate to
42 conduct an examination or audit of a pharmacy benefits manager.

43 (b) The pharmacy benefits manager shall pay the charges incurred in an examination or
44 audit under this section, including the expenses of the Department and the expenses and
45 compensation of the examiners. The Commissioner shall institute a civil action to recover the
46 expenses of examination against a pharmacy benefits manager which refuses or fails to pay the
47 expenses.

48 (c) The information or data acquired during an examination or audit under this section is
49 considered proprietary and confidential and is not a public record under Chapter 132 of the
50 General Statutes.

1 (d) The Commissioner shall adopt rules regarding the regulation of pharmacy benefits
2 managers that are not inconsistent with this Article.

3 (e) Violations of this Article are subject to the penalties under G.S. 58-56A-10. A
4 pharmacy benefits manager shall also be subject to revocation of, or a refusal to renew, a license
5 to operate in this State as a result of violations of this Article.

6 (f) The Commissioner shall report to the Attorney General any violations of this Article,
7 in accordance with G.S. 58-2-40(5).

8 **"§ 58-56A-40. Civil Penalties for violations; administrative procedure.**

9 (a) Whenever the Commissioner has reason to believe that a pharmacy benefits manager
10 has violated any of the provisions of this Article with such frequency as to indicate a general
11 business practice, the Commissioner may, after notice and opportunity for a hearing, proceed
12 under the appropriate subsections of this section.

13 (b) If, under subsection (a) of this section, the Commissioner finds a violation of this
14 Article, the Commissioner may order the payment of a monetary penalty ~~as provided in~~
15 ~~subsection (e) of this section~~ or petition the Superior Court of Wake County for an order directing
16 payment of restitution as provided in subsections (d) and (e) of this section, or both. Each day
17 during which a violation occurs constitutes a separate violation.

18 (c) ~~If~~ If, pursuant to subsection (b) of this section, the Commissioner orders the payment
19 of a monetary penalty ~~pursuant to subsection (b) of this section,~~ for a violation of G.S. 58-56A-5,
20 then the penalty shall not be less than one hundred dollars (\$100.00) nor more than one thousand
21 dollars (\$1,000) per day for each prescription drug resulting from the pharmacy benefit manager's
22 failure to comply with G.S. 58-56A-5. In determining the amount of the penalty, the
23 Commissioner shall consider the degree and extent of harm caused by the violation, the amount
24 of money that inured to the benefit of the violator as a result of the violation, whether the violation
25 was committed willfully, and the prior record of the violator in complying or failing to comply
26 with laws, rules, or orders applicable to the violator. The clear proceeds of the penalty shall be
27 remitted to the Civil Penalty and Forfeiture Fund in accordance with G.S. 115C-457.2. Payment
28 of the civil penalty under this section shall be in addition to payment of any other penalty for a
29 violation of the criminal laws of this State.

30 (c1) If, pursuant to subsection (b) of this section, the Commissioner orders the payment of
31 a monetary penalty for a violation of any provision of this Article other than G.S. 58-56A-5, then,
32 in determining the amount of the penalty, the Commissioner shall consider the degree and extent
33 of harm caused by the violation, the amount of money that inured to the benefit of the violator as
34 a result of the violation, whether the violation was committed willfully, and the prior record of
35 the violator in complying or failing to comply with laws, rules, or orders applicable to the
36 violator. The clear proceeds of the penalty shall be remitted to the Civil Penalty and Forfeiture
37 Fund in accordance with G.S. 115C-457.2. Payment of the civil penalty under this section shall
38 be in addition to payment of any other penalty for a violation of the criminal laws of this State.

39 (d) Upon petition of the Commissioner to the court pursuant to subsection (b) of this
40 section, the court may order the pharmacy benefits manager who committed a violation ~~specified~~

42 make whole any pharmacist harmed by the violation. The petition may be made at any time and
43 also in any appeal of the Commissioner's order.

44 (e) Upon petition of the Commissioner to the court pursuant to subsection (b) of this
45 section, the court may order the pharmacy benefits manager who committed a violation ~~specified~~
46 ~~in subsection (b) of this section~~ under this Article to make restitution to the Department for
47 expenses under subsection (f) of this section, incurred in the investigation, hearing, and any
48 appeals associated with the violation in such amount that would reimburse the agency for the
49 expenses. The petition may be made at any time and also in any appeal of the Commissioner's
50 order.

1 (f) The Commissioner may contract with consultants and other professionals with
2 relevant expertise as necessary and appropriate to conduct investigation, hearing, and appeals
3 activities as provided in this section. ~~Such~~ These contracts shall not be subject to G.S. 114-2.3,
4 G.S. 147-17, or Articles 3, 3C, and 8 of Chapter 143 of the General Statutes, together with rules
5 and procedures adopted under those Articles concerning procurement, contracting, and contract
6 review.

7 (g) Nothing in this section prevents the Commissioner from negotiating a mutually
8 acceptable agreement with any pharmacy benefits manager as to any civil penalty or restitution.

9 (h) Unless otherwise specifically provided for, all administrative proceedings under this
10 Article are governed by Chapter 150B of the General Statutes. Appeals of the Commissioner's
11 orders under this section shall be governed by G.S. 58-2-75."

12 **SECTION 3.** G.S. 58-2-40(5) reads as rewritten:

13 "(5) Report in detail to the Attorney General any violations of the laws relative to
14 pharmacy benefits manager, insurance companies, associations, orders and
15 bureaus or the business of insurance; and the Commissioner may institute civil
16 actions or criminal prosecutions either by the Attorney General or another
17 attorney whom the Attorney General may select, for any violation of the
18 provisions of Articles 1 through 64 of this Chapter."

19 **SECTION 4.** This act is effective January 1, 2020, and applies to any contracts
20 entered into on or after that date.
