FISCAL IMPACT SUMMARY

House Bill 444 amends GS 86A-25 by increasing all of the fees charged by the Board except the following: examination fees, fee for the issuance of any duplicate copy of a license, certificate, or permit, fee for the inspection of newly established barber school, fee for the issuance of a registered barber or apprentice certificate by certification, fees charged barbers 70 years and older for certificate or renewal, and charges for certified copies of public documents and duplication services and material.

FISCAL ANALYSIS

House Bill 444 would amend various fees collected by the Board of Barber Examiners. Listed below are the current fees, proposed fees, and any changes in those fees.

The North Carolina Board of Barber Examiners provided fee collection data for FY2012-13 through FY2017-18. The six year average was used to estimate the impact of the proposed fee changes. The estimated change in fee collections is shown in the table below.

The above table assumes that all of those individuals who are currently 70 years of age or older, and receive a free certificate to practice as a barber, will opt to pay for a certificate. According to the North Carolina Board of Barber Examiners, it's likely that a significant portion of those individuals are not currently active barbers and would not opt to pay for the certificate.

Over the next five years, Moody's Analytics estimates modest job growth in North Carolina for the Other Services sector. The board's revenue impact is grown using those estimates.
