1 A BILL TO BE ENTITLED
2 AN ACT TO STRENGTHEN POLICIES AND STANDARDS SURROUNDING LAW
3 ENFORCEMENT OFFICERS AND TO APPROPRIATE FUNDS.

4 The General Assembly of North Carolina enacts:

5
6 **PART I. DIRECT THE DEPARTMENT OF JUSTICE TO ASSIST LAW**
7 **ENFORCEMENT AGENCIES IN APPLYING FOR GRANT FUNDS AND FUND**
8 **POSITIONS TO MEET THE REQUIREMENTS OF THIS PART**

9 **SECTION 1.1.** The Department of Justice shall provide assistance to law
10 enforcement agencies seeking grant funds, including, but not limited to, the following:

- 11 (1) Alerting law enforcement agencies to available grant funds.
12 (2) Assisting law enforcement agencies with drafting and submitting grant
13 proposals and applications.

14 **SECTION 1.2.** There is appropriated from the General Fund to the Department of
15 Justice two hundred thousand dollars (\$200,000) in recurring funds for the 2022-2023 fiscal year
16 to be used to hire two full-time grant writers to assist law enforcement agencies pursuant to the
17 requirements of Section 1.1 of this Part.

18 **SECTION 1.3.** This Part becomes effective July 1, 2022.

20 **PART II. SUPPORT COMMUNITY POLICING PROGRAMS**

21 **SECTION 2.1.** There is appropriated from the General Fund to the Department of
22 Justice the sum of two hundred fifty thousand dollars (\$250,000) in recurring funds for the
23 2022-2023 fiscal year to be used to award grants to law enforcement agencies for initiatives
24 supporting community policing.

25 **SECTION 2.2.** This Part becomes effective July 1, 2022.

27 **PART III. CREATE INCENTIVES FOR LAW ENFORCEMENT OFFICERS AND**
28 **AGENCIES**

29 **SECTION 3.1.** There is appropriated from the General Fund to the Department of
30 Justice the sum of five hundred thousand dollars (\$500,000) in recurring funds for the 2022-2023
31 fiscal year to be used to provide the following types of grants:

- 32 (1) Grants provided to law enforcement agencies to be awarded to law
33 enforcement officers exhibiting exemplary service, as established by the
34 Department of Justice.



- 1 (2) Grants awarded to law enforcement agencies for meeting racial or gender
2 diversity benchmarks, as established by the Department of Justice.

3 **SECTION 3.2.** No grant awarded pursuant to this Part shall exceed ten thousand
4 dollars (\$10,000).

5 **SECTION 3.3.** This Part becomes effective July 1, 2022.

6
7 **PART IV. REVISE POLICE USE OF FORCE POLICIES**

8 **SECTION 4.1.** G.S. 15A-401(d) reads as rewritten:

9 "(d) Use of Force in Arrest. –

10 ...

- 11 (2) A law-enforcement officer is justified in using deadly physical force upon
12 another person for a purpose specified in subdivision (1) of this subsection
13 only when it is or appears to be reasonably necessary thereby:

14 ...

15 Strangleholds, lateral vascular neck restraints, carotid restraints, or any other
16 tactics that restrict oxygen or blood flow to the head or neck shall be
17 considered the use of deadly force under this subdivision.

18 Nothing in this subdivision constitutes justification for willful, malicious or
19 criminally negligent conduct by any person which injures or endangers any
20 person or property, nor shall it be construed to excuse or justify the use of
21 unreasonable or excessive force.

- 22 (3) Under all circumstances in which a law-enforcement officer uses force of any
23 kind, a law-enforcement officer shall use the minimum amount of force
24 reasonably necessary to accomplish the law-enforcement action and shall
25 attempt to utilize de-escalation tactics when possible."

26 **SECTION 4.2.** The Attorney General, in consultation with the North Carolina
27 Sheriffs' Association and the North Carolina Association of Chiefs of Police, shall develop
28 uniform use of force policies that may be adopted by all law enforcement agencies in the State.
29 These policies shall be submitted to the Joint Legislative Oversight Committee on Justice and
30 Public Safety no later than December 1, 2022, shall be published on the Department of Justice
31 website, and shall be distributed in digital format by the Attorney General to all law enforcement
32 agencies in the State.

33 **SECTION 4.3.** Section 4.1 of this Part becomes effective October 1, 2022, and
34 applies to actions taken on or after that date. The remainder of this Part is effective when it
35 becomes law.

37 **PART V. ESTABLISH MINIMUM STANDARDS FOR THE HIRING AND TRAINING**
38 **OF LAW ENFORCEMENT OFFICERS**

39 **SECTION 5.1.** G.S. 17C-6(a) reads as rewritten:

40 "(a) In addition to powers conferred upon the Commission elsewhere in this Article, the
41 Commission shall have the following powers, which shall be enforceable through its rules and
42 regulations, certification procedures, or the provisions of G.S. 17C-10:

43 ...

- 44 (2a) Establish the minimum age requirement that shall be met in order to qualify
45 for entry level employment as a criminal justice officer in temporary or
46 probationary status or in a permanent position, which shall not be less than 21
47 years of age.

48"

49 **SECTION 5.2.** G.S. 17C-13(b) reads as rewritten:

50 "(b) Notwithstanding G.S. 15A-145.4 or G.S. 15A-145.5, the Commission may gain
51 access to a person's misdemeanor and felony conviction records, including those maintained by

1 the Administrative Office of the Courts in its confidential files containing the names of persons
2 granted expunctions. The Commission may deny, suspend, or revoke a person's certification
3 based solely on that person's felony ~~conviction~~, conviction or the conviction of four or more
4 misdemeanors, whether or not ~~that conviction was~~ the convictions were expunged."

5 **SECTION 5.3.** G.S. 17E-4(a) reads as rewritten:

6 "(a) The Commission shall have the following powers, duties, and responsibilities, which
7 are enforceable through its rules and regulations, certification procedures, or the provisions of
8 G.S. 17E-8 and G.S. 17E-9:

9 ...

10 (2a) Establish the minimum age requirement that shall be met in order to qualify
11 for entry level employment as an officer in temporary or probationary status
12 or in a permanent position, which shall not be less than 21 years of age.

13 ...

14 The Commission may certify, and no additional certification shall be required from it, programs,
15 courses and teachers certified by the North Carolina Criminal Justice Education and Training
16 Standards Commission. Where the Commission determines that a program, course, instructor or
17 teacher is required for an area which is unique to the office of sheriff, the Commission may certify
18 such program, course, instructor, or teacher under such standards and procedures as it may
19 establish."

20 **SECTION 5.4.** G.S. 17E-12(b) reads as rewritten:

21 "(b) Notwithstanding G.S. 15A-145.4 or G.S. 15A-145.5, the Commission may gain
22 access to a person's misdemeanor and felony conviction records, including those maintained by
23 the Administrative Office of the Courts in its confidential files containing the names of persons
24 granted expunctions. The Commission may deny, suspend, or revoke a person's certification
25 based solely on that person's felony ~~conviction~~, conviction or the conviction of four or more
26 misdemeanors, whether or not ~~that conviction was~~ the convictions were expunged."

27 **SECTION 5.5.** Sections 5.1 and 5.3 of this Part become effective January 1, 2023,
28 and apply to officers hired or employed on or after that date. Sections 5.2 and 5.4 of this Part
29 become effective January 1, 2023, and apply to (i) officers hired on or after that date and (ii)
30 officers employed on or after that date that are convicted of a felony or misdemeanor on or after
31 that date. The remainder of this Part is effective when it becomes law.

32 33 **PART VI. FUND ADDITIONAL DETECTIVES OR INVESTIGATIVE OFFICERS TO** 34 **INVESTIGATE THE SEVERE CRIMES**

35 **SECTION 6.1.** There is appropriated from the General Fund to the Department of
36 Justice the sum of one million dollars (\$1,000,000) in recurring funds for the 2022-2023 fiscal
37 year to be used to provide grants to law enforcement agencies to temporarily provide partial or
38 total funding for detective or other investigative law enforcement positions in order to aid in the
39 investigation of person crimes that would constitute a charge of a Class D felony or higher.

40 **SECTION 6.2.** This Part becomes effective July 1, 2022.

41 42 **PART VII. SEVERABILITY CLAUSE AND EFFECTIVE DATE**

43 **SECTION 7.1.** If any Part, section, or provision of this act is declared
44 unconstitutional or invalid by the courts, it does not affect the validity of this act as a whole or
45 any portion other than the portion declared to be unconstitutional or invalid.

46 **SECTION 7.2.** Except as otherwise provided, this act is effective when it becomes
47 law.
