Short Title: Food Bank of Central & Eastern NC Funds. (Public)

1 A BILL TO BE ENTITLED  
2 AN ACT TO APPROPRIATE FUNDS TO THE FOOD BANK OF CENTRAL & EASTERN  
3 NORTH CAROLINA FOR CONSTRUCTION OF A NEW FOOD BANK FACILITY IN  
4 THE CITY OF WILMINGTON.

5 Whereas, the Food Bank of Central & Eastern North Carolina (Food Bank) serves  
6 over 100 partner agencies across Brunswick, Columbus, Duplin, New Hanover, and Pender  
7 Counties; and

8 Whereas, currently, more than 107,200 people in these counties are facing food  
9 insecurity and of that number more than 32,000 are children and at least 29,000 are senior  
10 citizens. Food insecurity in that area has increased by 38% due to the COVID-19 pandemic; and

11 Whereas, plans are underway to build a new food bank facility in the City of  
12 Wilmington. The new facility will be almost triple in size at 30,000 square feet and will be able  
13 to provide a more efficient distribution of food for each of the local hunger relief partners in  
14 southeastern North Carolina; and

15 Whereas, the new Wilmington facility will provide a 500% increase in the Food  
16 Bank's cold storage capacity, allowing greater distribution of healthy, fresh foods and  
17 high-quality proteins. Last year, the Wilmington Food Bank was able to distribute more than 4.1  
18 million pounds of fresh produce and nutritious protein despite space restrictions; and

19 Whereas, in response to Hurricane Florence, the Food Bank distributed 14,969,375  
20 pounds of food, water, and supplies. A new food bank facility in the City of Wilmington will  
21 also help to increase response time and better preparation for disasters, resulting in more  
22 immediate and comprehensive mobilization across the Cape Fear region; Now, therefore,  
23 The General Assembly of North Carolina enacts:

24 **SECTION 1.** There is appropriated from the General Fund to the Food Bank of  
25 Central & Eastern North Carolina, Inc., a nonprofit organization, the sum of seven hundred fifty  
26 thousand dollars (\$750,000) in nonrecurring funds for the 2021-2022 fiscal year for the  
27 construction of a new food bank facility in the City of Wilmington to support the health and well-  
28 being of children, seniors, and adults across southeastern North Carolina.

29 **SECTION 2.** This act becomes effective July 1, 2021.
