1 A BILL TO BE ENTITLED
2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO PRODUCE A
3 SPECIAL OLYMPICS NC SPECIAL REGISTRATION PLATE.

4 The General Assembly of North Carolina enacts:

5 SECTION 1. G.S. 20-79.4(b) reads as rewritten:

6 "(b) Types. – The Division shall issue the following types of special registration plates:

7 ...

8 () Special Olympics NC. – Issuable to a registered owner of a motor vehicle in
9 accordance with G.S. 20-81.12. The plate shall bear the Special Olympics
10 North Carolina logo followed by the assigned or personalized characters
11 ending with the suffix SO.

13 SECTION 2. G.S. 20-79.7 reads as rewritten:

14 "§ 20-79.7. Fees for special registration plates and distribution of the fees.

15 ...

16 (a1) Fees. – All other special registration plates are subject to the regular motor vehicle
17 registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

24 (b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate and
25 Cultural Attraction Plate Account are established within the Highway Fund. The Division must
26 credit the additional fee imposed for the special registration plates listed in subsection (a1) of this
27 section among the Special Registration Plate Account (SRPA), the Collegiate and Cultural
28 Attraction Plate Account (CCAPA), the ~~Clean Water Management Trust Fund (CWMTF)~~, Land
29 and Water Fund (LWF), which is established under G.S. 143B-135.234, and the Parks and
30 Recreation Trust Fund, which is established under G.S. 143B-135.56, as follows:

3 **SECTION 3.** G.S. 20-81.12 reads as rewritten:

4 "**§ 20-81.12. Collegiate insignia plates and certain other special plates.**

5 ...

6 Q Special Olympics North Carolina. – The Division shall transfer quarterly the money
7 in the Collegiate and Cultural Attraction Plate Account derived from the sale of Special Olympics
8 NC plates to Special Olympics North Carolina to be used to fund athletic programs throughout
9 North Carolina.

11 **SECTION 4.** The Revisor of Statutes is authorized to alphabetize, number, and
12 renumber the special registration plates listed in G.S. 20-79.4(b) and G.S. 20-81.12 to ensure that
13 all the special registration plates are listed in alphabetical order and numbered accordingly.

14 **SECTION 5.** This act becomes effective July 1, 2021.
