4 The General Assembly of North Carolina enacts:

5 SECTION 1. G.S. 86A-25 reads as rewritten:

6 "§ 86A-25. Fees collectible by Board.

7 The State Board of Barber Examiners shall charge fees not to exceed the following:

8 Certificate of registration or renewal as a barber \$

10 Certificate of registration or renewal as an apprentice barber

12 Barbershop permit or renewal
