Short Title: IIANC Special Registration Plate. (Public)

Sponsors: Senator Johnson (Primary Sponsor).

A BILL TO BE ENTITLED  
AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO PRODUCE AN  
"INDEPENDENT INSURANCE AGENTS OF NORTH CAROLINA" SPECIAL  
REGISTRATION PLATE.

The General Assembly of North Carolina enacts:

**SECTION 1.** G.S. 20-79.4(b) reads as rewritten:

"(b) Types. – The Division shall issue the following types of special registration plates:

...

( ) Independent Insurance Agents of North Carolina. – Issuable to a registered owner of a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the logo of the Independent Insurance Agents of North Carolina.

...."

**SECTION 2.** G.S. 20-79.7 reads as rewritten:

"§ 20-79.7. Fees for special registration plates and distribution of the fees.

...

(a1) Fees. – All other special registration plates are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

(b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a1) of this section among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), the <del>Clean Water Management Trust Fund (CWMTF)</del> , <u>Land and Water Fund (LWF)</u> , which is established under G.S. 143B-135.234, and the Parks and Recreation Trust Fund, which is established under G.S. 143B-135.56, as follows:
