A BILL TO BE ENTITLED

AN ACT TO ADD CERTAIN DESCRIBED PROPERTY TO THE CORPORATE LIMITS OF THE CITY OF CREEDMOOR AND TO REMOVE CERTAIN DESCRIBED PROPERTY FROM THE CORPORATE LIMITS OF THE CITY OF CREEDMOOR.

The General Assembly of North Carolina enacts:

**SECTION 1.(a)** The following described property, referenced by Granville County Tax Office Parcel Identification Number, is added to the corporate limits of the City of Creedmoor:

17           **SECTION 1.(b)** This section becomes effective June 30, 2024. Property in the  
 18 territory described in Section 1(a) of this act as of January 1, 2024, is subject to municipal taxes  
 19 for taxes imposed for taxable years beginning on or after July 1, 2024.

20           **SECTION 2.(a)** The following described property, identified by Granville County  
 21 Tax Property Identification Number, is removed from the corporate limits of the City of  
 22 Creedmoor: 180603417847.

23           **SECTION 2.(b)** This section has no effect upon the validity of any liens of the City  
 24 of Creedmoor for ad valorem taxes or special assessments outstanding before the effective date  
 25 of this section. Such liens may be collected or foreclosed upon after the effective date of this  
 26 section as though the property were still within the corporate limits of the City of Creedmoor.

27           **SECTION 2.(c)** This section becomes effective June 30, 2024. Property in the  
 28 territory described in Section 2(a) of this act as of January 1, 2024, is no longer subject to  
 29 municipal taxes for taxes imposed for taxable years beginning on or after July 1, 2024.

30           **SECTION 3.** Except as otherwise provided, this act is effective when it becomes  
 31 law.
